Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Note 1: Description of Plan

The following description of Mallick Mechanical Contractors, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution retirement plan established by the Mallick Mechanical Contractors, Inc. (Mallick) under a Non-Standardized Pre-Approved Profit Sharing Plan with CODA as sponsored by JM Pension Advisory, Inc. The Plan as amended and restated January 1, 2022, generally covers all employees of Mallick and its affiliate, Mallick Plumbing and Heating, Inc. (the Companies) who have attained the age of 18, been employed at least three months and completed at least 250 hours of service. The Plan provides for immediate entry dates for salary deferrals and safe-harbor match. The Plan qualifies under Section 401(k) of the Internal Revenue Code (IRC) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Participant Contributions: The Plan generally allows eligible participants to contribute an amount not to exceed the lesser of 100% of their compensation or an amount which, when added to other additions (exclusive of earnings) to the participant's account in any plan year, does not exceed the maximum limitation on annual additions to a participant's account under applicable provisions of the IRC. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participant contributions are made through payroll deductions. Each participant designates the percentage of his contribution which is to be invested in one or more of the available investment fund options. Participants have the opportunity to change their investment options daily. Participants are also allowed to rollover their account balances from other qualified retirement plans.

Employer Contributions: The Plan has a safe-harbor match where the Companies are required to match 100% of each employee's contributions up to 3% of the employee's eligible compensation and 50% of employee contributions of the next 2% that exceeds the first 3% of compensation. The maximum employee contribution eligible for matching is 5% of compensation. The Plan also allows the Companies to make discretionary match and profit sharing contributions. Both categories of employer contributions are dependent on length of service and employment on the last day of plan year. For the years ended December 31, 2024 and 2023, there were no discretionary contributions.

Participant Accounts: Each participant's account is credited with the participant's contributions, allocations of Companies' contributions, and Plan earnings and losses and administrative expenses. Plan earnings and losses are allocated based on the account balances of the participants. Allocation of Companies' contributions not based upon participant contributions are based on the compensation of the eligible employees. The benefit to which a participant is entitled is that which can be provided from the participant's vested account balance. All Plan assets as of December 31, 2024 and 2023 have been allocated to participant's accounts, except for participant and employer contributions receivables, if any.

Vesting: Participants are immediately vested in all of their contributions and investment earnings, thereon. Employer safe harbor contributions are fully vested and non-forfeitable when such contributions are made to a participant's account. Discretionary employer matching contributions are vested after three years of service. Discretionary employer profit sharing contributions are vested after six years of service, with vesting at 20% per year after two years of service. In the event of death, disability or retirement, a participant's interest is immediately fully vested in the employer contributions and related earnings under terms set forth in the Plan agreement.

Note 1: Description of Plan (Continued)

Notes Receivable from Participants: Participants may borrow from their accounts up to a maximum of the lesser of \$50,000 reduced by the excess of the highest outstanding balance of loans during the one year period ending on the day before the loan is made or 50% of the present value of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at 1% above the prime rate at the time of issuance. Principal and interest are paid through payroll deductions. A participant may have two loans outstanding at any one time.

Payment of Benefits: Upon termination of employment, a participant may elect to have vested Plan benefits distributed as a lump-sum payment. Account balances that are less than \$5,000 will be distributed in a lump sum amount. Participants are generally required to take minimum distributions upon reaching the age of 73. Hardship withdrawals by a participant are also permitted under certain circumstances.

Forfeitures: The non-vested portion of a participant's account balance is forfeited upon termination of employment. Forfeitures can be used to pay administrative expenses or reduce future employer contributions. During the years ended December 31, 2024 and 2023, there were no forfeitures used to reduce employer contributions or pay administrative expenses. There were \$64,854 and \$5,229 in forfeitures as of December 31, 2024 and 2023, respectively.

Note 2: Summary of Significant Accounting Policies

Following is a description of significant accounting and reporting policies of the Plan:

Basis of Presentation: The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates: The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Investment Valuation and Income Recognition: The Plan trustees are responsible for oversight of the Plan, determine the appropriateness of the Plan's investment offerings and monitor investment performance. Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Note 2: Summary of Significant Accounting Policies (Continued)

Contributions: Contributions from participants, along with any related employer matching contributions, are recorded in the period the employer withholds payroll deductions from Plan participants. The Companies' discretionary contribution is recorded when approved by the Companies' management and collectability is reasonably assured to participants.

Payment of Benefits: Benefits are recorded when paid to participants.

Subsequent Events: In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through October 1, 2025, the date the financial statements were available to be issued. During the period January 1, 2025 through October 1, 2025, the Plan did not have any material recognizable subsequent events.

Note 3: Fair Value Measurements

Generally Accepted Accounting Principles (GAAP) establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the assets or liabilities;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for measuring Plan investments:

Mutual Funds: The fair value of mutual funds is based on the closing price at year end as reported by the fund. Mutual funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 3: Fair Value Measurements (Continued)

Pooled Separate Accounts: Investments in pooled separate accounts are valued at fair value based on net asset value. The accounts offered are proprietary to Principal Life Insurance Company under a group annuity contract, and many invest exclusively in one underlying mutual fund traded on an established market. Those accounts investing in mutual funds are measured at net asset value, and the net asset value is used as a practical expedient to estimate fair value. While the accounts purchase shares of the underlying investments, neither the Plan nor participants own shares of the mutual funds or other investment contracts; instead, participants own “accumulation units” in the accounts.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There have been no changes in the methodologies used at December 31, 2024 and 2023.

In determining the appropriate levels, the Plan performs a detailed analysis of the assets that are to be reported at fair value. The tables below present the assets that are to be measured at fair value on a recurring basis by level within the fair value hierarchy as of December 31, 2024 and 2023:

Note 4: Information Certified by the Plan’s Custodians

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under the ERISA. Accordingly, the plan administrator has instructed the Plan’s independent auditors not to perform any auditing procedures with respect to information certified as complete and accurate by Principal Life Insurance Company and Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company (collectively referred to as Principal), the custodians of the Plan, except to compare such information to information included in the Plan’s financial statements and supplemental schedule.

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained or derived from information certified as complete and accurate by the Plan’s custodians.

Note 5: Notes Receivable from Participants

As of December 31, 2024 and 2023, 9 and 11 participants, respectively, were indebted to the Plan in the total amount of \$75,023 and \$105,502, respectively, as the result of loans made to them by the Plan. The loans are evidenced by promissory notes bearing interest at rates varying from 5.25% to 10.50% per annum, and are payable in installments, the latest of which is due in October 2029. The notes are fully secured by the participants’ vested account balances.

Note 6: Plan Termination

The Companies have the right under the Plan agreement to discontinue their contributions and to terminate the Plan, subject to applicable statutory provisions. In the event of termination, all Plan participants will become fully vested. The Companies have not indicated any intention to terminate the Plan.

However, as a result of a reduction of the Plan Sponsor's workforce in 2024 and 2023, the Plan experienced a partial plan termination as defined by ERISA in 2024. Under ERISA, a partial plan termination may occur if a significant percentage of the plan participants are terminated because of an action taken by the Plan Sponsor. If a partial plan termination occurs, full vesting is required for the terminated participants, but the remaining participants' vesting continues to be determined according to the plan provisions. As of December 31, 2024, terminated participants affected by the partial plan termination become fully vested in the Plan.

Note 7: Income Tax Status

The Internal Revenue Service (IRS) has ruled, in a letter dated June 30, 2020, that the Non-Standardized Pre-Approved Profit Sharing Plan with CODA, as amended, established by JM Pension Advisory, Inc., qualifies under applicable sections of the IRC. An employer who adopts this plan is generally considered to have a plan that is also qualified. The plan administrator and the Plan's sponsor believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC; therefore, the Plan is currently exempt from federal income tax. The Plan's federal tax returns are subject to examination by the IRS generally for a period of three years after the returns are filed.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator does not believe that the Plan has any uncertain tax positions. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress.

Note 8: Parties-In-Interest

The Plan offers various investment options which are products of Principal, custodian of the Plan. The Plan also uses Morgan Stanley Global as the Plan advisor. During the years ended December 31, 2024 and 2023, the Plan paid administrative expenses of \$48,353 and \$43,861, respectively, to Principal and Morgan Stanley Global. Certain officers and employees of the Plan sponsor are administrators of the Plan acting as fiduciaries and as trustees and are also participants in the Plan.

Note 9: Reconciliation of Financial Statements to Form 5500

There were no significant differences between the financial statements of the Plan as of and for the years ended December 31, 2024 and 2023 and the amounts reported on Schedule H (Financial Information) of Form 5500 (Annual Return/Report of Employee Benefit Plan).

Note 10: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 11: Administrative Expenses

The Plan's expenses are paid by either the Plan or the Companies, as provided by the plan document. Expenses paid directly by the Companies are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statements of changes in net assets available for benefits. In addition, certain investment-related expenses are included in net appreciation of fair value of investments.
