Except as discussed in the following paragraph, in planning and performing our audit of the financial statements of the Brentwood Country Club 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as of and for the year ended December 31, 2024, in accordance with auditing standards generally accepted in the United States of America, we considered the Plan's internal control over financial reporting (internal control) as a basis for designing audit procedures that are appropriate in the circumstances for the purpose of issuing our report on the financial statements, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, we do not express an opinion on the effectiveness of the Plan's internal control.

We were engaged to perform an ERISA Section 103(a)(3)(C) audit of those financial statements as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit did not extend to any statements or information related to the assets held for investment of the Plan ("investment information") by the Custodian that prepared and certified the statements or information regarding assets so held in accordance with 29 CFR 2520.103-5. Our audit also did not include a consideration of internal control relating to the investment information.

A deficiency in internal control exists when the design or operation of a control does not allow management or employees, in the normal course of performing their assigned functions, to prevent, or detect and correct, misstatements on a timely basis. A material weakness is a deficiency, or a combination of deficiencies in internal control, such that there is a reasonable possibility that a material misstatement of the Plan's financial statements will not be prevented, or detected and corrected, on a timely basis.

Our consideration of internal control was for the limited purpose described in the first two paragraphs and was not designed to identify all deficiencies in internal control that might be material weaknesses. Given these limitations, during our audit we did not identify and deficiencies in internal control that we consider to be material weaknesses. However, material weaknesses may exist that have not been identified.

Although our consideration would not necessarily disclose all matters that concern the internal control, we submit, for your consideration, certain comments and recommendations, which we believe are opportunities for strengthening the internal control.

This letter is intended solely for the information and use of the Plan Administrator and others within the Plan's management and is not intended to be and should not be used by anyone other than these specified parties.

We wish to express our appreciation for the cooperation and courtesies extended to our representative during the audit of the Plan. We would be pleased to discuss our comments with you further, should you so desire.

### **Participant contributions**

During the audit of the Plan for the year ended December 31, 2024, we noted instances in which amounts withheld from participants were not remitted to the Plan in a consistent manner. The DOL requires that participant contributions be remitted to the Plan on the earliest date on which they can be reasonably segregated from the Club's general assets but in no event later than the 15<sup>th</sup> business day following the end of the month in which amounts are contributed by employees or withheld from their wages, which is not considered a "safe harbor". Failure to remit participant contributions to the Plan in a timely and consistent manner may result in a prohibited transaction that must be separately reported to the DOL and may also result in penalties to the Club. We recommend that the Club establish policies and procedures to ensure participant contributions are remitted timely and consistently in accordance with such timeline.

### **Investments**

1. We noted during our audit that the Plan does not have written investment policy guidelines or adequate records supporting the basis for investment decisions. We recommend Plan management create written investment policy guidelines to establish investment mix, risk, safety, liquidity, and targeted investment returns. The investment policy would provide guidelines and support investment-related decisions made on behalf of the Plan and should be reviewed at least annually, and if appropriate, can be amended to reflect changes in the markets, plan participant objectives, or other factors relevant to the Plan. This process should be documented and recorded in the minutes to support the Plan sponsor's responsibility and fiduciary obligation.
2. We noted that there is no formal policy to review investment valuation. Investments are the most significant assets in a benefit plan, and Plan management is responsible for ensuring proper valuation and reporting of those assets. Each different investment has a unique valuation and disclosure considerations. Even if outside investment custodians, assets or fund managers, or other service providers are used to assist in determining the value of investments reported in the Plan's financial statements and on Form 5500, the Department of Labor holds Plan management responsible for the proper reporting of Plan investments. This responsibility cannot be outsourced or assigned to a party other than Plan management. Plan sponsors should have sufficient information to evaluate and independently challenge the valuation of Plan investments. Therefore, it is important that Plan management be familiar with the Plan's investments and the methods and significant assumptions used to value them, especially for investments for which readily determinable fair values do not exist. We recommend Plan management implement policies and procedures requiring formal review of investment valuation methods, including guidelines for challenging valuation, as applicable.

### **General**

1. The Plan utilizes a third-party service organization for administering its retirement plan. We recommend that the Plan Administrator review the service organization's internal control reporting (commonly referred to as SOC-1 reports). Such reports allow the Plan to assess and address the risks associated with the outsourced services.

**General (continued)**

2. We recommend that the Plan Administrator compile an accounting and internal control procedures manual containing policies and procedures designed to assist management with all aspects of the Plan's functions. Such a manual would serve as an aid in training new employees, improving internal communications, documenting and assuring the continuity of operational policies and procedures that have been approved by the Plan administrator. This document should be written with sufficient detail to allow new employees of the Plan sponsor the ability to complete the task by reviewing the manual. This document should be updated for any system or policy changes. A master manual of all procedures should be maintained in a secure location. At a minimum, the manual should include:

- Location of Plan-related documents. For example:
  - Executed Plan document
  - Current IRS determination letter
  - Executed amendments to the Plan document
  - Executed board minutes as they pertain to the Plan
  - Copy of the Plan's fidelity bond insurance
  - Copy of investment policy
- Operational compliance procedures. For example:
  - Reviewing Plan eligibility provisions and comparing them to actual practices
  - Reviewing the Plan's definition of compensation and comparing it to actual payroll procedures
  - Depositing participant deferrals in a timely manner
- Internal controls. For example:
  - Reviewing participant data provided to the Plan's third party administrator on a regular basis
  - Reviewing incoming information from the Plan's third party administrator
  - Reviewing Plan reporting
  - Reviewing investment valuation
- Financial reporting. For example:
  - External financial reporting and review
  - Review of the Form 5500 filing

## 2. (continued)

- Written set of policies and procedures designed to mitigate the Plan's risk with regard to regulatory compliance and to protect the Plan fiduciaries as they carry out their duties related to the Plan. These procedures should outline the various responsibilities applicable to Plan Administration and those parties that are responsible for executing the procedures.
  - Working with third party administrators ensuring IT compliance and security
  - Any other information deemed pertain to the Plan
3. As far as we could ascertain, there are no formal minutes maintained for actions taken by the Trustees of the Plan. With the complexity of investment alternatives and tax laws covering the qualifications of the Plan and fiduciary responsibilities of the Trustees, it is important that the Trustees adequately document the due diligence they exercise over operations of the Plan. We recommend the Trustees/Plan Administrator establish procedures for carrying out the above and document the establishment of those procedures in formal minutes. Procedures should include performance and documentation in the minutes of (a) an annual review of investment performance compared with market benchmarks for each related market sector; (b) a periodic review of the operations of the Plan as carried out by the Plan Administrator and monitor tax and qualification compliance, and approve Plan amendments, third-party administrator and investment and investment manager; and (c) review and approval of all benefit distributions.
4. We noted that Plan management does not conduct self-initiated audits of the Plan for possible compliance issues. Conducting a self-initiated audit can assist management in identifying compliance issues and developing procedures to prevent, detect and correct any errors. We recommend Plan management consider conducting self-initiated audits of the Plan's transactions (i.e., employee deferrals, investment valuations, benefit payments, etc.) on a periodic basis. The Department of Labor has been very active in auditing various retirement plans for compliance issues. A self-audit may uncover potential issues that can be corrected before significant issues arise.
5. We noted instances where non-participating employees, who are eligible to make contributions to the Plan, did not complete an enrollment form documenting their choice to decline participation in the Plan. We recommend the Club maintain a completed enrollment form for all participating and non-participating employees.
