### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Topco Associates LLC 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

**Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). #### Note 1. Plan Description

The following description of Topco Associates LLC 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the plan agreement for a complete description of the Plan's provisions.

**General:** The Plan is a defined contribution plan covering substantially all employees of Topco Associates LLC and TopSource LLC (together, the Company). Employees are eligible to participate on the first day of employment with the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions:** Under the 401(k) provisions of the Plan, participants may contribute up to 60% of pre-tax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Eligible participants are automatically enrolled in the Plan upon meeting the eligibility requirements. A participant will have 3% of compensation automatically deducted and contributed to the Plan, until the participant elects a higher or lower deferral rate. This deferral rate will automatically increase 1% each year until it reaches 10% of eligible compensation. Participants may also contribute amounts representing distributions from other qualified plans. The Plan also allows participants to make Roth 401(k) contributions and other employee after-tax contributions, which are treated as elective deferrals for all purposes of the Plan. For participants hired prior to January 1, 2010, the Company makes matching contributions of 33.33% of each eligible participant's pre-tax contributions, Roth 401(k) contributions, after-tax contributions and matching contributions on participant's deferrals shall not be in excess of 3% of his or her compensation. For participants hired on or after January 1, 2010, the Company makes matching contributions of 100% of each eligible participant's pre-tax contributions, Roth 401(k) contributions, after-tax contributions and matching contributions on participant's deferrals shall not be in excess of 2% of his or her compensation. The Company may also make an additional discretionary Company Matching Contribution and Company Non-Elective Contributions as declared by the Board of Directors. Discretionary Company Non-Elective contributions for the year ended December 31, 2024, amounted to \$2,500,644. Contributions are subject to certain limitations.

**Participant accounts:** Each participant's account is credited with the participant's contribution, Company matching contributions, allocations of plan earnings, discretionary Company contributions and charged with an allocation of administrative expenses. Allocations are based on specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting:** Participants are immediately vested in all contributions and earnings thereon for those participants that were hired prior to January 1, 2010. Participants with a hire date on or after January 1, 2010, vest in the Company Matching Contributions and Company Non-Elective Contributions and any earnings thereon based on years of continuous service. A participant is 100% vested after six years of credited service, with 20% annual vesting after completion of two years of service.

**Forfeitures:** At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$282,700 and \$203,405, respectively. These accounts are used to reduce future Company contributions or pay plan expenses. During the year ended December 31, 2024, \$374,115 was used to reduce Company contributions and pay plan expenses.

**Investment options:** Upon enrollment in the Plan, a participant may direct contributions in a variety of investment choices as more fully described in the Plan's literature. Participants may change their investment options at any time.

#### Note 1. Plan Description (Continued)

**Notes receivable from participants:** Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balances. The loan repayment period is not to exceed five years except for the purchase of a principal residence, for which the loan repayment period may not exceed 10 years. The loans are collateralized by the balance in the participant's account and bear an interest rate of 1% over the Prime Rate published in the Wall Street Journal, on the first business day of the month before the loan is originated. The interest rate is fixed for the life of the loan. The interest rates on loans currently outstanding ranged from 4.25% to 9.50%. Principal and interest are paid ratably through payroll deductions.

**Payment of benefits:** On termination of service, a participant's vested accrued benefit shall be paid in the form of a lump sum or installment payments. The Plan also permits in-service withdrawals at age 59½ and hardship withdrawals.

#### Note 2. Summary of Significant Accounting Policies

**Basis of accounting:** The financial statements of the Plan are prepared on the accrual basis of accounting.

**Accounting estimates:** The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Notes receivable from participants:** Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent loans are treated as distributions based upon the terms of the plan document.

**Investment valuation and income recognition:** Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Contributions:** Contributions from Plan participants and the related matching contributions from the employer are recorded in the year in which participant compensation is earned.

**Payment of benefits:** Benefits are recorded when paid.

**Subsequent events:** The Company has evaluated subsequent events for potential recognition and/or disclosure through October 13, 2025, the date that the financial statements were available to be issued.

#### Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820 are described below:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

**Shares of registered investment companies:** Valued at the daily closing price as reported by the fund. Shares of registered investment companies held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Units of common/collective fund:** Valued based on the NAV of units of the common/collective fund. The NAV, as provided by the trustee, is used as a practical expedient to estimating fair value. The NAV is based upon the fair value of the underlying investments comprising the trust less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

**Changes in fair value levels:** To assess the appropriate classification of investments with the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another.

Plan management evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits. For the year ended December 31, 2024, there were no transfers in or out of Level 3.

#### **Note 5. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

#### **Note 6. Related-Party and Party-in-Interest Transactions**

Empower Annuity Insurance Company of America, an affiliate of Empower Trust Company, LLC, the Plan trustee and custodian, provides recordkeeping services to the Plan. These transactions qualify as party-in-interest. Fees for these services incurred by the Plan were \$68,605 for the year ended December 31, 2024.

Certain administrative expenses are being paid by the Company. Certain employees of the Company are performing services for the Plan and are not compensated by the Plan.

#### **Note 7. Tax Status**

Effective November 2, 2021, the Plan adopted a pre-approved non-standardized profit sharing plan (the pre-approved Plan) sponsored by Great-West Trust Company, LLC. The pre-approved Plan has received an opinion letter from the Internal Revenue Service (IRS) as to the pre-approved Plan's qualified status dated June 30, 2020. The Company has relied on the pre-approved Plan opinion letter. The Company believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **Note 8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
