### Opinion

We have audited the accompanying financial statements of AMS Mechanical Holdings, Inc. Employee Stock Ownership Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the information in the accompanying schedule is fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

### **NOTES TO FINANCIAL STATEMENTS**

#### **NOTE A - DESCRIPTION OF PLAN**

The following description of the AMS Mechanical Holdings, Inc. Employee Stock Ownership Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### GENERAL

AMS Mechanical Holdings, Inc. (Company) established the Plan effective as of January 1, 2016. The Plan was amended and operates, in relevant part, as a leveraged employee stock ownership plan (ESOP) and is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code (IRC) of 1986, as amended, and is subject to the applicable provisions of Employee Retirement Income Security Act of 1974(ERISA). The Plan is administered by the Chief Financial Officer of the Company and the ESOP Committee comprising individuals appointed by the Company's Board of Directors. The trust department of an independent third-party bank is the Plan's Trustee (Trustee).

On December 30, 2016, the Plan purchased 12,000 shares of the Company's common stock using the proceeds of a note payable (see Note G) and holds the common stock in a trust established under the Plan (Trust). The stock was purchased at a price of \$250 per share, for an aggregate purchase price of \$3,000,000. Following the purchase, the Company split the shares 8.3333:1 resulting in 100,000 issued and outstanding shares held by the Plan, and a split-adjusted share price of \$30 per share.

The borrowing is collateralized by the unallocated shares of the Company's common stock. The lender (the Company) has no rights against shares of common stock once they are allocated to participants in accordance with the terms of the ESOP.

#### ELIGIBILITY

An employee of the Company who has attained age 21 and has completed one year of employment of at least 1,000 hours of service, is eligible to participate in the Plan, except for independent contractors, nonresident aliens, and leased or union employees. Initial enrollment is available on the first day of the month following the satisfaction of eligibility requirements.

#### CONTRIBUTIONS

Employer contributions to the Plan are at the discretion of the Company and are accrued upon approval of the Company's Board of Directors. Employer contributions may be paid in cash or in shares of Company stock, or both, as determined by the Company's Board of Directors. Employer contributions may also be paid in cash in such amounts and at such times, as may be required to provide the ESOP with funds sufficient to pay when due any principal and interest required by the note payable, except to the extent such payments have been satisfied by the Trustee from dividends. Employee contributions are not permitted.

VESTING

Vesting in the Company's ESOP contributions is based on years of service. Upon termination of employment for reasons by death and disability, participants will receive 100% of their participant account balance.

PAYMENT OF BENEFITS

Distributions on account of death, disability, or normal retirement are made in a lump sum in the Plan year following the event. Distributions for other separations from service commence in the fifth Plan year following the separation from service. The amount to be distributed is based upon the immediately preceding valuation date. Distributions are made in cash or, if a participant elects, in the form of Company common stock plus cash for any fractional share of common stock. Under the provisions of the Plan, the Company is obligated to repurchase participant shares, which have been distributed under the terms of the Plan if the shares are not publicly traded or if the shares are subject to trading limitations.

VOTING RIGHTS

Each participant is entitled to exercise voting rights attributable to the shares allocated to his or her account and is notified by the Trustee prior to the time that such rights are to be exercised. If a corporate matter requires voting of shares of Company stock for the approval or disapproval of any corporate merger or consolidation, recapitalization, liquidation, dissolution, sale of substantially all assets of a trade or business, or such similar transaction as the Secretary of the Treasury may prescribe in regulations, then the participants may direct the Trustee on how to vote the shares allocated to their accounts. If such instructions are not received by the Trustee at least ten business days prior to the meeting in which such vote shall occur, the Trustee shall vote for such allocated shares as directed by the ESOP Committee. The Trustee is also required to vote for any unallocated shares as directed by the ESOP Committee.

#### NOTE A - DESCRIPTION OF PLAN (Continued)

##### PARTICIPANT ACCOUNTS

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited as of the last day of each Plan year with an allocation of shares of the Company's common stock released by the Trustee from the unallocated account and forfeitures of terminated participants' non-vested accounts. Only those qualified employees who were active participants of the Plan and completed 1,000 hours of service during the Plan year will receive an allocation. Allocations are based on a participant's eligible compensation, relative to total eligible compensation. Plan earnings are allocated to each participant's account based on the ratio of the participant's account balance.

##### PUT OPTION

Under federal income tax regulations, the Company common stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the current appraised value of the stock. The Company can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

##### DIVERSIFICATION

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company common stock into investments that are more diversified. Participants who are at least age 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a 6-year period. In each of the first 5 years, a participant may diversify up to 25% of the number of post-1986 shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changes to 50%. Participants who elect to diversify receive a cash distribution. The election to diversify is made subsequent to year-end based upon the shares of employer stock in the participant's account at year-end.

##### FORFEITED ACCOUNTS

Plan forfeitures are allocated to each participant's account based upon the relation of the participant's eligible compensation to total eligible compensation for the Plan year. Forfeitures allocated to participants during the year ended December 31, 2024 approximated \$100. As of December 31, 2024 and 2023, there were no forfeited non-vested accounts to be allocated to participant accounts.

#### NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The summary of significant accounting policies is presented to assist in understanding the Plan's financial statements. The financial statements and notes are representations of the Plan's management, which is responsible for their integrity and objectivity. These accounting policies conform to accounting principles generally accepted in the United States of America and have been consistently applied in the preparation of the financial statements.

#### NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

##### BASIS OF ACCOUNTING

The financial statements of the Plan are prepared using the accrual method of accounting in conformity with generally accepted accounting principles.

##### USE OF ESTIMATES

The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Due to the inherent uncertainty involved in making estimates, actual results may differ from those estimates.

##### ALLOCATIONS

The financial statements of the Plan as of December 31, 2024 and 2023, and for the year ended December 31, 2024, present separately the assets and liabilities and changes therein pertaining to (a) the accounts of employees with rights in allocated common stock (allocated) and (b) common stock not yet allocated to employees (unallocated), including shares that are committed to be released. Shares are released from collateral and become allocated generally in the period in which debt service is actually paid.

##### INVESTMENT VALUATION AND INCOME RECOGNITION

The shares of Company common stock are reported at fair value. See Note F for discussion of fair value measurements. Dividend income is accrued on the ex-dividend date. Purchases and sales of securities are recorded on a trade-date basis. Realized gains and losses from security transactions are reported on the average cost method. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### PAYMENT OF BENEFITS

Benefit obligations are recorded when paid.

##### ADMINISTRATIVE EXPENSES

All administrative expenses of the Plan have been paid directly by the Company. Expenses that are paid by the Company are excluded from these financial statements.

##### SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through October 14, 2025, the date which the financial statements were available to be issued.

#### NOTE C - PLAN TERMINATION

The Company reserves the right to terminate the Plan at any time, subject to Plan provisions. Upon termination of the Plan, the ESOP Committee directs the Trustee to pay all liabilities and expenses of the ESOP and to sell shares of financed common stock held as collateral to the extent it determines such sale to be necessary in order to repay the loan. Subsequently, the interest of each participant in the Trust will be distributed to such participant or his or her beneficiary at the time prescribed by the Plan terms and the IRC.

#### NOTE D - TAX STATUS

The Plan is an individually designed plan sponsored by the Company. The Plan obtained its latest opinion letter on April 24, 2018, by which the Internal Revenue Service has determined and informed the Company that the Plan and related trust, as then designed, were designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the U.S. Federal or Illinois taxing jurisdictions. The plan administrator has analyzed the tax positions taken by the plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### NOTE E - INVESTMENTS

#### NOTE F - FAIR VALUE MEASUREMENTS

FASB ASC Topic 820, *Fair Value Measurements*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC Topic 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

*Company common stock:* The fair value of the Company common stock held by the Plan is valued utilizing an appraisal, prepared by an independent professional appraiser. This appraisal was based upon a combination of the market and income valuation techniques consistent with prior years. The appraisal is reviewed by the ESOP Plan Trustee and Board of Directors.

*Registered investment companies:* Valued at the net asset value (NAV) of shares, which are based on quoted market prices, held by the Plan as of the end of the year.

The preceding methods described may produce a fair value calculation that may not be indicative of the net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE G - NOTE PAYABLE**

In 2016, the Plan entered into a \$3,000,000 term loan agreement with the Company. The proceeds of the loan were used to purchase Company common stock. Unallocated shares are collateral for the loan. Shares are released from collateral and allocated to participants as payments of principal and interest are made. The number of shares released in any Plan year shall equal the number of shares of Company stock held as collateral immediately before the release of any shares for the Plan year multiplied by a fraction with a numerator equal to all principal and interest payments made on the loan for such Plan year and a denominator equal to the numerator plus the total principal and interest payable under the loan for all subsequent Plan years. This resulted in 6,669 and 6,796 shares being released and allocated for the years ended December 31, 2024 and 2023, respectively.

The agreement provides for the loan to be repaid over 15 years. The loan bears interest at 2.26%. The fair value of the note payable as of December 31, 2024 and 2023, was approximately \$1,200,000 and \$1,400,000, respectively, determined by using interest rates currently available for issuance of debt with similar terms, maturity dates, and nonperformance risk.

**NOTE H - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE I - PARTY-IN-INTEREST TRANSACTIONS**

The Plan invests in Company common stock and has indebtedness to the Company. These are related party and party-in-interest transactions. As described in Note B, the Company pays all Plan expenses. The Plan has a number of service providers. Such providers are parties in interest under ERISA.
