INDEPENDENT AUDITOR'S REPORT

To the 401(k) Fiduciary Committee of
AML Riverside, LLC 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of AML Riverside, LLC 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements, as a whole, are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

NOTE 1 — DESCRIPTION OF THE PLAN

The following description of the AML Riverside, LLC 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan agreement (Agreement) for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution covering all eligible employees of AML Riverside, LLC (AML or Employer) and its affiliates who are at least 21 years of age and have completed three months of service. Eligible employees may begin deferring compensation, and employer contributions commence, on the first day of the month following the satisfaction of the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The 401(k) Fiduciary Committee is responsible for oversight of the Plan, determining the appropriateness of the Plan's investment offerings and monitoring investment performance.

Plan Administration

The Employer has contracted Principal Life Insurance Company, Principal Global Investors Trust Company, and Principal Trust Company (collectively, Principal) to hold the Plan's assets, execute investment transactions, perform allocations of contributions and investment earnings, and make benefit payments.

Contributions

Each year, participants may contribute up to 100% of annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 4% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. The Employer matches 100% of the first 4% of base compensation that a participant contributes to the Plan as a safe harbor matching contribution. Additional discretionary contributions may be contributed, but none were authorized for the year ended December 31, 2024. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions and Employer safe harbor matching contributions, as well as allocations of the Employer's discretionary contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

NOTE 1 — DESCRIPTION OF THE PLAN (Continued)

Vesting

Participants are vested immediately in their contributions and Employer safe harbor matching contributions, plus actual earnings thereon. Employer discretionary contributions are subject to a three-year cliff vesting schedule, under which a participant becomes fully vested after completing three years of service. No vesting occurs before the completion of three years of service. Participants are considered 100% vested if they reach the age of 65, become totally disabled as defined in the Agreement, or die, while employed.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their vested balance. The loans are secured by the balance in the participant's account. The loan interest rate is set at 1% above the prime rate, as defined. Principal and interest is paid ratably through monthly payroll deductions.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant (or a participant's beneficiary in the event of death) may elect to receive a lump-sum distribution equal to the value of the participant's vested interest in his or her account. A participant may also withdraw a portion of his or her vested Plan benefit upon attaining age 59 1/2 while still employed by the Employer. In addition, disability and hardship distributions are permitted if certain criteria are met.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right, under the Plan, to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

NOTE 2 — SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on an accrual basis of accounting, in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of the financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

NOTE 2 — SIGNIFICANT ACCOUNTING POLICIES (Continued)

Risks and Uncertainties

Under the Plan, participants invest in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Investment Valuation and Income Recognition

Investments are reported in the financial statements at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. See Note 4 for discussions of the fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is reported on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Contributions

Contributions from Plan participants and the safe harbor matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation. Employer discretionary contributions are recorded in the year in which the related compensation was paid, if any.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Certain investment-related expenses are included as a reduction of net appreciation in fair value of investments.

Payment of Benefits

Benefits are recorded when paid.

NOTE 4 — FAIR VALUE MEASUREMENTS

GAAP establishes a three-tier fair value hierarchy, which categorizes the inputs used in measuring fair value. These categories include (in descending order of priority): Level 1, defined as observable inputs such as quoted prices in active markets for identical assets; Level 2, defined as inputs other than quoted prices in active markets that are either directly or indirectly observable; and Level 3, defined as unobservable inputs in which little or no market data exists, therefore requiring the Plan to develop its own assumptions. The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- *Mutual funds*: Valued based on quoted prices of identical assets in active markets.
- *Common collective trusts and pooled separate accounts*: The fair value of units are valued at net asset value, determined using available market information of the underlying securities including quoted prices for identical or similar securities in active or nonactive markets, similar to a mutual fund. These redemption values are the values at which a participant would transact on a daily basis. There are no restrictions on the ability to transact with the funds at net asset value.

NOTE 5 — FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

In 2023, the Plan entered into a traditional fully benefit-responsive guaranteed investment contract, Principal Fixed Income Guaranteed Option (PFIGO), with Principal, which had a balance of \$72,999 and \$63,959 at December 31, 2024 and 2023, respectively. This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Principal, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Under the terms of the contract, the crediting rate is reset on a semiannual basis. There is no minimum crediting rate.

PFIGO is not a portfolio of contracts whose yields are based on changes in fair value of underlying assets as would be found in a stable value fund. As a result, the average yield earned by the Plan is the yield earned (interest credited) on the group annuity contracts. The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. PFIGO has a guarantee backed by the assets in the multi-billion-dollar general account of Principal. The general account consists of over 7,000 investments, which include corporate bonds, asset-backed securities, commercial real estate mortgages, government bonds, and short-term cash equivalents.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include an employer-level liquidation or employer-initiated transfer of the Plan's interest in PFIGO will be subject to either a 12-month irrevocable advance notice or a 5% surrender charge, whichever the Plan would choose at the termination event. A 5% surrender charge will also apply if the cumulative percentage of participant transfers from the PFIGO exceeds 25% of the Plan's interest in the contract during the 12-month period immediately preceding the employer-level surrender of the Plan's interest in the contract. Plan management believes that the occurrence of an event that would cause the fund to transact at less than contract value is not probable.

There are no circumstances that would allow Principal to terminate the contract and settle at a value other than the contract value.

NOTE 6 — PLAN MERGER

Effective July 1, 2024, the Plan was amended to allow participants with prior service at Midwest Veterinary Services, Inc. (MVS) to receive service credit for enrollment and vesting purposes. As a result, net assets of approximately \$4,387,000 were transferred into the Plan in November 2024, and employees of MVS became participants of the Plan.

NOTE 7 — PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by Principal. Fees incurred by the Plan for the investment management services are included in net appreciation in fair values of investments. Therefore, these transactions with Principal qualify as party-in-interest transactions. However, all such transactions are exempt and are not prohibited by ERISA. Principal also charged administrative fees of \$46,495 for the year ending December 31, 2024.

NOTE 8 — INCOME TAX STATUS

The Plan is using a prototype plan document developed by Qualified Plan Consultants LLC (QPC). QPC received an opinion letter from the IRS dated June 30, 2020, which states that the prototype plan document satisfies the applicable provisions of the Internal Revenue Code (IRC). The Plan itself has not received a determination letter from the IRS. However, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. As of December 31, 2024 and 2023, no such uncertain positions exist.

NOTE 9 — PROHIBITED TRANSACTIONS

During the years ended December 31, 2024 and 2023, the Employer inadvertently failed to deposit participant deferrals of approximately \$180,603 and \$211,286, respectively, within the required timeframe as stated by the Department of Labor (DOL). The DOL considers late deposits to be prohibited transactions. The Employer made deposits into the Plan for lost earnings attributable to the 2024 delinquent contributions to fully correct the prohibited transactions subsequent to year end. The Employer is working to calculate and pay the lost earnings on the 2023 contributions.

NOTE 10 — SUBSEQUENT EVENTS

Effective January 1, 2025, the Plan was amended to implement an automatic annual increase of 1%, up to a maximum of 10% for participant contributions. The amendment also allows participants with prior service at TriRx will receive service credit for vesting purposes. As a result, net assets of approximately \$15,000,000 have been rolled into the Plan during 2025.

The Plan's management has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued.
