**Note 1: Description of Plan**

The following description of Peri Formwork Systems, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution retirement plan established by Peri Formwork Systems, Inc. (the Company) under a Non-Standardized Pre-Approved Profit Sharing Plan with CODA, as amended, sponsored by Fidelity Management & Research Company. The Plan generally covers all employees of the Company who have been employed at least one month and who have attained the age of 18. The Plan qualifies under Section 401(k) of the Internal Revenue Code (IRC) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Participant Contributions: The Plan generally allows eligible employees to contribute an amount not to exceed the lesser of 100% of their compensation or an amount which, when added to other additions (exclusive of earnings) to the participant's account in any plan year, does not exceed the maximum limitation on annual additions to a participant's account under applicable provisions of the IRC. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participant contributions are made through payroll deductions. Each participant designates the percentage of their contribution which is to be invested in one or more of the available investment fund options. The Plan provides for an initial automatic enrollment of eligible participants equal to 4% of the participants' qualifying wages with an election required by the employee to opt-out or change their contribution percentage. The automatic enrollment feature of the Plan provides for a 1% annual escalation of the participant's deferral rate to a maximum of 10% subject to the participant's approval. Participants are also allowed to contribute distributions received from other qualified retirement plans. In addition, participants may also make Roth contributions to the Plan. In the event the Plan fails to satisfy relevant nondiscrimination provisions, participant contributions may be returned to certain active participants. The liability "Excess participant contributions payable" in the statements of net assets available for benefits represents the amount to be refunded, if applicable for the Plan year.

Employer Contributions: The Company is required to make matching contributions after a participant has been employed for at least six months. The Company is required to match 75% of each participant's eligible contributions to the Plan with the maximum employee contribution eligible for matching being 6% of compensation. The Plan also allows the Company to make additional discretionary matching contributions.

Participant Accounts: Each participant's account is credited with the participant's contributions, allocations of the Company's contributions, and Plan earnings and losses. Plan earnings and losses are allocated based on the account balances of the participants. The benefit to which a participant is entitled is that which can be provided from the participant's vested account balance. All Plan assets as of December 31, 2024 and 2023, with the exception of the forfeiture account, have been allocated to participant accounts.

Vesting: Participants are immediately vested in all their contributions and investment earnings thereon. Vesting in the Company's contributions and investment earnings thereon is based on years of service. A participant is 100% vested after five years of credited service. In the event of death, disability or retirement, a participant's interest is immediately fully vested in the employer contributions and related earnings under terms set forth in the Plan agreement.

Notes Receivable from Participants: Participants may borrow from their accounts up to the lesser of \$50,000 or 50 percent of their vested account balance. The loans, which must be for at least \$1,000, bear interest at prevailing rates for similar loans as determined by the plan administrator, and are carried at their outstanding principal balance. Repayments are generally made through payroll deductions. A participant may only have one loan outstanding at any one time.

Payment of Benefits: Upon termination of employment, a participant may elect to have vested Plan benefits distributed as a lump-sum or in installment payments. If employment is terminated prior to retirement, the participant may receive a mandatory distribution depending on their vested account balance in the Plan. Participants are generally required to take minimum distributions upon reaching the age of 73. In-service withdrawals are permitted after a participant has attained 59½ years of age. Hardship withdrawals by a participant are permitted if specified criteria are met.

Forfeitures: The non-vested portion of a participant's account balance is generally forfeited upon termination of employment. As of December 31, 2024 and 2023 forfeited non-vested accounts totaled approximately \$33,000 and \$17,000, respectively. Forfeitures are generally utilized to reduce Company contributions but can be used to pay the Plan's administrative expenses. During the years ended December 31, 2024 and 2023, approximately \$91,000 and \$125,000, respectively, was used to reduce Company contributions.

**Note 2: Summary of Significant Accounting Policies**

Following is a description of the significant accounting and reporting policies of the Plan:

Basis of Presentation: The financial statements of the Plan are prepared under the accrual method of accounting in accordance with generally accepted accounting principles in the United States of America (GAAP).

Use of Estimates: The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Investment Valuation and Income Recognition: The Plan trustees are responsible for oversight of the Plan, determine the appropriateness of the Plan's investment offerings and monitor investment performance. Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Contributions: Contributions from participants, including any related employer matching contributions, are recorded in the period the employer withholds payroll deductions from Plan participants. Employer discretionary contributions are recorded in the period when approved by the Company's management and collectability is reasonably assured.

Benefits Paid to Participants: Benefit are recorded when paid.

Subsequent Events: In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through October 10, 2025, the date the financial statements were available to be issued. During the period January 1, 2025 through October 10, 2025, the Plan did not have any material recognizable subsequent events.

**Note 3: Fair Value Measurements**

GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual Funds: The fair value of mutual funds is based on the closing price at year-end as reported by the fund. Mutual funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Interest-Bearing Cash: Interest-bearing cash represents an investment in a money market mutual fund at fair value, based on the closing price at year-end as reported by the fund.

There has been no change in the methodologies used to value investments at December 31, 2024 and 2023.

The methods described above may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

In determining the appropriate levels, the Plan performs a detailed analysis of the assets that are to be reported at fair value. The tables below present the assets measured at fair value on a recurring basis by level within the hierarchy as of December 31, 2024 and 2023:

**Note 4: Information Certified by the Plan Trustee**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the plan administrator has instructed the Plan's independent auditors not to perform any auditing procedures with respect to information certified as complete and accurate by Fidelity Management Trust Company (Fidelity), the Trustee of the Plan, except to compare such information to information included in the Plan's financial statements and supplemental schedule.

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments in interest-bearing cash, mutual funds and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, dividends and interest income, and interest income on notes receivable from participants for the years then ended, was derived from information certified as complete and accurate by Fidelity.

**Note 5: Notes Receivable from Participants**

As of December 31, 2024 and 2023, 108 and 97 participants, respectively, were indebted to the Plan in the total amount of \$895,449 and \$808,216, respectively, as a result of loans made to them by the Plan. The loans are evidenced by promissory notes bearing interest in the range of 3.25% to 8.50% per annum, and are payable in installments, the latest of which is due in August 2032. The notes are fully secured by the participants' vested account balances.

**Note 6: Plan Termination**

The Company has the right under the Plan agreement to discontinue its contributions at any time and to terminate the Plan, subject to applicable statutory provisions. In the event of termination, all participants will become fully vested. The Company has not indicated any intention to terminate the Plan.

**Note 7: Income Tax Status**

The Internal Revenue Service (IRS) has ruled in a letter dated June 30, 2020, that the Non-Standardized Pre-Approved Profit Sharing Plan with CODA and related trust established by Fidelity Management & Research Company (see Note 1) qualifies under applicable sections of the IRC. An employer who adopts this plan is generally considered to have a plan that is also qualified. The plan's administrator and the plan's sponsor believe that the Plan, as amended, is designed and currently operating in compliance with the applicable requirements of the IRC. The Plan's federal tax returns are subject to examination by the IRS generally for a period of three years after the returns are filed.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator does not believe that the Plan has any uncertain tax positions. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits in progress for any tax periods.

**Note 8: Reconciliation of Financial Statements to Form 5500**

The financial statements of the Plan for the year ended December 31, 2024 and 2023 did not differ from the amounts reported on Schedule H (Financial Information) of Form 5500 (Annual Return/Report of Employee Benefit Plan) filed with the IRS.

**Note 9: Parties-in-Interest**

The Plan offers participants various investment options which are managed by an affiliate of Fidelity, the custodian of the Plan; therefore, these transactions qualify as party-in-interest transactions. In addition, Fidelity provides various recordkeeping services for which it is compensated. For the years ended December 31, 2024 and 2023, the Plan paid administrative expenses totaling \$10,624 and \$4,190, respectively, to Fidelity. During the years ended December 31, 2024 and 2023, the Plan paid advisor fees to a third party totaling \$66,306 and \$45,176, respectively. In addition, certain officers and employees of the Company are administrators of the Plan acting as fiduciaries and are also participants in the Plan.

**Note 10: Administrative Expenses**

The Plan agreement provides that the Company, at its discretion, can agree to pay administrative expenses of the Plan. For the years ended December 31, 2024 and 2023, the Company paid or incurred plan expenses of approximately \$21,000 in each year. Expenses paid by the Company are excluded from these financial statements.

**Note 11: Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
