### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

L.M. Cohen & Co. LLP Certified Public Accountants (“LMC Certified Public Accountants”, “we”, “us”, or “our”) have performed an audit of the accompanying financial statements of ULE Group Corp. 401(K) Profit Sharing Plan (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

**NOTE 1 - DESCRIPTION OF THE PLAN**

The following description of the ULE Group Corp. 401(K) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General**

The Plan was established on January 1, 2016, to provide benefits to eligible employees. The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") covering eligible employees of ULE Group Corp. and United Lighting Electrical Corp. (collectively, the "Company" or "Employers"). Eligibility to participate in the Plan for pretax deferrals, roth elective deferrals, employer matching contributions, employer safe harbor nonelective contributions, and employer profit sharing contributions is contingent upon completing three (3) months of service and having attained age twenty-one (21). In addition, eligibility for profit sharing contributions requires the completion of three (3) months of service and having attained age of twenty-one (21). Collective bargaining (union) employees, non-resident aliens, leased employees, independent contractors, and interns are excluded from eligibility.

Assets of the Plan are allocated to participant accounts based on specific contributions made by each participant and respective employer contribution made by the Company. Investment income (loss) is credited to each account based on appreciation (depreciation) of specific assets held in each participant account and any earnings thereon.

**Plan Contributions**

Each year, participants may contribute up to 100% of pre-tax and/or after-tax ("Roth") of annual compensation, as defined in the Plan, not to exceed the maximum allowable limits as prescribed by the Internal Revenue Code ("IRC"). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans ("Rollovers").

The Company, at its discretion, may make safe harbor nonelective, employer matching, or profit sharing contributions to eligible employees under the terms of the Plan. The amount of profit sharing contributions may vary from year to year. For plan years in which a safe harbor contribution is elected, the Company will make a contribution equal to 3% of a participant's compensation as defined in the Plan document. Safe harbor nonelective contributions and profit sharing contributions may be made in the same plan year. Safe harbor nonelective contributions for the year ended December 31, 2024 were \$196,530. Profit sharing contributions for the year ended December 31, 2024 were \$378,056.

Participants direct the investments of their contributions and the Company's contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service ("IRS") limitations.

**NOTE 1 - DESCRIPTION OF THE PLAN** (Continued)

**Participant Accounts**

Each participant's account is credited with the participant's contribution, allocations of the Company's matching and discretionary contributions, Plan gains or losses, forfeitures, and is charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Investment Options**

Upon enrollment in the Plan, participants direct the investment of their contributions and Company contributions into various investment options offered by the Plan. Participants may direct their contributions into one or more investment options offered under the Plan. All employer contributions will be invested in the same proportion as the participant-elected contribution. Participants may change their investments as frequently as they choose.

**Vesting**

Participant's contributions, safe harbor nonelective contributions, and earnings thereon are immediately fully vested. Company profit sharing and employer matching contributions are subject to a vesting schedule. The following table illustrates the percentage of any Company profit sharing or employer matching contributions that an employee is entitled to, based on the number of years of continuous service with the Company:

Less than 2	0%
2 but less than 3	20%
3 but less than 4	40%
4 but less than 5	60%
5 but less than 6	80%
6 or more	100%

**Notes Receivable from Participants**

Participants may borrow from their vested amounts a minimum of \$1,000 and up to a maximum equal to the lesser of 50% of the participant's vested interest in the Plan, not to exceed 50,000. Loan terms range from one to five years and may be extended for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at the Prime rate plus one percent (1%). Principal and interest are paid ratably through payroll deductions. Participants may only have one loan outstanding at any time.

**Payments of Benefits**

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount, equal to the value of the participant's vested interest in his or her account, or installments over a period of time, as defined. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution or, if the vested account balance exceeds \$5,000, in installments in accordance with minimum required distribution rules per the Plan document. The Plan also provides for in-service distributions subject to conditions and limitations provided for in the Plan document.

**Forfeited Accounts**

Forfeitures are created when participants terminate employment before becoming vested in their full benefits under the Plan. Forfeitures may be used to reduce employer contributions or allocated to the remaining participants. In addition, the Plan may use forfeitures to pay the administrative expenses of the Plan. At December 31, 2024, forfeited nonvested accounts totaled \$3,033. Employer contributions for 2024 were reduced by \$23,951 from forfeited nonvested accounts.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting – Compliance with the Accounting Standards Codification (ASC) of the Financial Accounting Standards Board (FASB)**

The financial statements of the Plan are prepared using the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies utilizing information provided by the trustees. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. If a participant does not make loan repayments and the Plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

**Excess Contributions Payable**

Amounts payable to participants for employer contributions in excess of amounts allowed by the IRS under the Plan document are recorded as a liability with a corresponding reduction to contributions. At December 31, 2024, the Plan had no excess contributions payable.

**Payment of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid by either the Plan or the Company, as provided by the Plan's provisions. Administrative expenses paid by the Plan include recordkeeping fees, trustee fees, and related expenses.

**NOTE 3 - INVESTMENT CERTIFICATIONS**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, Capital Bank and Trust Company and Principal Life Insurance Company, the trustees of the Plan, have certified the completeness and accuracy of all investments and related investment activity in the accompanying statement of net assets available for benefits as of December 31, 2024, the statement of changes in net assets available for benefits for the year then ended, and the accompanying supplemental schedule, Schedule H, line 4i – schedule of assets (held at end of year) as of December 31, 2024.

**NOTE 4 - FAIR VALUE MEASUREMENTS**

ASC Topic 820, Fair Value Measurement (ASC Topic 820), provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC Topic 820 are described as follows:

Level 1            Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2            Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by observable or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3            Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. There are no Plan assets requiring the use of Level 3 inputs for the periods presented.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission ("SEC"). These funds are required to publish their net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Pooled Separate Accounts:* Valued as practical expedient based on the NAV of units held by the Plan at year-end. The calculated NAV is directly related to the NAV of the underlying investment adjusted for dividends on distributions received by the custodian and the daily equivalent of any fees charged. The investments held by the pooled separate account are traded on an active market.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value (“NRV”) or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following table sets forth by level, within the fair value hierarchy, the Plan’s assets at fair value.

Gains and losses included in changes in net assets available for benefits for the year ended December 31, 2024 are reported in net appreciation (depreciation) in fair value of investments.

The Plan's policy is to recognize transfers between Levels 1 and 2 and into and out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the year ended December 31, 2024, there were no significant transfers between Levels 1 and 2 and no transfers into or out of Level 3.

**NOTE 5 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the Plan provides 100% vesting, and the net assets of the Plan will either be distributed to the participants and beneficiaries of the Plan, or the participants' benefits will be transferred to another Plan sponsored by the Company.

**NOTE 6 - RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are shares of mutual funds and pooled separate accounts managed by Capital Bank and Trust Company and Principal Life Insurance Company.

Capital Bank and Trust Company and Principal Life Insurance Company are the trustees as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. The Plan allows for transactions with certain parties who may perform services or have fiduciary responsibilities to the Plan. These transactions are permitted under the provisions of the Plan and are exempt from the prohibition of party-in-interest transactions under ERISA and applicable exemptions promulgated thereunder. The Plan made direct payments to the Plan's trustees and third-party administrator totaling \$13,817 for the year ended December 31, 2024, which is included in administrative expenses on the accompanying statement of changes in net assets available for benefits.

The Plan sponsor pays all other fees related to the operation of the Plan directly.

**NOTE 7 - TAX STATUS**

The IRS has determined and informed the Company by a letter dated June 30, 2020 that the Plan and related trust are designed in accordance with applicable sections of the IRC. The Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 8 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 9 - SUBSEQUENT EVENTS**

Plan management has performed its evaluation of subsequent events through October 14, 2025, the date the financial statements were available to be issued.

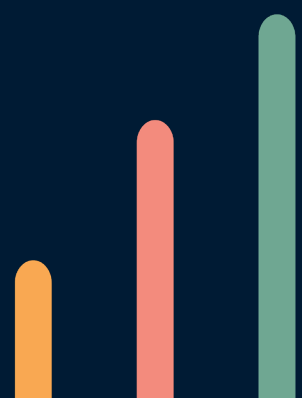
