NOTE 1 – DESCRIPTION OF PLAN

The following description of Bank Independent Stock Bonus Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. The Plan Sponsor is Bank Independent (Company, Plan Sponsor), a 100% owned subsidiary of BanIndependent, Incorporated.

General: The Plan is a defined contribution plan for full-time employees of the Company who have one year of service and are age twenty-one or older. It is subject to the provisions of the Employee Retirement Income Security Act (ERISA), as amended. Effective January 1, 2005, the Plan is no longer offered as an investment option to employees.

Contributions: The Plan is a non-contributory plan. Employer contributions are contributed at the option of the Company's board of directors. For 2024, no contributions were made to the Plan.

Participants' Accounts: Each participant's account is credited with an allocation of (a) the Company's contribution and (b) Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant eligible wages or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. All investments are nonparticipant-directed.

Retirement, Death and Disability: A participant is entitled to 100% of his or her account balance upon retirement, death or disability.

Vesting: Vesting in participants' accounts plus earnings thereon is based on years of continuous service. A participant is 100% vested after 3 years of credited service.

Forfeitures: The non-vested portion of terminated participants accounts plus earnings thereon are forfeited and are reallocated. For the year ended December 31, 2024, there were no forfeited amounts.

Payment of Benefits: On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over a ten-year period. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Loan Provisions: Loans are not permitted by the Plan.

Administrative Expenses: Certain costs incurred in the administration of the Plan have been paid by the Company.

Put Option: If BanIndependent, Incorporated common stock is distributed to a participant and such stock is not readily tradeable on an established securities market, a participant has a right to require the Plan Sponsor to repurchase the stock distributed to such participant under a fair valuation formula. Such stock put transactions shall be subject to the provisions of the Plan.

Voting Rights: The Trustees shall vote all BanIndependent, Incorporated common stock held as Plan assets. If the Trustees do not timely receive voting directions from a participant with respect to any BanIndependent, Incorporated stock allocated to that participant's stock account, the Trustees shall vote such BanIndependent, Incorporated stock.

Investment Diversification: Each participant or former participant who has completed ten years of service and has attained age 55 may elect within ninety days after the close of each plan year to direct the Plan Sponsor in writing to diversify up to twenty-five percent of the total number of shares of BancIndependent, Incorporated common stock acquired by or contributed to the Plan that have been allocated to their account. The Plan Sponsor may satisfy the diversification election by permitting the participant to elect to receive a lump sum distribution of the applicable portion of the balance transferred to the Bank Independent 401K Profit Sharing Plan as a direct rollover. Such distribution or transfer shall be completed no later than one-hundred and eighty days after the close of the plan year.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The accompanying financial statements have been prepared using the accrual basis of accounting.

Investment Valuation and Income Recognition: The Plan's investments are reported at estimated fair value. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates. It is at least reasonably possible that a significant change may occur in the near term in the estimated fair value of the Plan's investment in employer securities.

Payment of Benefits: Benefits are recorded when paid.

Distributions Payable: At December 31, 2024 and 2023, there were no benefit payments that had been approved but not yet paid.

Risk and Uncertainties: The Plan's investments are held in BancIndependent, Incorporated common stock which is exposed to various risks such as interest rate, market, liquidity and credit risks. Due to the level of risk associated with the Plan's investment in BancIndependent, Incorporated common stock and the sensitivity of its fair value estimates to changes in valuation assumptions, it is at least reasonably possible that changes in the fair values of the Plan's investment in BancIndependent, Incorporated common stock will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 3 – RIGHTS UPON PLAN TERMINATION

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions and earnings thereon. No action had been taken by the Plan Sponsor as of the date of these financial statements to terminate the Plan.

NOTE 4 – FAIR VALUE MEASUREMENTS

Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs when measuring fair value. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (level 1 measurements) and gives the lowest priority to unobservable inputs (level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value includes inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following descriptions of the valuation methods and assumptions used by the Plan to estimate the fair values of investments apply to investments held directly by the Plan.

BanIndependent, Incorporated common stock: The fair value of BanIndependent, Incorporated's common stock is estimated annually, as of the financial statement date, based upon the results of an independent third party appraisal performed by a business appraiser selected by the Plan. The Plan Trustee engages the valuation specialist and receives the valuation report directly. The appraisals are performed using a combination of the income approach using the discounted cash flows method, the net asset value approach, and the market approach based upon valuation multiples of guideline public companies (Level 3 inputs). Under the discounted cash flows method, projections are based upon past performance as identified in audited and unaudited financial statements of BanIndependent, Incorporated and management's projections of BanIndependent, Incorporated's future performance. The resulting cash flow projections are discounted using a market related discount rate (which incorporates BanIndependent, Incorporated's estimated weighted average cost of capital). The net asset value approach uses the book value of the bank, assessing premiums or discounts to the balance sheet accounts based upon the current market value of the assets and liabilities. The guideline public companies method identifies pricing multiples of public companies deemed to be comparable to BanIndependent, Incorporated. Under all three approaches a discount for a lack of marketability is applied since BanIndependent, Incorporated's stock is not readily traded on an organized exchange.

Interest-bearing cash account: Fair values are estimated to approximate deposit account balances, payable on demand, as no discounts for credit quality or liquidity were determined to be applicable (level 2 inputs).

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Parties-in-interest are defined under Department of Labor's regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Company and certain others. The Plan holds 1,420 shares of BanIndependent, Incorporated common stock, and recognized dividend income of \$36,920 during 2024 from this related party investment. At December 31, 2024 and 2023, the Plan invested \$117,396 and \$106,725 respectively, in an interest-bearing cash account at Bank Independent. The Plan Sponsor acts as custodian of the Plan's investment assets. The Plan's payment of administrative fees to FuturePlan, as third party participant record-keeper for the Plan, qualifies as party-in-interest transactions. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid by the Company.

NOTE 6 - TAX STATUS

The Internal Revenue Service has determined and informed the Company by a letter dated December 16, 2013 that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code. Plan management also believes that the Plan is operating in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, Plan management believes that the Plan is designed and being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 7 – SUBSEQUENT EVENTS

Plan management has evaluated subsequent events for recognition and disclosure through October 14, 2025, which is the date the financial statements were available to be issued. No subsequent events requiring adjustment or disclosure were identified.

Opinion
