The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General** - The Plan is a defined contribution plan covering all full-time employees (other than those covered under a collective bargaining agreement) of the Company who have one year of service and are age twenty-one or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

**Contributions** - Each year, participants may defer up to 100% of their eligible compensation but are limited to the annual threshold set by the Internal Revenue Service (IRS). Participants who have attained age 50 before the end of the Plan year are also eligible to make catch-up contributions, subject to IRS limitations. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. Annually, the participating Sponsors may match a portion of employee contributions to the Plan on a discretionary basis. For the years ended December 31, 2024 and 2023, the employer match was 25% of the first 4% of compensation that a participant contributes to the Plan.

**Participant Accounts** - Each participant's account is credited with the participant's contribution and allocation of (a) the Company's contribution, (b) Plan earnings, and an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account. The Plan is a participant-directed Plan

**Vesting** - Participants are immediately vested in their voluntary contributions plus earnings thereon. Vesting in the Company's contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after six years of service.

**Payment of Benefits** - On termination of service due to death, disability or retirement, a participant whose balance is greater than \$1,000 may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or payment in the form of a joint or survivor annuity. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. If, however, such participant's account balance is less than \$1,000, the vested balance will automatically be distributed to the participant in a lump-sum. Benefits are recorded when paid. A financial hardship withdrawal provision is available, enabling a participant to withdraw an amount to cover an immediate and heavy financial need, in accordance with IRS regulations.

**Notes Receivable from Participants** -Participants may borrow from their fund accounts a minimum of \$500 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the balance in the participant's account and bear interest at a rate of 3.25% to 8.50%, which is commensurate with local prevailing rates as determined monthly by the Plan administrator. Principal and interest is paid ratably through payroll deductions.

NOTE 1 - DESCRIPTION OF PLAN (Continued)

**Forfeited Accounts** - At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$15,142 and \$4,217, respectively. These accounts will first be used to pay any administrative expenses. Any remaining amount will be used to reduce future employer matching contributions.

NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting** - The financial statements of the Plan are prepared using the accrual method of accounting.

**Estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

**Investment Valuation and Income Recognition** - The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 8 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants** - Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Unpaid participant loans are reclassified as distributions upon termination based on the terms of the Plan document.

**Excess Contributions Payable** - Amounts payable to participants for contributions in excess of amounts allowed by the Plan are recorded as a liability as of December 31, 2024 in the accompanying financial statements. The Plan will remit the year's excess contributions as of December 31, 2024, to the respective participants in 2025.

**Administrative Expenses** - Participant administration and record keeping fees are paid by the participants. The annual plan administration and compliance fee is paid by the participating Sponsors.

**Subsequent Events** - The Plan's trustees have evaluated events and transactions that occurred during the period from January 1, 2024 through October 6, 2025, which is the date the financial statements were available to be issued, for possible disclosure and recognition in the financial statements

**Risks and Uncertainties** - The Plan invests in various investment securities. These investment securities are exposed to various risks such as interest rate, market, and credit. Due to the level of risk associated with these investments, and the level of uncertainty related to the changes in the value of these investments, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

**NOTE 3 - TAX STATUS**

The Plan uses a prototype plan sponsored by Omega, Inc. The Internal Revenue Service approved the prototype plans under their prototype program. The Plan administrator believes the Plan is designed and operated in compliance with the applicable requirements of the Internal Revenue Code. The Plan is subject to routine audits by the Internal Revenue Service and the Department of Labor; however, there are currently no audits for any tax periods in progress.

**NOTE 4 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the participating Sponsors have the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**NOTE 5 - CONCENTRATION OF CREDIT RISK**

Investments which potentially subject the Plan to concentration of credit risk consist principally of mutual funds which are managed by the financial institution that is the custodian of the Plan assets at December 31, 2024 and 2023. The Plan has no formal policy regarding collateral to support the investments subject to credit risk.

Generally accepted accounting principles establish a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 unobservable inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. There were no Level 2 or Level 3 inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Mutual Funds** - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
