## INDEPENDENT AUDITOR'S REPORT

To the Board of Trustees of the

**NOTE 1. DESCRIPTION OF THE PLAN**

The following description of the Sunshine Ace Hardware, Inc. 401(k) Profit Sharing Plan and Trust (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions, which is on file in the offices of Sunshine Ace Hardware, Inc. (the Plan sponsor).

***General***

The Plan is a defined contribution 401(k) profit sharing retirement plan, covering all eligible employees of the Plan sponsor, Wynn Properties, Inc., Wynn Catering, Inc. (through December 29, 2022), Wynn's Healthy Oasis (through December 29, 2022), Wynn's at the Reef LLC, Wynn's Family Market, Inc. and Florida Handyman Services, LLC (collectively the "Company" or "Companies"). The Plan commenced on January 1, 2003 and was amended and restated as of January 1, 2008. It is subject to the provisions of the Internal Revenue Code and the Employee Retirement Income Security Act of 1974 (ERISA).

***Eligibility***

In order to be eligible to participate in the Plan, an employee must be 18 years of age and have been employed with the Company for 6 consecutive months. All employees hired on or before January 1, 2003 are automatically eligible to participate regardless of the age and service requirements.

***Contributions***

Participants may elect to contribute up to 95% of pretax annual compensation, as defined by the Plan. According to Internal Revenue Service IRS rules, the deferral may not exceed \$23,500 in 2024 and \$22,500 in 2023. Participants who have reached at least age 50 may contribute an additional catch-up yearly contribution of \$7,500 and \$7,500 during 2024 and 2023, respectively. Eligible participants may also contribute amounts representing distributions from other qualified benefit or contribution plans. The employer matching contribution equals 100% of the employees' contribution to a maximum of 5% of their annual compensation. All contributions are invested in a group annuity or mutual funds.

***Participant Accounts***

Each participant's account is credited with employee contributions, the employer's matching contribution, and a ratable portion of investment gain or losses, net of Plan expenses. Each participant's account is charged with any distributions made to that participant. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

***Investment Options***

Participants may direct contributions to be allocated among a selection of securities provided by the Plan (see Note 3).

***Vesting***

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the employer's matching and discretionary contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. Participants are 100% vested in the Plan if they were participants prior to January 1, 2003. The vesting schedule for participants hired subsequent to January 1, 2003 is stated as follows:

After 2 years	50%
After 3 years	75%
After 4 years	100%

***Payment of Benefits***

Participant contributions and the vested portion of the Plan sponsor's matching contributions are available for distribution upon attainment of retirement age, termination of employment, disability or death. If the participant's vested account balance was less than \$5,000 at the date of the distribution, then that balance shall be distributed in a single lump-sum payment. If the participant's vested account balance was more than \$5,000 at the date of the distribution, then the participant can elect to receive a lump sum or direct rollover or choose to defer receiving payment until age 70½.

Contributions are also available for distribution in the form of a hardship withdrawal. Hardship withdrawals may be made by participants to satisfy certain immediate and heavy financial needs that a participant may have, as outlined in the Plan agreement. The amount of the hardship withdrawal is limited to the balance of the participant's salary deferral and rollover from other plans.

In the event of death, 100% of the participant's vested account balance is payable to a participant's beneficiary or beneficiaries.

Participants become eligible to receive 100% of their entire account balance in the Plan if they become permanently disabled as defined by the Plan agreement.

***Forfeitures***

Forfeitures of the non-vested account balances of participants may be used to reduce employer contributions. As of December 31, 2024 and 2023, the balance of the forfeiture account was \$19,337, and \$9,042, respectively. During the year ended December 31, 2024, \$15,964 in forfeitures were used to reduce employer contributions.

***Termination of the Plan***

Although it has not expressed any intent to do so, the Plan sponsor has the right to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

***Basis of Accounting***

The accompanying financial statements have been prepared on the accrual basis of accounting. The preparation of financial statements in conformity with generally accepted accounting principles (GAAP) requires the Plan to make estimates and assumptions that affect the reported amounts of net assets available for benefits and disclosure of contingent net assets available for benefits at the date of the financial statements and the reported amounts of additions to and deductions from net assets available for benefits during the reporting period. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

Investments are reported at fair value (see Note 3). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants (see Note 5 for disclosure of fair value measurements).

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Concentration of Credit Risk***

Financial instruments which potentially expose the Plan to concentrations of credit risks, as defined by GAAP, consist primarily of investments and notes receivable. The Plan invests in marketable securities which, inherent in the fair market value determination, include the risk factor of credit worthiness for each individual debt security.

***Administrative Expenses***

Certain administrative and accounting functions are performed by the Plan sponsor's employees, who received no compensation from the Plan. Administrative expenses, such as professional fees, can be paid directly by the Plan's sponsor.

**NOTE 3. INFORMATION PREPARED AND CERTIFIED BY THE CUSTODIAN**

Reliance Trust Company, the custodian, held the Plan's investments as of December 31, 2024 and 2023. The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance Trust Company has certified to the completeness and accuracy of all investments reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, respectively, the related investment activity reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the information reflected on the schedule of Form 5500 - Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024.

Allocations among the underlying investments are participant directed. The accounts are credited with earnings on the underlying investments (principally mutual funds) and charged for Plan withdrawals and administrative expenses.

During the year ended December 31, 2024, the Plan's underlying investments (including gains and losses on investments bought and sold, as well as held during the year) appreciated in value by \$1,327,703. This was reported as net appreciation in fair value of investments in the statement of changes in net assets available for benefits.

**NOTE 4. NOTES RECEIVABLE FROM PARTICIPANTS**

Participants may borrow from their fund accounts up to \$50,000 or 50% of their vested account balance, whichever is less. Participant loans are only available for the purchase of a primary residence. The repayment period of the loan is commensurate with the repayment period permitted by a commercial lender, normally 10 years or less. The loans would be secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates provided by local lending institutions. As of December 31, 2024 and 2023, the interest on the notes receivable from participants ranged between 4.25% and 9.50% with maturities through 2034. Principal and interest would be repaid ratably through bi-weekly payroll deductions. For the Plan years ended December 31, 2024 and 2023, participant loans were \$230,587 and \$208,065, respectively.

**NOTE 5. FAIR VALUE MEASUREMENTS**

GAAP provides a framework for measuring fair value, expands disclosures about fair value measurements, and establishes a fair value hierarchy which prioritizes the inputs used in measuring fair value summarized as follows:

Level 1: Inputs using the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of the unobservable inputs.

The following is a description of the valuation methods used for assets measured at fair value. There have been no changes in methodologies used as of December 31, 2024 and 2023:

- Mutual funds: Valued at the daily closing price as reported by the Plan. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
- Land trust: Valued at appraisal value. The appraiser used a sales-comparison approach comparing to existing properties of the same or similar utility (including location, size and use).

**NOTE 6. FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT**

As of December 31, 2024, the Plan has a group annuity contract with Mass Mutual Life Insurance Company managed by Great West Investments that invests contributions in the Mass Mutual Separate Account Guaranteed Interest Contract (the SAGIC). The SAGIC is a general account product.

Contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the group annuity contract since the contract was determined to be fully benefit-responsive. The contract is included in the financial statements at fair value which approximates contract value. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses.

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The fair values of the investment contract as of December 31, 2024 and 2023 were \$3,992,487 and \$4,668,509, respectively. The crediting interest is based on a formula agreed upon with the issuer.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (a) amendments to the Plan document (including complete or partial Plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Plan sponsor or other Plan sponsor events that cause a significant withdrawal from the Plan or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable to occur.

The group annuity contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date. Average yields for the Plan were as follows:

**NOTE 7. PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments may include shares of investments managed by Empower, the Plan's custodian, or its affiliates and, therefore, these transactions qualify as a party-in-interest transaction; however, they are exempt from the prohibited transactions rules under ERISA. Fees paid by the Plan to Empower for contract recordkeeping services for the year ended December 31, 2024 were approximately \$59,339.

The Plan's sponsor and participating employers absorb virtually all the Plan's administrative expenses.

**NOTE 8. NOTES PAYABLE TO SPONSOR AND PARTICIPATING EMPLOYERS**

To alleviate liquidity issues arising from the need to make distributions to participants and pay for expenses associated with the Land Trust investment, the Plan sponsor and participating employers make interest free loans to the Plan. These transactions are excluded from the prohibited transactions rules by Prohibited Exemption 80-26. The note payable balance was \$314,425 and \$201,980 as of December 31, 2024 and 2023, respectively.

Repayment of the loan will be made within an administratively practical time after receipt of demand for payment from the sponsor, or upon sale of the Land Trust investment. At that time, all participant account balances will be allocated a proportionate share of the total amount repaid based upon each respective account balance at the time the original loan was made by the Plan sponsor.

**NOTE 9. TAX STATUS**

The Plan was designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Internal Revenue Service has determined that the prototype which this Plan has been based on has been designed in accordance with applicable sections of the IRC.

Plan management is required to evaluate uncertain tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more likely than not to be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken by the Plan. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The administrator believes it is no longer subject to income tax examination for years prior to December 31, 2021.

**NOTE 10. PROHIBITED TRANSACTIONS**

During 2023, participant deferrals for two payroll periods totaling approximately \$30,866 had not been remitted timely to the Plan. Subsequent to the due dates, the Plan sponsor remitted these participant contributions to the Plan within the 2023 Plan year excluding interests, which were remitted during the 2024 Plan year. These are shown as fully corrected in the Schedule of Delinquent Participant Contributions.

There were no such late remittances during 2024.

**NOTE 11. SUBSEQUENT EVENTS**

Management has evaluated subsequent events through October 8, 2025, the date the financial statements were available to be issued.
