Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Edaptive Computing Inc. Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) audit. NOTE 1 - DESCRIPTION OF THE PLAN

The following brief description of Edaptive Computing, Inc. Savings Plan (the "Plan") is provided for general information. Participants should refer to the Plan document for more complete information.

A. General

Effective January 1, 2016, the board of trustees of Edaptive Computing, Inc. (the Company) adopted the Edaptive Computing Savings Plan, a defined-contribution 401(k) deferred and safe harbor plan. Employees are eligible for participation in the Plan upon attaining 21 years of age and completion of 1,000 hours of service during an eligibility computation period. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan's Trustee oversees governance of the Plan, determine the appropriateness of the Plan's investment options and monitors investment performance.

B. Contributions

Participants may contribute up to \$23,000 and additional catch-up for age 50 or older of \$7,500 of pretax annual compensation for 2024 as defined by the Internal Revenue Service. A participant may designate savings as before-tax savings, Roth IRA deferral, or any combination of the two. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans and make catch-up contributions. Participants direct the investment of their contributions and corporate contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds as investment options for participants. Under this safe harbor 401(k) plan, the Company's contribution is 3% of plan compensation.

Contributions are subject to certain limitations. The limits include:

C. Participant Accounts

Each participant's account is credited with the participant's respective deferral, the Company's safe harbor contribution and plan earnings (losses). Participant accounts are charged with an allocation of certain administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled, is the benefit that can be provided from the participant's vested account.

D. Vesting

Participants are immediately 100% vested in amounts attributable to their contributions and the Company's contributions plus actual earnings thereon.

E. Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear a rate of interest of the prime interest rate plus 1%, which is commensurate with local prevailing rates as determined by the plan administrator. Principal and interest are repaid ratably through bi-weekly payroll deductions.

NOTE 1 - DESCRIPTION OF PLAN - CONT'D

F. Payment of Benefits

Upon termination of services due to death, disability, or retirement, the vested interest in the participant's accounts shall be paid in the form of a single lump-sum or in periodic installment payments in accordance with the Plan document. Participants with an account balance of less than \$5,000 at termination of service, are required to take a lump-sum distribution, or roll the balance of the account to an IRA.

G. Forfeitures

The non-vested portion of a terminated participant's account balance remains in the Plan and is called a forfeiture. Forfeitures may be used by the Plan at the discretion of the Plan administrator to pay administrative expenses, reduce employer contributions, or allocate to participant accounts on a pro-rata basis. During the year ended December 31, 2024, no forfeitures were used to pay administrative expenses or used to reduce employer contributions. No forfeited non-vested accounts were allocated to participant's accounts during the year ended December 31, 2024.

H. Investment Options

The participants are permitted to direct the allocation of their individual account balance within the investment options of the Plan.

I. In-Service Distributions

Hardship withdrawals are available to Plan participants for the various reasons as described in the Plan documents. Hardship withdrawals are limited to the pre-tax deferral portion of the participants account balance. Rollover contribution accounts are available for in-service distribution without restriction, and a participant may request distribution from these accounts at any time.

Employees who have reached the age of 59 ½ years old may withdraw all or a portion of their vested contributions.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

The accompanying financial statements have been prepared under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investment contracts held by a defined contribution plan are required to be reported at the fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan does not currently have any fully benefit-responsive investment contracts.

B. Accounting Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

C. Investment Valuation and Income Recognition

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator (Administrator,) in conjunction with the third-party service provider to the Plan (Trustee) for the Administrator, determine the Plan's valuation policies. See Note 6 for description of fair value measurements.

Purchase and sales transactions are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

D. Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged to and paid by the Company. As of December 31, 2024, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

E. Risk and Uncertainties

The Plan utilizes various investment instruments. Investment securities, in general are exposed to various risks, such as interest rate, market credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

F. Contributions

Participant contributions and employer safe harbor contributions, are recognized when the participant contributions are withheld from participant's earnings.

G. Rollover

Participants may elect to rollover amounts from other qualified plans or individual retirement accounts into the Plan, provided that certain conditions are met. As of December 31, 2024, and 2023, the Plan has participant's rollovers amounting to \$41,327 and \$0 respectively.

H. Benefits and Withdrawals Paid to Participants

Benefit payments and withdrawals to participants are recorded upon distribution.

I. Expenses

Operating expenses and administrative of maintaining the Plan are paid by the Company and are therefore excluded from these financial statements. Recordkeeping expenses are paid by the Plan. Investment-related expenses are included in net appreciation in fair value of investments.

J. Allowance for Credit Losses - Notes Receivable from Participants

The allowance for credit losses is a valuation account that is deducted from, or added to, the note receivables amortized cost basis to present the net amount expected to be collected on the loan. Loans are charged off against the allowance when management believes the collectability of a loan balance is confirmed.

Management estimates the allowance balance using relevant available information, from internal and external sources, relating to past events, current conditions, and reasonable and supportable forecasts. Historical credit loss experience provides the basis for the estimation of expected credit losses. Adjustments to historical loss information are made for changes in environmental conditions, such as changes in unemployment rates, collateral values, or other relevant factors. Management has determined there is no requirement to provide an allowance for credit loss because the loans are secured by the balance in the participant's account.

K. Allowance for Credit Losses - Investments

Management assesses the financial condition and near-term prospects of the issuer, industry and/or geographic conditions, credit ratings as well as other indicators at the individual security level. Impairments below cost in the estimated fair value of individual securities when there is an intent to sell or for which it is more likely than not the Plan will not be required to sell before the impairment is recovered, are realized in other income in the statements of changes in net assets available for benefits. When there is not an intent to sell or it is more likely than not the Plan will not be required to sell the security before the impairment is recovered, management assesses whether the decline in fair value has resulted from credit losses or other factors. If the present value of discounted cash flows expected to be collected is less than the amortized cost basis, a credit loss exists and an allowance for securities credit losses is recorded. Such losses are limited to the amount that amortized cost exceeds fair value, even if the amount of the credit loss is greater. Any future changes in the allowance for credit losses is recorded as provision for (reversal of) credit losses. Losses attributable to other factors are charged to net appreciation (depreciation) in fair value of investments. Mutual Funds are carried in the financial statements at fair value and Common/Collective Trust funds are measured at net asset value, and both realized and unrealized gains and losses are included in net increase(decrease) in net assets.

NOTE 3 - PLAN TERMINATION

Although the Company has not expressed any intention to do so, it has the right under the Plan to terminate the Plan, subject to the provisions set forth in ERISA. In the event the Plan terminates, the net assets of the Plan will be allocated as prescribed by ERISA and the Plan document.

NOTE 4 - TAX STATUS

The Department of the Treasury, Internal Revenue Service (IRS) has determined and informed the Newport Group Inc. by a letter dated June 30, 2020 that the Non-Standardized Pre-Approved Profit Sharing/Money Purchase/CODA, plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has been amended, since receiving the determination letter. However, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

The Plan operates under a Participating Employer Adoption Agreement in connection with a Non-Standardized Pre-Approved Profit Sharing/Money Purchase/CODA plan and custodial documents sponsored by Ascensus. This prototype plan document has been filed with the appropriate agency. The Plan has not obtained or requested a determination letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax-exempt as of the financial statement date. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator has analyzed the tax position taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

NOTE 5 - EXEMPT PARTY-IN-INTEREST TRANSACTIONS

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employee association, or relatives of such persons.

The plan directly paid \$25,379 to Ascensus, Inc. for recordkeeping services. Certain administrative functions are performed by the officers and employees of the Company (who may also be participants in the Plan) at no cost to the Plan. These transactions are not deemed prohibited party-in-interest transactions because they are covered by the statutory or administrative exceptions from the Internal Revenue Code and ERISA's rules on prohibited transactions.

NOTE 6 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no significant changes in the methodologies used during the year ended December 31, 2024, and 2023:

For certain defined contribution Interest Account most participant transactions are executed using contract value without adjustment. Therefore, for these types of Interest Accounts, the contract value is a good proxy for fair value and is the value that will be used as fair value. The Plan has no liabilities measured at fair value. For assets classified within Level 3 of the fair value hierarchy, the process used to develop the reported fair value is described below.

Mutual Funds: The value of a mutual fund is the sum of the market value of the underlying investments as determined by quoted market prices, less operating expenses accrued but not deducted, if any.

Securities without quoted market prices: If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections and cash flows. Such securities are classified in Level 2 of the valuation hierarchy.

NOTE 8 - FORFEITED ACCOUNTS

As of December 31, 2024 and 2023 there were no forfeited non-vested accounts.

NOTE 9 - BENEFITS ALLOCATED TO WITHDRAWN PARTICIPANTS

As of December 31, 2024 and 2023, there were no amounts due to participants who have withdrawn from the Plan and requested benefit payment prior to year-end.

NOTE 10 - SUBSEQUENT EVENTS

NOTE 11 - SECURE 2.0

In December 2022, the Consolidated Appropriations Act of 2023 was signed into law, which includes the package of retirement provisions referred to as "SECURE 2.0". These provisions continued the measures and reforms that began with the 2019 SECURE Act, focusing on getting more participants into the retirement system and finding ways for them to accumulate more assets. These changes have various effective dates starting in 2023 and forward. Since the provisions include both required and optional elements, the Plan administrator will determine the optional provisions to elect.
