Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Kings Tire Service, Inc. 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024 stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Note 1 – Plan Description

The following description of the Kings Tire Service, Inc. 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all eligible employees of Kings Tire Service, Inc. (the “Company”), the employer of a controlled group made up of Kings Retread, Inc. and Sam King, Inc. The Plan was established to provide retirement benefits to eligible employees of the Company in conformity with the minimum standards of eligibility, vesting, and funding required by the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

All employees, as defined, are eligible to participate in the Plan. There are no age or service requirements for either the salary deferral portion of the Plan or the employer’s safe harbor contributions. To be eligible to receive an allocation for the discretionary employer profit-sharing contribution, the participant must complete 1,000 hours of service and be employed the last day of the Plan year.

Contributions

Each year participants may contribute pre-tax a percentage of their compensation not to exceed the dollar amount limit set by law. Under the ADP and ACP test safe harbor provisions, the Plan provides for employer contributions of 100% of the first 4% of base compensation for each payroll period. This safe harbor contribution is fully vested and is referred to as an enhanced matching contribution. The Plan also provides for an additional employer contribution on a discretionary basis out of its current or accumulated net profit as determined by appropriate action of the Company to the extent the contribution does not exceed the participant’s maximum permissible amount. The Company made no additional discretionary contributions during 2024 and 2023. Participants direct the investment of their contributions into various investment options offered by the Plan. Participants may contribute amounts representing distributions from other qualified defined benefit or contribution plans.

Participant Accounts

Each participant’s account is credited with the participant’s contribution, the Company’s contribution, and an allocation of Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their contributions and Company safe harbor matching contributions plus earnings thereon. In regards to any discretionary profit-sharing contributions made by the Company, a participant who has completed six years of service or who attains age 65 while employed by the Company shall have a non-forfeitable right to

the entire balance in his/her account. Upon termination of employment, a participant shall have a vested interest in his/her accrued benefit based on the table below. The benefit will be payable at normal retirement date.

Payment of Benefits

Upon attainment of normal retirement age of 65 or termination of employment, a participant, or in the case of death, the participant's beneficiary, will receive the vested portion of the amount credited to the participant's account. The participant receives payment in a lump sum. Withdrawals prior to attaining age 65 were not permitted except in the event of retirement, disability, or as a hardship distribution. Effective December 15, 2023, the Plan was amended to permit in service distributions for active employees who have attained age 59½. Upon proof, to the satisfaction of the Plan Administrator, of an immediate and heavy financial need, pre-tax elective deferrals may be withdrawn for a hardship purpose. Certain income tax penalties may apply to withdrawals or distributions prior to age 59½.

Forfeited Accounts

Participants are immediately vested in their voluntary contributions and in the Company's safe harbor contributions. Forfeitures from terminated participants' non-vested accounts attributable to employer discretionary contributions are used to reduce administrative expenses and future employer contributions. There were no forfeitures available for this purpose at December 31, 2024 and 2023.

Administration

The Company administers the Plan through an agreement with Siegel Actuarial Consulting, Inc. Capital Group Companies, Inc. is the Plan's Custodian and American Funds Institutional Group is utilized as the Plan's investment platform.

Administrative Costs

Certain administrative expenses are paid by the Plan and remaining expenses are paid by the Company and are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments. Expenses for audit services to the Plan are not reflected in the accompanying financial statements as they are paid by the Company.

Note 2 – Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset, or paid to transfer a liability, in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Benefit Payments

Benefits are recorded when paid.

Subsequent Events

Subsequent events have been evaluated through October 13, 2025, which is the date the financial statements were available to be issued.

Note 3 – Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with those of other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of observable inputs other than quoted prices for identical assets; and Level 3 inputs consist of unobservable inputs and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are used only when Level 1 or Level 2 inputs are not available.

Level 1 Fair Value Measurements

The fair values of mutual funds are based on the quoted net asset value (“NAV”) provided by the administrator of the fund. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, divided by the number of units outstanding. The NAV is a quoted price in an active market and classified within Level 1 of the valuation hierarchy.

Note 5 – Tax Status

The Plan has adopted a non-standardized, pre-approved plan sponsored by Siegel Actuarial Consulting, Inc. and has not requested a determination letter but rather relied upon the Internal Revenue Service opinion letter dated June 30, 2020, stating the non-standardized, pre-approved plan and related trust are designed in accordance with applicable sections of the *Internal Revenue Code (IRC)*.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

Note 6 – Related Party and Parties-in-Interest Transactions

Certain employees of the Plan Sponsor perform administrative duties and provide bookkeeping services to the Plan without additional compensation from the Plan. The Company absorbs other significant costs of the Plan.

Certain Plan investments are units of mutual funds managed by Retirement Plan Services Division of the Capital Group Companies, Inc., the Custodian, and Siegel Actuarial Consulting, Inc. is contracted as the Plan’s third-party administrator as defined by the Plan. These transactions qualify as party-in-interest transactions.

Note 7 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 8 – Delinquent Participant Contributions

Employee contributions to the Plan are required to be remitted as soon as administratively feasible. While the Company remitted all employee contributions to the Plan for the year ended December 31, 2024, contributions of \$35,754 were not remitted within the required time period for the Plan years 2015 to 2023.
