NOTE A – DESCRIPTION OF THE PLAN:

As a controlled group, Energy Process Technologies, Inc., Heater Specialists, LLC And Mohawk Field Services, Inc. (hereafter also referred to as “the Companies”) sponsor the Energy Process Technologies, Inc. Savings Plan (hereafter also referred to as “the Plan”) for the benefit of its employees. The following description of the Plan provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution, 401(k) plan, covering employees of the Companies who have completed at least ninety (90) days of service, as defined in the Plan document. Days of service need not be contiguous, but there can be no more than a one-year break in service. Plan entrance is available on a quarterly basis. The Plan is intended to satisfy all of the requirements for a qualified retirement plan under the appropriate provisions of the Internal Revenue Code (“IRC”) and similar state tax laws. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Board of Trustees is responsible for oversight of the Plan, determining the appropriateness of the Plan’s investment offerings and for monitoring investment performance.

Contributions

Participants may contribute a percentage of compensation, up to the current pre-tax 401(k) contribution limits or after-tax Roth 401(k) contribution limits permissible under the IRC, as defined in the Plan document. Participants who have attained age fifty (50) before the end of the Plan year are eligible to make “catch-up” contributions. Participants may also contribute amounts representing distributions or rollovers from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and an insurance contract as investment options for participants. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with an initial default deferral rate set at 3% of eligible compensation. Contributions are automatically invested in a designated fund until changed by the participant. All participant contributions are invested according to the allocations as determined by each individual Plan participant. Participants are allowed to stop their elective deferrals to the Plan and may change their elective deferral amounts on a semi-monthly basis.

The Companies match all participant contributions up to a percentage of each participant’s compensation. The Companies’ matching contribution is invested according to each participant’s determined allocations. The Companies’ matching percentage is 100% of each participant’s payroll period compensation up to 3% and 50% for payroll period compensation over 3%, but not more than 4%, as defined in the Plan document.

The Plan document allows for annual discretionary employer profit-sharing contributions. Each eligible participant who is actively employed on the last day of the Plan year is allocated a proportionate share of such contributions, based upon gross compensation of each participant during this period of participation for the year. The Plan did not make any profit-sharing contributions for the year ended December 31, 2024.

Participant Accounts

Each participant’s account is credited with the participant’s contributions, the Companies’ matching contributions and allocations of Plan earnings including gains and/or losses on investments. Participant accounts are charged individually for participant requested services. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account balance.

NOTE A – DESCRIPTION OF THE PLAN – (Continued):

Payment of Benefits

On termination of service due to death, disability, hardship or retirement, a participant may elect to receive a lump-sum distribution equal to the vested balance of his or her account, under the terms of the Plan document. For termination of service due to other reasons, a participant may receive the value of their account balance as a lump-sum distribution. In-service distributions are not allowed except as required. For participants who have reached age seventy-three (73), required minimum distribution amounts as required by the Internal Revenue Service must be met.

Vesting

Participants are immediately 100% vested in their own contributions plus or minus any earnings or losses thereon. Vesting of employer matching contributions is based upon years of service according to the following schedule:

<u>Years of Service</u>	<u>Vesting Percentage</u>
Less than one	0%
One, but less than two	50%
Two or more	100%

Participants automatically become 100% vested upon (a) normal retirement age, i.e. attainment of age 65, (b) disability, (c) death or (d) a partial termination of the Plan. Participants who terminate for any other reason are entitled to the vested portion of their accounts.

Notes Receivable from Participants

Participants may borrow from their Plan accounts a minimum of \$1,000 up to a maximum of \$50,000, not to exceed 50% of their account balance. Participants may not have more than two loans outstanding at any time. Notes receivable are secured by the balance in the participant's account, evidenced by a promissory note. Notes receivable accrue interest at a reasonable rate that is determined by the Plan administrator. Interest rates are set at prime, plus 2%. The interest rate for new notes receivable was set at 10.5%. Older, pre-existing notes receivable have an interest rate of 5.25% to 10.5%. Repayment terms for notes receivable are five years or less. Principal and interest are paid ratably through payroll deductions. Upon termination of employment, outstanding note balances are treated as distributions and are subject to applicable federal and state income taxes, and penalties.

Hardship Withdrawals

The Plan allows hardship and disaster relief withdrawals subject to account balance limits and applicable laws.

Forfeitures

On December 31, 2024 and 2023, forfeited non-vested accounts totaled \$12,926 and \$10,826, respectively. Forfeitures of employer matching contributions resulting from participants withdrawing prior to becoming fully vested are allocated to offset employer matching and profit-sharing contributions. Five consecutive one-year breaks in service must occur before the forfeitures are available for use. Forfeitures of \$6,593 were allocated to employer matching deposits and to pay Plan administrative expenses during the year ended December 31, 2024.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

Basis of Accounting

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from the estimates that were used.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for fully benefit responsive investment contracts (See Notes C and D). Fair value is the price that would be received in the sale of an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Board of Trustees determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians of the Plan. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Payment of Benefits

Benefits are recorded when paid. On December 31, 2024, there were no employees who had terminated employment with the Company who had requested distributions from the Plan that had not yet been received.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements (See Note F). Fees related to the administration of notes receivable from participants and participant distributions are charged directly to the participant's account and are included in administrative expenses.

Date of Management's Review and Subsequent Events

Management of the Plan has evaluated subsequent events through October 13, 2025, the date that the financial statements were available for issuance, noting certain events that required recognition or disclosure in the accompanying financial statements and footnotes.

NOTE C – CERTIFIED INVESTMENTS:

On December 31, 2024, the Plan's investments were held by the insurance company, Empower Annuity Insurance Company of America. The Plan investments that are included in the accompanying financial statements are based on information certified by the insurance company as complete and accurate in accordance with Section 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974.

During the year ended December 31, 2024, the Plan's investments (including gains and losses on investments bought and sold, as well as held during the year) appreciated in value by \$185,196.

NOTE D – FAIR VALUE MEASUREMENTS:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (“Level 1”) and the lowest priority to unobservable inputs (“Level 3”). The three levels of the fair value hierarchy under The Financial Accounting Standards Board’s (“FASB”) Accounting Standards Codification (“ASC”) 820 are described as follows:

Level 1

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

The Plan held investments determined to be “Level 1” investments as of December 31, 2024 and 2023.

Level 2

Inputs to the valuation methodology include quoted market prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the assets or liability and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified contractual term, the Level 2 input must be observable for substantially the full term of the asset or liability.

The Plan did not hold any “Level 2” investment as of December 31, 2024 and 2023.

Level 3

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The Plan did not hold any “Level 3” investments as of December 31, 2024 and 2023.

Explanation of the Fair Value Hierarchy

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used on December 31, 2024 and 2023.

Fair Value Measurements

Registered investment companies are valued at the net asset value (“NAV”) of units held by the Plan at year end. The NAV is determined by dividing the net assets at fair value of the fund by the number of units outstanding on the day of valuation, the value of the underlying investments held by the fund less its liabilities, and then divided by the number of shares outstanding. The NAV is quoted in an active market.

NOTE E – GUARANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY:

The Plan has a traditional fully benefit-responsive group annuity contract with Massachusetts Mutual Life Insurance Company (“Mass Mutual”). Mass Mutual maintains the contributions in a general account. The account is credited with earnings on the underlying investments and is charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract meets the criteria to be considered fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statement of net assets available for benefits at contract value. Contract value as reported to the Plan by Mass Mutual, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer but may not be less than 1%. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the Plan’s ability to transact at contract value with Mass Mutual. Such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan’s prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other events that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (1) an uncured breach of the Plan’s investment guidelines, (2) a material amendment to the contract without the issuer’s consent, (3) a violation of a material obligation under the contract, or (4) a material misrepresentation. The Plan administrator does not believe that any events that would limit the Plan’s ability to transact at contract value with the Plan participants or the issuer is probable.

The guaranteed investment contract does not permit the custodian to terminate the document prior to the scheduled maturity.

Average yield based on actual earnings and credit to participants was 3%.

NOTE F – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS:

Plan investments are held in custody by Empower Annuity Life Insurance Company of America, the insurance company of the Plan. Certain Plan investments are managed by Empower Retirement, LLC (“Empower”). Empower the recordkeeper for the Plan and, therefore these transactions qualify as party-in-interest transactions.

Empower provides certain administrative services to the Plan pursuant to the Plan Services Agreement (“PSA”) between the Company and Empower. Empower receives revenue from mutual fund service providers and a group annuity with Empower Annuity Life Insurance Company of America for services Empower provides to the funds and annuity contract. This revenue is used to offset certain amounts owed to Empower for its administrative services of the Plan.

Fees paid by the Plan to Empower for investment management and contract administration services amounted to \$23,468 for the year ended December 31, 2024. All party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE G – EMPLOYER ABSORBED COSTS:

The Company pays certain administrative expenses of the Plan, such as professional fees. During the year ended December 31, 2024, the Company paid administrative expenses of the Plan in the amount of \$21,840 for audit fees.

NOTE H – PLAN TERMINATION:

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

NOTE I – TAX STATUS:

The Plan was formed August 1, 1990, using a “Volume Submitter” plan that has been pre-approved for use by the IRS. Although the Plan’s “Volume Submitter” plan document has been amended since receiving the determination letter, the Plan administrator and the Plan’s tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that “more likely than not” would not be sustained upon examination by the IRS. Management of the Plan does not believe they had any uncertain tax positions as of December 31, 2024.

NOTE J – RECONCILIATION OF FINANCIAL STATEMENTS TO SCHEDULE H OF FORM 5500:
