## Independent Auditors' Report

To the Participants and Trustees of  
The DISTek Integration Inc 401(k) Profit Sharing Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of DISTek Integration Inc 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of DISTek Integration Inc 401(k) Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

## DISTek Integration, Inc. 401(k) Profit Sharing Plan

### Notes to Financial Statements

#### 1. Description of Plan

The following description of the DISTek Integration, Inc. (Company) 401(k) Profit Sharing Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

##### General

The Plan is a defined contribution plan covering eligible employees of DISTek Integration, Inc. Employees are eligible to participate in the salary reduction arrangement, matching contributions, and profit sharing contributions as of the employment commencement date when they are hired on a permanent and full-time basis. All other employees are eligible to participate on the date the employee attains age 21 and has completed one year of service in which the employee had 1,000 hours of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

##### Employer Contributions

The Company may elect to contribute a discretionary match to all eligible participants. The discretionary match for plan year 2024 and 2023 was 3%. The amount of the employer matching contributions equaled \$426,332 and \$398,089 for the years ended December 31, 2024 and 2023, respectively.

The Company may also elect to contribute additional profit sharing amounts to eligible participants at the option of the Company. There were no additional profit sharing contributions made during 2024 and 2023.

##### Employee Contributions

Participants may contribute up to 100% of pretax annual compensation, not to exceed \$23,000 and \$22,500 in 2024 and 2023, respectively. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The maximum catch-up contribution is \$7,500 and \$7,500 in 2024 and 2023, respectively. Participants may also contribute amounts representing distributions from other eligible retirement plans. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation. The Plan also includes an automatic escalation feature whereby eligible participants will have their default 3% deferral of base pay increase 1% each year until the participant is contributing 10%, unless the participant elects otherwise.

##### Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's match and profit sharing contributions, and (b) Plan earnings less expenses. Allocations are based on participant compensation paid during the Plan year for the company's discretionary match contribution and account balances for Plan earnings. The benefit to which the participant is entitled is the benefit that can be provided from the participant's vested account.

##### Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's discretionary match and profit sharing contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after six years of credited service.

##### Payment of Benefits

On termination of service due to death, disability, or retirement, a participant will receive a lump-sum distribution, substantially equal installments, or partial withdrawals equal to the value of the participant's vested interest in his or her account.

## 1. **Description of Plan** (continued)

### Forfeitures

Forfeitures are used first to pay Plan expenses and second to reduce any future matching contributions. For the years ended December 31, 2024 and 2023, the Company used \$60,436 and \$35,976, respectively, of forfeitures to pay Plan expenses. For the years ended December 31, 2024 and 2023, the Company used \$-0- and \$-0-, respectively, of forfeitures to reduce the employer match. At December 31, 2024 and 2023, there were forfeited balances totaling \$57,765 and \$3,348, respectively.

### Notes Receivable from Participants

Participants may borrow from their fund accounts a maximum equal to the lesser of \$50,000 or 50% of the participant's vested account balance. Loans are secured by the participant's vested interest in his account, not to exceed 50%. Loans outstanding bear interest at 1% above the prime interest rate. Principal and interest is paid ratably through payroll deductions. Participants may only have one loan outstanding at any time.

### Plan Administration

The Plan is governed by the Trustees, which is comprised of members of the Company's management. T. Rowe Price Retirement Plan Services, Inc. served as the asset custodian and recordkeeper for the years ended December 31, 2024 and 2023.

## 2. **Summary of Significant Accounting Policies**

### Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

### Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note (4) for discussion of fair value measurements. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis.

### Payment of Benefits

Benefits are recorded when paid.

### Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

### Subsequent Events

The Plan has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued. See Note 10 for information on subsequent events.

### 3. Certified Investments

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company (the custodian of the Plan). This information has not been audited by the Plan's independent auditors. The certified information at December 31, 2024 and 2023 and for the years then ended includes:

### 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices in active markets for identical assets or liabilities the Plan can access at the measurement date.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs that are unobservable inputs for the asset or liability.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

#### Mutual Funds

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

#### Stable Value Collective Trust Fund

A stable value fund that is composed primarily of fully benefit-responsive investment contracts that is valued at the net asset value of units of the bank collective trust. The net asset value is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported net asset value. Participant transactions (purchased and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

## 6. Related-Party Transactions and Party in Interest Transactions

Certain Plan investments are shares of mutual funds managed by T. Rowe Price Retirement Plan Services, Inc. T. Rowe Price Retirement Plan Services, Inc. is the custodian as defined by the Plan and, therefore, these transactions qualify as party in interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment, rather than a direct payment.

## 7. Plan Termination

Although it has not expressed the intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their account.

## 8. Tax Status

The IRS has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC.

## 9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

## 10. Subsequent Events

The Plan adopted an amended and restated plan agreement effective January 1, 2025. On November 19, 2024, a newly formed holding company, Carthage Holdings, Inc., exchanged with DISTek Integration, Inc. Employee Stock Ownership Trust all of the issued and outstanding stock of DISTek Integration, Inc. for all of the issued and outstanding stock of Carthage Holdings, Inc. Around the same time, Carthage Holdings, Inc., acquired substantially all of the assets of Red Foundry, LLC. This new plan agreement was used to document these transactions, change the Plan Sponsor from DISTek Integration, Inc. to Carthage Holdings, Inc., and name DISTek Integration, Inc. and Red Foundry, LLC as participating employers.
