1. Plan Description

The following description of the Havco Wood Products LLC 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the summary plan description for a more complete description of the Plan's provisions.

General:

The Plan is a defined contribution plan sponsored by Havco Wood Products LLC (the "Company") for the benefit of all employees, as defined by the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). Reliance Trust Company is the trustee and a custodian of the Plan. MassMutual Retirement Services ("MassMutual") was the third-party administrator of the Plan and custodian of the guaranteed interest account. On December 31, 2020, Empower Retirement LLC ("Empower") acquired MassMutual and became the third-party administrator of the Plan. Great-West Life & Annuity Insurance Company, an affiliate of Empower, became the custodian of the guaranteed interest account.

Contributions:

The Plan permits eligible employees through a salary deferral election to make annual contributions of up to 50 percent of eligible compensation. Employee rollover contributions are also permitted. The Company makes matching contributions of employee salary deferral amounts of 100 percent of the first 3 percent of employee salary deferrals and 50 percent of the following 2 percent that is deferred for a total match of up to 4 percent.

The Plan also permits Company profit-sharing contributions, which are discretionary, as determined by the Company's Board of Members. No discretionary contributions were made for the years ended December 31, 2024 and 2023. Contributions are subject to certain limitations

Eligible Participants:

Employees are eligible to participate in the Plan after they complete 90 days of service with the Company.

Participant Investment Account Options:

Investment account options available include various mutual funds and a guaranteed interest account. Each participant has the option of directing their contributions into any of the separate investment accounts and may change their allocation daily.

Participant Accounts:

Each participant's account is credited with the participant's contribution, the Company's contribution, earnings and forfeitures of terminated participants' nonvested accounts, and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

1. Plan Description (continued)

Vesting:

Participants are immediately vested in their voluntary deferral contributions and the Company matching contributions, plus earnings thereon. Vesting in the Company's profit-sharing contributions plus earnings thereon is based on years of continuous service. A participant is fully vested after three years of continuous service, with no amounts vesting prior to that period. The nonvested balance is forfeited upon termination of service. Forfeitures are allocated among active participants based upon a predetermined formula as documented in the Plan Document.

Payment of Benefits:

Upon termination of service, retirement, death or disability, an employee may receive a lump-sum amount equal to the value of their vested account.

Forfeited Plan Assets:

Forfeitures are allocated among active participants based upon a predetermined formula as documented in the Plan Document. For the years ended December 31, 2024 and 2023, forfeited nonvested accounts totaled \$0 and \$9,429, respectively. The Plan also maintains an unallocated account of excess matching contributions which are used to pay administrative expenses of the Plan or offset future Company matching contributions. The balance of unallocated excess matching contributions and forfeited nonvested accounts totaled \$125,650 and \$77,215, respectively, at December 31, 2024 and 2023.

Notes Receivable from Participants:

The Plan Document includes provisions authorizing loans from the Plan to active eligible participants. The minimum amount of a loan shall be \$500. The maximum amount of a participant's loan is restricted to the lesser of \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the balance in the participant's account. Interest on the loans is based on the published prime rate at the time of loan inception, plus 1%.

Plan Termination:

Although it has not expressed an intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

2. Summary of Significant Accounting Policies

Basis of Accounting:

The financial statements of the Plan are prepared on the accrual method of accounting.

Use of Estimates:

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amount of increases and decreases in net assets during the reporting period. Actual results could differ from those estimates.

2. Summary of Significant Accounting Policies (continued)

Investment Valuation:

Investment contracts held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Investment Risk:

The Plan invests in investment securities that are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes could materially affect the participants' account balances and the amounts reported in the statement of net assets available for benefits.

Notes Receivable from Participants:

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest is recorded on the accrual basis. Delinquent participant notes are reclassified as distributions based on the terms of the Plan document.

Benefits Distributed to Participants:

Benefits are recorded upon distribution.

Administrative Expenses:

Plan expenses may be paid by the Plan unless the Plan Sponsor, in its sole discretion, elects at any time to pay part or all of such expenses.

Subsequent Events:

The Plan has evaluated the existence of subsequent events through October 13, 2025, which represents the date the financial statements were available to be issued.

3. Internal Revenue Service Status

The Plan operates under a non-standardized adoption agreement in connection with a prototype retirement plan and trust/custodial document. This prototype document has been filed with the appropriate agency and has obtained an opinion letter on March 31, 2014, in which the Internal Revenue Service stated that the prototype plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code and, therefore, not subject to tax.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

The Plan is required to file form 5500 "Annual Return / Report of Employee Benefit Plan". The returns of the Plan are subject to examination by the respective taxing authorities, generally for three years after they are filed. The returns for the years ended December 31, 2022, 2023 and 2024 are still considered open subject to possible examination.

4. Information Certified by the Plan Trustee and Custodians (Unaudited)

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the trustees and custodians of the Plan have certified the following information included in the accompanying financial statements and supplemental schedule is complete and accurate to the best of their knowledge and belief.

- Investments at December 31, 2024 and 2023.
- Dividends and interest income and net appreciation (depreciation) in fair value of investments for the year ended December 31, 2024.
- Supplemental schedule – all investment information.

The Plan's independent auditors did not perform auditing procedures with respect to this information except for comparing such information to the related information included in the financial statements and supplemental schedule.

5. Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs consist of unobservable inputs with little or no market activity and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs are used only when Level 1 or Level 2 inputs are not available.

An asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used should maximize the use of observable inputs and minimize the use of unobservable inputs. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

The Plan's policy is to recognize transfers between Levels 1 and 2 and into and out of level 3 as of the date of the event or change in circumstances that caused the transfer. For the years ended December 31, 2024 and 2023, there were no transfers between Levels 1, 2 or 3.

6. General Account (at Contract Value)

The Plan offers a market value separate account investment option with a general investment account guarantee that provides a stated rate of return and insulates plan participant activity from daily fluctuations in the market. This general account is a fully benefit-responsive investment contract. The account is credited with contributions and with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract is included in the financial statements at contract value. Contract value represents contributions made by participants, plus credited interest less withdrawals and fees. Participants may ordinarily direct the withdrawal or transfer of all or portion of their investment at contract value.

There are no reserves against the contract value for credit risk of the contract issuer or otherwise. Certain events limit the Plan's ability to transact at contract value. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The average yield earned is calculated by dividing the annual interest credited to the plan during the plan year by the average annual fair value. The average interest rate credited to participants is calculated by dividing the annual interest credited to the participants during the plan year by the average annual fair value. The average yield earned by the plan and the average interest rate credited to participants is generally the same. The average yield for the year ended December 31, 2024 and 2023, was 3.12% and 4.26%, respectively.

The value as reported represents the contract value (generally the liquidation value). At December 31, 2024 and 2023, the reported contract value was \$2,314,084 and \$3,525,730. Dividends and interest earnings for the years ended December 31, 2024 and 2023 was \$103,836 and \$150,764, respectively.

7. Transactions with Parties-in-Interest

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, a person who owns 50% or more of the employer, or relative of such persons.

The Plan Sponsor pays certain administration and recordkeeping fees relating to the Plan. Fees paid by the Plan for investment management and advisory services are included in the net appreciation in fair value of investments of the Plan.

Plan investments include a guaranteed interest account (general account) managed by a custodian of the Plan. The custodian of the guaranteed interest account as of and for the years ended December 31, 2024 and 2023 was Great-West Life & Annuity Insurance Company, an affiliate of Empower.
