### **Opinion**

We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditors' Responsibilities for the Audit of the Financial Statements**

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audits.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

## NOTES TO FINANCIAL STATEMENTS FOR THE YEARS ENDED DECEMBER 31, 2024 AND 2023

---

### 1. PLAN DESCRIPTION

The following description of the Nucor Corporation Group Life & Health Insurance Plan For All Employees (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General - The Plan was established to provide medical and dental benefits to employees of Nucor Corporation (the "Employer") and their covered dependents. Plan assets are held in a health and welfare grantor trust (the "Trust"). Employees are eligible to participate in the Plan after they have been employed as a full-time employee for thirty days. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The Plan is also subject to the rules and regulations promulgated by the Department of Labor ("DOL") and the Internal Revenue Service ("IRS"). Failure to comply with the provisions of ERISA or the rules and regulations of the DOL and IRS could result in penalties to the Plan and/or the Employer. The Employer believes it has complied in all material respects with such rules and regulations.

Benefits - The Plan provides health (medical, hospital, surgical, major medical, prescription drugs and dental) benefits to full-time employees (with at least 20 hours of work during a consecutive 30 day period) and to their covered dependents. Retired employees are entitled to similar health benefits provided they have attained at least age 50 and the combination of age and continuous years of service is equal to or greater than 70. Certain terminated employees are entitled to participate in the Plan for a limited time under the terms of the Consolidated Omnibus Budget Reconciliation Act of 1985 ("COBRA").

Self-Insured Benefits - All plan benefits are self-insured. The claims for self-insured benefits are processed by the Plan's third-party claims processors under administrative services only agreements. The claims processors pay claims directly to or on behalf of participants and are then reimbursed by the Plan's trust. Despite the Plan's utilization of third party claims processors, ultimate responsibility for payments to providers and participants is retained by the Plan.

Contributions - The plan agreement provides that the Employer make contributions to provide for the payment of benefits. The Employer contributes all amounts in excess of amounts contributed by the participants that are necessary to provide current benefit payments under the Plan. Participant contributions to the Plan are required for coverage. The Employer determines the amounts to be contributed to the Plan by the plan participants. The Plan also contains a flexible spending feature that enables participants to receive reimbursements for eligible medical expenses not otherwise reimbursable under any other health care coverage. Prior to the beginning of each Plan year, participants may elect to designate a portion of their compensation to provide for health, dental or dependent care benefits. Amounts designated to pay for basic health and medical coverage are excluded from the employee's taxable income. The balance in flexible spending accounts totaled approximately \$1,948,000 and \$1,122,000 as of December 31, 2024 and 2023, respectively.

Concentration of Credit Risk - Financial instruments, which potentially subject the Plan to concentrations of credit risk, consist principally of cash. As of December 31, 2024 and 2023, all cash was maintained by a single major financial institution. At times, cash at this financial institution is in excess of the Federal Depository Insurance Corporation insurance limit.

Reimbursements - The Medicare Prescription Drug Improvement and Modernization Act of 2003 provides reimbursements to employers that sponsor postretirement health care plans that provide certain benefits. Such reimbursements, if any, have not been reflected in the postretirement benefit obligation and changes in the benefit obligation because the Plan is not directly entitled to these benefits.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The financial statements have been prepared on the accrual basis of accounting.

Use of Estimates - The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America ("GAAP") requires management to make estimates and assumptions that affect the reported amounts of certain assets and liabilities, including estimated health claims incurred but not reported and claims payable and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Postretirement Benefit Obligation - The Plan records the postretirement benefit obligation at the actuarial present value of those estimated future benefits that are attributed to employee service rendered through December 31. Postretirement benefits include future benefits expected to be paid to or for (1) currently retired employees and their beneficiaries and dependents and (2) active employees and their beneficiaries and dependents after retirement from service with the Employer. Prior to an active employee's full eligibility date, the postretirement benefit obligation is the portion of the expected postretirement benefit obligation that is attributed to that employee's service rendered to the valuation date.

Post-Employment Benefit Obligation - The Plan records the post-employment benefit obligation at the actuarial present value of those estimated future benefits that are attributed to employees that were disabled or terminated as of December 31, but still eligible to receive benefits.

Payment of Benefits - Claims payments are recorded when paid by the third-party claims processors. Amounts due to claims processors that have yet to be reimbursed by the Plan are recorded as claims payable in the accompanying statements of benefit obligations and net assets available for benefits.

Subsequent Events - Management has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued.

3. POSTRETIREMENT BENEFIT OBLIGATIONS

The actuarial present value of the expected postretirement benefit obligations are determined by an actuary and is the amount that results from applying actuarial assumptions to historical claims-cost data to estimate future annual incurred claims-costs per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as those for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment.

For measurement purposes as of December 31, 2024, 6.25% and 10.25% annual rates of increase in the per capita cost of covered medical and prescription health care benefits, respectively, was assumed for 2025; the rate was assumed to decrease gradually to 4.00% for 2050 and to remain at that level thereafter. For measurement purposes as of December 31, 2023, 6.75% and 9.75% annual rates of increase in the per capita cost of covered medical and prescription health care benefits, respectively, was assumed for 2024; the rate was assumed to decrease gradually to 4.00% for 2049 and to remain at that level thereafter.

The significant actuarial assumptions used in the valuations as of December 31, 2024 and 2023 include:

Retirement Age	65
Mortality	Pri-2012 base mortality tables, separate employee and retiree, with projected mortality improvement using the MP-2021 projection scale with 80% blue collar adjustment.

The foregoing actuarial assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of accumulated plan benefits.

The health care cost-trend rate assumption has a significant effect on the amounts reported. If the assumed rates increase by 1% point each year, that would increase the obligation as of December 31, 2024 and 2023, by approximately \$4,460,000 and \$4,487,000 respectively.

#### 4. POST-EMPLOYMENT BENEFIT OBLIGATIONS

The actuarial present value of the expected post-employment benefit obligations is based on the actual number of employees utilizing these benefits as of the measurement date and claim payment history and includes estimates of claims incurred by participants that have not been reported.

The significant actuarial assumptions used in the valuations as of December 31, 2024 and 2023 include:

5. CLAIMS INCURRED BUT NOT REPORTED

Plan obligations as of December 31, 2024 and 2023 for health claims incurred by active participants but not reported at that date and for accumulated eligibility of participants are estimated by the Plan's actuary in accordance with accepted actuarial principles. These amounts are paid by the Plan only if claims are submitted and approved for payment.

6. ADMINISTRATIVE EXPENSES

The Plan pays administrative expenses which consist primarily of administrative fees paid to third-party claims administrators. These expenses are reported on the accompanying statements of changes in benefit obligations and net assets available for benefits as administrative expenses. Certain other expenses of the Plan, such as professional fees, are paid by the Employer on behalf of the Plan.

7. TAX STATUS

The Plan constitutes a Health and Welfare Fund organized as a grantor trust. The trust is exempt from income tax as described under Section 419(e)(3)(B) of the Internal Revenue Code.

GAAP requires management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the taxing authorities. Management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits of any tax periods in progress.

8. PLAN TERMINATION

Although it has not expressed an intent to do so, the Employer has the right under the Plan to modify the benefits provided to employees, to discontinue its contributions at any time, and to terminate the Plan subject to the provisions of ERISA.

Benefits shall be paid only to the extent that assets held in the Plan are sufficient to pay outstanding claims. Any excess funds must be used to provide benefits for the plan participants on such equitable basis as shall be determined by the Investment Committee.

9. RISKS AND UNCERTAINTIES

The actuarial present value of benefit obligations is reported based on certain assumptions pertaining to interest rates, health care inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.
