INDEPENDENT AUDITOR'S REPORT

To the Administrators of the

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Mission Senior Living, LLC 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.



NOTE 1 - Description of Plan:

The Plan was created to enable eligible permanent employees of Mission Senior Living, LLC (the “Company”) and their beneficiaries to assist in meeting their retirement income requirements by providing a payroll-based savings program and to share in the Company’s profits.

The following description of the Mission Senior Living, LLC 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General:

The Plan is a defined contribution plan (as adopted from ADP, LLC, the Third-Party Administrator’s “Prototype Non-standardized Pre-Approved Profit-Sharing Plan/Money Purchase/CODA”) covering all employees of the Company who have completed six months of service and are age twenty-one or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan administrator is responsible for the oversight of the plan, including monitoring of investment options and performance.

Contributions:

Each year participants may contribute from 1% up to 90% of their total annual compensation as either a pre-tax 401(k) contribution or as a Roth 401(k) contribution, as defined in the Plan, up to the IRS maximum. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and common/collective trust funds as investment options for participants. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default deferral rate set at 3% of eligible compensation. Contributions are automatically invested in a company selected default investment fund until changed by the participant. The Company may make discretionary matching contributions but has elected not to match contributions for the years ended December 31, 2024 and 2023. Contributions are subject to certain statutory limitations.

Participant Accounts:

Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s matching contribution (if any) and, (b) Plan earnings (losses). Allocations are based on participant account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting:

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company’s contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after five years of credited service.

Notes Receivable from Participants

Participants may borrow up to 50% of their vested account balance with a minimum loan amount of \$500 and a maximum loan amount of \$50,000. The \$50,000 maximum must be reduced by the highest outstanding loan balance the participant had under the Plan during the previous one-year period. The notes are secured by the balance in the participant’s account and bear interest at the prime rate plus two percentage points, per annum. Principal and interest are paid ratably through monthly payroll deductions and must be repaid within five years unless the loan was used for the purchase of a primary residence and then it must be repaid within thirty years.

NOTE 1 - Description of Plan (Continued):

Payment of Benefits:

On termination of service due to death, disability, or retirement or in the case of financial hardship, a participant may elect to receive an amount equal to the value of the participant's vested interest in their account. Generally, withdrawals are paid in cash in a single lump sum.

Forfeited Accounts:

At December 31, 2024, there were no forfeited non-vested amounts. If there were forfeitures, these amounts would be used to reduce employer contributions or to pay Plan expenses.

Rollovers:

The Plan accepts rollover contributions of eligible rollover distributions from certain qualified plans, annuity contracts and individual retirement accounts. However, the plan will not accept a rollover of any after tax contributions. Monies rolled over to the Plan do not require the participant to satisfy the Plan's age and service requirements but will be subject to the provisions of the Plan.

NOTE 2 - Summary of Significant Accounting Policies:

Basis of Accounting:

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan.

Use of Estimates:

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition:

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Shares of registered investment companies are valued at quoted market prices which represent the net asset value of shares held by the Plan at year end.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

NOTE 2 - Summary of Significant Accounting Policies (continued):

Excess Contributions Payable:

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as accounts payable, with a corresponding reduction to contributions. The excess contributions payable for the years ended December 31, 2024 and 2023 is \$- and \$-, respectively.

Payment of Benefits:

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Company and are therefore excluded from these financial statements. However, the Company applied for reimbursement of \$25,975 and \$15,950 from the Plan for accounting and audit fees relevant to the Plan in 2024 and 2023, respectively. Therefore, the \$25,975 and \$15,950 are included in the administrative expenses for the years ended December 31, 2024 and 2023, respectively. Investment-related expenses are included in net appreciation (depreciation) in fair value of investments. Fees for the administration of notes receivable from participants are included in administrative expenses and charged directly to the participant's account.

NOTE 3 - Risks and Uncertainties:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

The Plan invests in common collective trusts, and mutual funds with underlying assets consisting of any combination of stocks, bonds, fixed income securities and other investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the fair values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

On July 6, 2021, the plan administrator received a notice of rejection of the form 5500 annual report for the year ended December 31, 2019 from the U.S. Department of Labor (DOL). The DOL rejected the December 31, 2019 form 5500 filing due to missing required material information. On January 5, 2022, the Company received a Notice of Intent to Assess a Penalty from the DOL asserting the \$50,000 maximum penalty. Legal counsel estimates the potential penalty for this matter to be between \$0 and the maximum of \$50,000. Further, as the 2018 and 2020 forms 5500 were initially filed without the required Independent Qualified Public Accountant reports, additional penalties could be assessed.

An operational failure of the plan was noted during examination of plan documents. The original effective date for the Plan, per the Adoption Agreement, was January 1, 2017. This Adoption Agreement was executed on December 17, 2017. The Adoption Agreement notes elective deferrals and a 3% automatic contribution arrangement to all eligible participants as of the last payroll of 2017 and that eligible participants be given an opportunity to make elective deferrals as of the last payroll of 2017. Further, a 5500 for 2017 was not prepared or filed. Management has asserted that the Company intended the effective date of the plan to be January 1, 2018 with automatic contribution arrangements to begin April 1, 2018. The Company amended the Adoption Agreement on December 12, 2024 for the correction on the effective date to be January 1, 2018 with automatic contribution arrangements to begin April 1, 2018 under the Employee Plans Compliance Resolution System (EPCRS) and a Voluntary Correction Program (VCP) application. However, As of December 31, 2024, the Company has not received a response regarding the correction. Depending on the outcome of the correction to the Adoption Agreement, the Company may need to enter into the Delinquent Filer Voluntary Compliance Program (DFVCP) with respect to the 2017 5500. The VCP application will also include an amended form 5500 for 2018 to include the Independent Qualified Accountant Report once it can be submitted.

NOTE 3 - Risks and Uncertainties (continued):

EPCRS corrects plans for purposes of DOL filings, but the Internal Revenue Service has stated that late 5500 filings cannot be corrected under EPCRS. At this time, the IRS has not asserted that the filings were late; however, there could be penalties assessed. At this time it is uncertain as to the amount of penalties that could be assessed.

The Plan invests in common collective trusts, and mutual funds with underlying assets consisting of any combination of stocks, bonds, fixed income securities and other investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the fair values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

NOTE 4 - Concentration of Credit Risk:

The concentration of credit risk with respect to mutual funds managed by ADP Company is reduced as a result of the diversity of the underlying investments.

NOTE 5 - Unaudited Information Certified by the Trustee:

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company (the trustee of the Plan). Accordingly, as permitted under such election, the following information was provided by ADP Company (U.S.A), Recordkeeper of the Plan acting on behalf of the trustee, and was not subjected to any auditing procedures performed by the independent auditor:

NOTE 8 - Tax Status:

The Internal Revenue Services (IRS) has determined and informed the Company by a letter dated October 6, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Other than as mentioned in Note 3, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

NOTE 9 - Fair Value Measurements:

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 3 inputs for the periods presented.

Level 1 Fair Value Measurements

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Level 2 Fair Value Measurements

Common/collective trusts: Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchased and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.
