***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of the **Turner, Padgett, Graham & Laney, P.A. 401(k) Plan** (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The Plan is a defined contribution plan covering all employees of Turner, Padget, Graham, & Laney, P.A. (the Company). Each full-time employee is eligible to participate on the first plan entry date following the attainment of age 21 and the completion of a six-month service period. Part-time employees are eligible to participate on the first plan entry date following the attainment of age 21 and completion of at least 1,000 hours of service. Plan entry dates are the first day of each month. The Plan has an automatic enrollment feature so that newly eligible participants begin making salary deferral contributions to the Plan, unless they elect not to do so, with a default deferral rate of 3% of eligible compensation. Contributions are automatically invested in a balanced fund until changed by the participant.

OneAmerica serves as the trustee of the Plan, and certain members of management serve on an advisory committee which oversees the governance of the Plan, including determining the appropriateness of the investment offerings and monitoring investment performance. The Plan is subject to the provisions of the Employee Retirement Income Security Act (ERISA) of 1974.

The Setting Every Community Up for Retirement Enhancement (SECURE) 2.0 Act of 2022 was enacted to enhance retirement savings opportunities and improve retirement plan administration in the United States. The Act provides a broad range of mandatory and optional provisions affecting retirement plans, including increasing participation, improving portability of retirement savings, and expanding penalty-free withdrawal options for certain circumstances. Plan sponsors may elect to adopt certain provisions voluntarily before their mandatory effective dates. For the year ended 2024, the Plan adopted the following voluntary provisions under the SECURE 2.0 Act:

- Eligibility requirements for long-term part-time (LTPT) employees: LTPT employees who complete at least 500 hours of service in three consecutive plan years become eligible to defer into the Plan. They are not eligible for employer contributions.
- The automatic cash-out threshold for former participants' account balances was increased from \$5,000 to \$7,000.

Management has evaluated the impact of these amendments and determined that they do not materially affect the financial statements as of and for the year ended December 31, 2024. These changes are intended to improve participant experience and administrative efficiency in accordance with recent legislative developments.

Contributions

Participants may contribute up to 100% of their pretax annual compensation, as defined in the Plan, subject to the limitations as defined in the Internal Revenue Code (IRC).

Effective January 1, 2019, the Company adopted safe harbor non-elective contribution provisions. Under these provisions, the Company must contribute safe harbor non-elective contributions equal to 3% of each eligible participant's annual compensation. The Company made safe harbor non-elective contributions of approximately \$382,000 and \$424,000 for the years ended December 31, 2024 and 2023, respectively.

Contributions (continued)

Each year the Company may contribute to the Plan a discretionary matching amount and/or a discretionary profit-sharing amount determined annually by the Company's Executive Committee. No discretionary profit-sharing contributions were made during the years ended December 31, 2024 and 2023.

Qualified non-elective contributions may be made by the Company in order to satisfy the non-discrimination tests described in the IRC. Qualified non-elective contributions are allocated in the same manner as the Company's profit-sharing contributions. The Company did not make any qualified non-elective contributions for the years ended December 31, 2024 and 2023.

Rollover and transfer contributions to the Plan are permitted from other qualified defined benefit or defined contribution plans. Participants are always 100% vested in rollover and transfer contributions plus earnings thereon.

Participant accounts

Each participant's account is credited with the participant's contributions and an allocation of (a) the Company's safe harbor non-elective, discretionary matching, profit-sharing, and qualified non-elective contributions (if any); and (b) plan earnings and losses and charged with an allocation of administrative expenses. Participants' accounts are charged for certain participant directed transactions. Allocations are based on participant earnings or account balances as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions and the Company's safe harbor and qualified non-elective contributions plus actual earnings thereon. Vesting in the Company's discretionary matching and profit-sharing contributions, plus actual earnings thereon, is based on years of continuous service. A participant is 20% vested after two years of continuous service. Vesting increases by 20% each year thereafter, and the participant is 100% vested after six years of continuous service. Upon reaching the minimum retirement age or if a participant dies or becomes disabled, the participant will become 100% vested in all contributions.

Forfeitures

Forfeitures are created when participants terminate employment before becoming entitled to their full benefits under the Plan. The Plan had approximately \$0 and \$7,780 of available forfeitures at December 31, 2024 and 2023, respectively. Forfeitures generated in 2024 and 2023 were approximately \$16,189 and \$10,740, respectively. Forfeited employer contributions not used to pay administrative expense may be used to reduce future employer contributions. Forfeitures of approximately \$24,102 and \$55,700 were used to offset employer contributions and administrative expenses in 2024 and 2023, respectively.

Investment options

Upon enrollment in the Plan, participants may direct their contributions and the Company's contributions in a variety of investment options as more fully described in the Plan's literature. Participants may change their investment options at any time.

Withdrawal and payment of benefits

On termination of service, if a participant's vested account balance does not exceed \$1,000, the Plan will automatically distribute the participant's vested account balance in a lump sum. If his or her vested account balance exceeds \$1,000 but is less than \$7,000 (\$5,000 prior to 2024) (excluding rollover contributions and earnings thereon), a participant may elect to receive a single lump sum or roll over the vested balance into an individual retirement account (IRA) or another qualified plan. However, if no election is made by the participant, the Plan will automatically roll over the vested balance into an IRA as designated by Plan management. If his or her balance exceeds \$7,000 (\$5,000 prior to 2024) (excluding rollover contributions and earnings thereon), a participant may leave his or her balance in the Plan or elect to receive the value of the participant's interest in his or her account in the form of a single lump sum, installment payments, or roll over the balance into an IRA or other qualified plan. Participants still employed may withdraw all or part of their employee deferral contributions, employer matching contributions, or employer nonelective contributions upon furnishing proof of financial hardship.

**Note 2. Summary of Accounting Policies**

Basis of accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ materially from those estimates.

Contributions

Employee contributions are recorded in the period during which the Company makes payroll deductions from the participant's earnings.

Discretionary and safe harbor employer contributions are accrued and paid based on amounts to be funded for each year under the Plan provisions and the applicable requirements of the IRC.

Investment valuation and income recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment advisors and custodians. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis by the trustee. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Management fees and operating expenses charged to the Plan for investments in registered investment companies are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment returns.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan payments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and the delinquent participant loan is recorded as a benefit payment based on the terms of the Plan document.

Payment of benefits

Benefits are recorded when paid.

Administrative expenses

Certain expenses of maintaining the Plan are paid by the Plan unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefits paid to participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

**Note 3. Information Prepared and Certified by Trustee**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest, and dividends for the years then ended, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by OneAmerica (the trustee of the Plan).

**Note 4. Fair Value Measurements**

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023:

- *Shares of registered investment companies (mutual funds):* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Note 5. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 6. Tax Status**

The Plan is a prototype of OneAmerica Financial Partners Inc. A letter has been received from the Internal Revenue Service (IRS) dated November 30, 2020, indicating that the form of the prototype plan is acceptable under Section 401 of the Internal Revenue Code (IRC) for use by employers for the benefit of their employees and is exempt from federal income taxes. The Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 7. Contracts with Insurance Company**

Beginning in 2022, the Plan offered its participants a traditional fully benefit-responsive guaranteed investment contract with American United Life Insurance Company (AUL) totaling \$2,928,188 and \$2,956,177, as of December 31, 2024 and 2023, respectively. The AUL Stable Value Account (SVA) is an interest-earning investment option, backed by AUL's general account assets. Interest is credited to all SVA monies at the current rate declared by AUL. New contributions and transfers to the SVA earn the interest rate in effect at the time of the contribution or transfer. AUL may declare a new interest rate for the SVA that becomes effective on January 1 of each calendar year; however, any increase in the interest rate will never be greater than 1% above the previously declared rate. The minimum interest rate guarantee is 0%. These guarantees are based on the continued claims-paying ability of AUL.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by American United Life Insurance Company, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (a) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that cause a significant withdrawal from the Plan, (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (e) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Such events include the following: (a) an uncured violation of the Plan's investment guidelines, (b) a breach of material obligation under the contract, (c) a material misrepresentation, or (d) a material amendment to the agreements without the consent of the issuer.

**Note 8. Plan Termination**

Although it has not expressed any interest to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their accounts.

**Note 9. Party-In-Interest Transactions**

The Plan offers a stable value investment option as described in Note 7, which is managed by American United Life Insurance Company, an affiliated entity of OneAmerica. OneAmerica is the custodian and recordkeeper as defined by the Plan and therefore these transactions qualified as party-in-interest transactions. Fees paid by the Plan to OneAmerica during 2024 and 2023 were \$3,173 and \$2,496, respectively.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**Note 10. Delinquent Contributions**

Due to administrative errors, the company did not remit certain participant contributions of \$70,083 in a timely manner as defined by ERISA during 2023. These contributions are considered non-exempt party-in-interest transactions which may result on an imposition of a 15% excise tax on the amount of the transaction. The Company intends to compensate participants for any potential lost earnings associated with the delay in remitting contributions. The accompanying financial statements do not include any adjustments or accrual related to the potential liability for excise tax or earnings.

**Note 11. Subsequent Events**

Effective January 1, 2025, OneAmerica Financial, Inc. was acquired by Voya Financial, Inc. The Plan is scheduled to migrate to Voya Financial's platform in February 2026.

The Plan has evaluated subsequent events through October 8, 2025, the date the financial statements were available to be issued. There were no additional material subsequent events requiring disclosure as of this date.
