Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Alta Ski Lifts Company Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Opinion

presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

1 – Description of the Plan

The following description of the Alta Ski Lifts Company Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan adopted January 1, 2019 covering all full-time employees of Alta Ski Lifts Company (the "Plan Sponsor" or the "Company"). The Plan is subject to the provisions of the Employment Retirement Income Security Act of 1974 (ERISA). The sponsors board of directors is responsible for the oversight of the Plan. The plan administrator determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the board.

Eligibility - Employees of the Company that are 21 years of age become eligible to participate in the Plan after one year of continued service as defined in the Plan document, provided they are not excluded employees.

Contributions - All eligible employees may make elective deferral and/or Roth contributions into the Plan up to 100% of pretax annual compensation, subject to limitations, as defined by the Plan. However, deferred contributions for any participant cannot exceed \$23,000 and \$22,500 in 2024 and 2023. Participants over the age of 50 are allowed to make catch-up contributions which cannot exceed \$7,500 for 2024 and 2023.

Eligible participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The amount of any rollover contributions will be invested along with other assets of the Plan but will be held for the participant in a special rollover account and will be 100% vested at all times.

The Plan Sponsor makes matching safe harbor contributions equal to 100% of the first 4% of base compensation. The Sponsor may elect to make a matching contribution on employee elective deferral contributions in excess of the minimum but is not obligated to do so per the Plan Document. The Company may also elect to make a discretionary profit-sharing contribution.

Vesting - A participant's elective deferral account balance and earnings thereon is always 100% vested. A participant is also immediately and fully vested in Sponsor contributions.

Participant accounts - Each participant's account is credited with the participant's contribution and allocation of the Sponsor's contributions, Plan earnings or losses, and may be charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant compensation or account balances.

The Plan provides that participants may direct how their account balance is invested among the investment alternatives offered by the Plan. The Plan offered mutual funds and a collective trust fund as investment options in 2024 and 2023.

Payment of benefits - On termination of service due to death, disability, or retirement (as defined by the Plan), a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested benefit or receive the vested benefit in partial withdrawals over a specified period of time. If the value of the vested account balance is \$5,000 or less the balance will be paid in one lump sum to the participant unless they elect to roll the balance into another qualified plan.

Notes receivable from participants - The plan does not allow for participant loans.

Forfeited accounts - As allowed in the Plan Document, forfeitures may be used to restore forfeitures, reduce the employer matching contribution, or pay reasonable Plan expenses. There are no Forfeited non-vested amounts in 2024 or 2023 due to participants being 100% vested as soon as deferrals are contributed.

Significant plan amendments - There were no significant plan amendments during the year ended December 31, 2024. There was a plan amendment during 2023 that changed the hours of service necessary for a year of eligibility from 780 to 760 hours. A break in service is considered if an employee works less than 500 hours.

2 – Significant accounting policies

Basis of accounting - The financial statements of the Plan are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Management estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition - The Plan's investments are reported at fair value. Quoted market prices are used to value mutual funds. See note 4 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. The Plan presents in the statement of changes in net assets the net appreciation (depreciation) in the fair value of investments, which consists of the realized gains (or losses) and the unrealized appreciation (depreciation) on those investments.

Payment of benefits - Benefits are recorded when paid.

Operating expenses - The Plan allows for administrative expenses to be paid from Plan assets, which are recorded as incurred, although the Plan Sponsor may also pay for some expenses. Fees related to certain participant specific administrative items may be charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments.

4 – Fair value measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, defines fair value as the price that would be received on the measurement date to sell an asset or the price paid to transfer a liability in the principal or most advantageous market available to the entity in an orderly transaction between market participants. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2

Inputs to the valuation methodology include

- quoted market prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are generally open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Money Market Fund – Valued at the daily closing price as reported by the fund. The money market fund held by the Plan is an open-end mutual fund that is registered with the SEC. The fund is required to publish the NAV daily and to transact at that price. The money market fund held by the Plan is deemed to be actively traded.

5 – Related party and party-in-interest transactions

North Capital Inc. acts as an advisor to the plan while Retirement Plan Consultants, LLC acts as the third-party administrator and record keeper. Matrix Trust Company acts as trustee and custodian of the Plan. The investment transactions qualify as party in interest transactions which are exempt from the prohibited transaction rules. Fees paid by the Plan for the investment management and administrative services amounted to \$21,667 and \$16,299 for December 31, 2024 and 2023, respectively.

6 – Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participant's account balances and the amounts reported on the statement of net assets available for benefits.

7 – Income tax status

Effective January 1, 2019, the Plan adopted a non-standardized pre-approved profit sharing plan with CODA sponsored by CCH Incorporated. The prototype plan received a favorable opinion letter from the Internal Revenue Service dated June 30, 2020, that it is a qualified Plan under §401(a) of the Internal Revenue Code and as such the Plan is exempt from federal income tax. The Plan has been amended since the latest amendment covered by the determination letter. However, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, the administrator believes that the Plan is qualified and the related trust is tax-exempt.

8 – Plan termination

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

9 – Subsequent events

Management has evaluated subsequent events or transactions that occurred after December 31, 2024, through October 13, 2025, the date these financial statements were available to be issued. There were no material recognizable subsequent events


