Notes to Financial Statements

Note 1: Description of Plan

The following description of the One Diversified, LLC 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

Participation

Eligible employees of Diversified Video Systems, Diversified Media Group, Skyweb Digital Media, LLC, DiamondLyte, LLC, Technical Innovation, The Systems Group, LLC, CompView Medical, LLC, Media Management LLC, MCW Solutions, Sensory Technologies LLC, and HB Communications, Inc, (collectively "One Diversified" or the "Company") may participate in the Plan as of the entry date. The entry date is considered the first day of the month coinciding with or next following the date on which all applicable age and service requirements are satisfied. For elective salary deferrals, a participant becomes eligible on the participant's hire date. For the Company matching and discretionary nonelective contributions, if any, a participant becomes eligible after completing 1,000 hours in a 12-month period and attaining age 21. Effective November 1, 2023, for elective salary deferrals and the Company matching and discretionary nonelective contributions, a participant becomes eligible after the completion of 30 days of service. The entry date is considered the date on which the applicable service requirement is satisfied.

Contributions

A participant may elect to defer a percentage of compensation up to the limits allowed by the Internal Revenue Service (IRS). The Plan allows participants to make pre-tax and/or Roth elective deferrals. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). The Plan has implemented an automatic contribution arrangement in which employees hired on or after January 1, 2018 will be automatically enrolled at a deferral rate of 3% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. The employer can make discretionary matching and discretionary nonelective contributions to the Plan. During the year ended December 31, 2024, the Company made a discretionary matching contribution of 2% of eligible compensation. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Contributions are credited to individual accounts of each participant. The Plan allows participants to direct the investment of their contributions and the Company's contributions into various investment options.

Participant Accounts

Each participant's account is credited with the participant's contributions, Company discretionary matching and discretionary nonelective contributions, and an allocation of (a) plan earnings (losses), and (b) forfeitures of terminated participants' nonvested accounts. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes to Financial Statements

Note 1: Description of Plan (Continued)

Vesting

Participants are vested immediately in their voluntary contributions plus actual earnings (losses) thereon. Vesting in the Plan's contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. Participants vest at a rate of 20% beginning with the second year of service. Participants become fully vested after three years of service.

Notes Receivable from Participants

Participants may borrow a total of the lesser of 50% of their vested account balance (\$1,000 minimum) or \$50,000. A maximum of two outstanding notes are permitted at one time per participant. Loan terms range from one to five years; however, terms may exceed five years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan administrator. Interest rates were in the range of 4.25% and 9.50% at December 31, 2024. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant shall be entitled to receive the vested amount in his or her separate account. The Plan provides that distributions at retirement be made at the participant's option, either in one of several annuity options or in a lump-sum distribution. In addition, hardship distributions out of the participant's vested accounts are permitted if certain criteria are met. A participant's normal retirement age is 59-1/2.

Upon the death of a participant, the participant's account balance will be 100% vested and will be used to provide his or her beneficiary with a death benefit.

Upon termination, a participant shall be entitled to his or her vested interest in the amount credited to his or her account.

Forfeitures

The portion of a participant's account balance which is not vested upon termination of employment will be forfeited and may be used in future periods to pay for administrative expenses or employer contributions.

Forfeitures amounting to approximately \$898,905 and \$200,000 at December 31, 2024 and 2023, respectively, were available for reduction of future administrative expenses or employer contributions. For the year ended December 31, 2024, \$1,566 of forfeitures were used to reduce employer contributions and \$20,118 of forfeitures were used to reduce plan expenses.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

This summary of significant accounting policies of the Plan is presented to assist in understanding the Plan's financial statements. The financial statements and notes are representations of the Plan's management who is responsible for their integrity and objectivity. These accounting policies conform to accounting principles generally accepted in the United States of America and have been consistently applied in the preparation of the financial statements.

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States (GAAP).

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities, at the date of the financial statements, and the reported amount of additions to and deductions from net assets during the reporting period. Actual results could differ from these estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Notes Receivable From Participants

Notes receivable from participants are reported at their unpaid principal balances plus accrued interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for uncollectible accounts was recorded as of December 31, 2024 and 2023. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Note 2: Summary of Significant Accounting Policies (Continued)

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefit payments are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are allocated proportionately to plan participants based on their respective account balances and are included in net investment income/loss.

Expense Offset Arrangements

Fees incurred by the Plan for investment management services or recordkeeping are included in the net appreciation (depreciation) in fair value of investments, as they are paid through revenue sharing, rather than a direct payment.

Subsequent Events

The Plan has evaluated subsequent events through October 13, 2025, which is the date the financial statements were available to be issued.

Note 3: Information Prepared and Certified by the Trustee

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Bank of America, the Trustee of the Plan, effective November 1, 2023.

Note 4: Fair Value Measurements

FASB's Accounting Standards Codification, ("ASC") 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements), and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Note 4: Fair Value Measurements (Continued)

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs that are unobservable inputs for the asset or liability.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common Collective Trust Funds: Valued at the net asset value (NAV) of units of a bank common trust. The NAV, as provided by the Trustee, is used to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less liabilities. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate full redemption of the common trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

Note 5: Tax Status

The Plan adopted a non-standardized pre-approved profit sharing plan sponsored by Automatic Data Processing, which received an Opinion Letter from the Internal Revenue Service. The plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Note 6: Related-Party Transactions and Party-in-Interest Transactions

Plan investments are managed by Bank of America, N.A. ("Bank of America"), the Trustee, as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Bank of America receives revenue from mutual fund service providers for services Bank of America provides to the funds. This revenue is used to offset certain amounts owed to Bank of America for its administrative services to the Plan. If the revenue received by Bank of America from such mutual fund service providers exceeds the amount owed under the service agreement with the Plan, Bank of America remits the excess to the Plan's trust. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. The Plan or Company may make a payment to Bank of America for administrative expenses not covered by revenue sharing.

Merrill Lynch, Pierce, Fenner, & Smith Incorporated ("Merrill Lynch") became the third-party administrator, as defined by the Plan, and therefore transactions with Merrill Lynch also qualify as party-in-interest transactions. Administrative expenses totaling \$34,384 were paid to Merrill Lynch for the year ended December 31, 2024.

Note 6: Related-Party Transactions and Party-in-Interest Transactions (Continued)

Merrill Lynch is the financial advisor, as defined by the Plan, and therefore transactions with Merrill Lynch qualify as party-in-interest transactions. Fees incurred by the Plan for investment management services are included in net appreciation/depreciation in fair value of investments, since they are paid through revenue sharing rather than a direct payment.

Wipfli LLP ("Wipfli") is the auditor for the Plan and, therefore, fees paid to Wipfli also qualify as party-in-interest transactions. Fees paid directly by the Plan to Wipfli for audit services amounted to \$20,118 for the year ended December 31, 2024.

Notes receivable from participants are also considered party-in-interest transactions exempt from the prohibited transactions rules.

Note 7: Risks and Uncertainties and Concentration of Investments

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 8: Plan Termination

Although it has not expressed any intent to do so, the Company, and each participating employer, has the right under the Plan to discontinue its contributions at any time and to terminate its participation in the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

Note 9: Prohibited Transactions

Under DOL Reg. 2510.3-102(b), the Plan is required to remit the employee contributions to the Plan at the earliest date such amounts can be reasonably segregated from the Plan's general assets, but no later than the fifteenth business day of the month following the date that participant contributions are withheld by the Plan. As reported on Schedule H, Line 4a – Schedule of Delinquent Participant Contributions, certain contributions for payrolls during the plan year ended December 31, 2023, totaling \$697, were remitted outside the 15-day requirement. These transactions constitute prohibited transactions as defined by ERISA.

Note 10: Excess Matching Contributions Payable

Matching contributions paid to certain participants in 2023, included excess payments of \$2,095; in order to satisfy the relevant nondiscrimination provisions of the Plan, the excess contributions were forfeited from the impacted participant accounts and are payable to the Plan Sponsor. These amounts are recorded in the Plan's Statement of Net Assets Available for Benefits as excess contributions payable at December 31, 2024.
