INDEPENDENT AUDITORS' REPORT

To the Plan Administrator of
Boston Valley Pottery 401(k) Plan
Orchard Park, New York

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Boston Valley Pottery 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Boston Valley Pottery 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedule Required by ERISA

The supplemental schedule as listed in the table of contents is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO FINANCIAL STATEMENTS FOR THE YEARS ENDED DECEMBER 31, 2024 AND 2023

1. PLAN DESCRIPTION

The following is a brief description of the Boston Valley Pottery 401(k) Plan (the “Plan”) provided for general informational purposes. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General – The Plan is a defined contribution plan as permitted under Section 401(k) of the Internal Revenue Code (“IRC”). The Plan is funded by employee and employer contributions and covers all employees of Boston Valley Terra Cotta, LLC (the “Company”) who have attained 18 years of age. The Plan’s service requirement requires that employees achieve at least one month of service in order to participate. Employees covered by a collective bargaining agreement, nonresident aliens, and leased employees are not eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions – Participants may elect to defer a specified percentage of pre-tax compensation as well as make Roth contributions to the Plan, not to exceed 100% of pre-tax annual compensation, or IRC limitations.

The Plan Sponsor matches 100% of the first 3% of the employee’s elective deferral, plus 50% on deferrals that are greater than 3%, but less than or equal to 5% of compensation. Upon reaching eligibility, participants are automatically enrolled for elective deferrals of 5%.

In addition, the Plan Sponsor may make discretionary profit-sharing contributions to all eligible participants that are actively employed on the last day of the Plan year. Contributions are subject to certain limitations. The Company declared profit-sharing contributions of \$117,525 and \$72,872 for the years ended December 31, 2024 and 2023, respectively.

Vesting – Participants are immediately vested in their elective deferral contributions and safe harbor matching contributions. Vesting in the discretionary profit-sharing contributions, and earnings thereon, are based on a graded vesting schedule as follows:

Notes Receivable from Participants – Participants may borrow from their accounts up to a maximum of the lesser of \$50,000, reduced by the highest outstanding loan balance in the previous year, or 50% of the participants’ vested balance in the Plan, reduced by the current outstanding loan balance, if any. In addition, participants may only have one loan outstanding, generally at a maximum five-year term, longer for primary residence purchase. Loans are subject to a minimum of \$1,000, and bear interest at the prime rate plus 2%. Principal and interest are paid ratably through regular payroll deductions. At December 31, 2024, loan interest rates ranged from 4.25% to 10.50%, maturing through August 2028.

1. PLAN DESCRIPTION (continued)

Participant Accounts – Each participant’s account is credited with the participant’s contribution and an allocation of the employers’ contributions and Plan earnings. Plan earnings are allocated to the participants’ accounts based on the performance of the participants’ investment selections.

Forfeitures – Participants who leave the Plan Sponsor with less than six years of service forfeit the non-vested portion of the Plan Sponsor’s discretionary profit-sharing contributions. Forfeitures are available to reduce expenses associated with the Plan’s administration or offset future Plan Sponsor contributions. During the years ended December 31, 2024 and 2023, approximately \$2,300 and \$2,500 of forfeitures were utilized to offset Plan administrative expenses, respectively. Forfeitures available to offset future employer matching contributions or Plan administrative expenses amounted to approximately \$3,400 and \$120 as of December 31, 2024 and 2023, respectively.

Plan Termination – Although it has not expressed any intent to do so, the Plan Sponsor has the right to terminate the Plan subject to the provisions of ERISA. In the event of termination, participants shall become 100% vested in their accounts at the date of such termination.

Payment of Benefits – Employees are eligible for retirement at age 65. Benefits are determined by the final value of the participant’s account at the time of payment. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. Unless a participant elects otherwise, distributions will be made as soon as practical after a participant’s normal retirement date or actual retirement date. Distributions are also permitted in the event of financial hardship, as defined by the Plan, and after the age of 59 ½.

Participants may receive their accumulated benefits upon termination of employment or elect to keep their account in the Plan until the earlier of normal retirement age, death or disability if their account balance exceeds \$5,000. If the participant elects to keep their account in the Plan, the account will continue to receive its respective allocation of Plan earnings and expenses.

Administrative Expenses – Administrative expenses are primarily paid by the Plan.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting – The accompanying financial statements have been prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition – The Plan determines the fair value of assets and liabilities which are subject to reporting at fair value based on standards established within generally accepted accounting principles. These standards establish a hierarchy for the determination of fair value, as well as disclosure requirements relative to those assets and liabilities. The hierarchy identifies three levels of input. Level 1 inputs are generally quoted market prices for identical assets or liabilities, which are actively traded on an exchange. Level 2 inputs generally consist of market prices for identical assets which are not actively traded or market prices of similar assets or liabilities which are actively traded on an exchange. Level 3 inputs are referred to as unobservable inputs and consist primarily of information derived by management where Level 1 and Level 2 inputs are not available. These may include such things as present value of expected future cash flows or other valuation methodologies. Under the hierarchy, Level 1 inputs are the most preferred, followed by Level 2, and Level 3 are to be used only where neither Level 1 nor Level 2 inputs are available.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

An investment's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for investments measured at fair value as of December 31, 2024 and 2023:

Interest bearing cash and cash equivalents: Investments in money market funds are valued based on quoted net asset values of shares held by the Plan.

Investments in registered investment companies: Fair value based on quoted net asset values of the shares held by the Plan.

Deferred variable annuity contracts: The Plan's units of participation are valued using net asset value of the underlying pooled separate account investments as a practical expedient, as reported by the investment manager. See Note 4 for additional information on these contracts.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan presents in the statements of changes in net assets available for benefits the net appreciation in fair value of investments, which includes unrealized and realized gains and losses on investments that were held or sold during the year.

Purchases and sales of securities are recorded on a trade date basis. Dividend income is recognized on the ex-dividend date. Interest income is recorded on the accrual basis.

Payment of Benefits – Benefits are recorded when paid.

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of net assets at the date of the financial statements and the reported amounts of changes in net assets during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties – The Plan provides for various investment options. Investment securities are exposed to various risks, such as interest, market and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

Subsequent Events – Management has evaluated the effects of all subsequent events through October 10, 2025, the date the financial statements were available to be issued, to determine if events or transactions occurring through that date require potential adjustment or disclosure in the financial statements.

3. FAIR VALUE MEASUREMENTS

The Plan uses fair value measurements to record fair value adjustments to certain assets and to determine fair value disclosures. For additional information on how the Plan measures fair value, refer to Note 2 – Summary of Significant Accounting Policies. The following table sets forth, by level within the fair value hierarchy, the Plan’s assets that are measured at fair value as of December 31, with the exception of the deferred variable annuity contracts, which are measured at fair value using the net asset value practical expedient.

The fair value for the deferred variable annuity contracts is provided below to permit reconciliation of the fair value hierarchy to the amounts presented in the statements of net assets available for benefits.

4. CONTRACTS WITH INSURANCE COMPANIES

The Plan has entered into a series of deferred variable annuity contracts with Guardian Insurance & Annuity Company (“Guardian”). These contracts represent an investment option which provides a guaranteed annuity payment at retirement with the opportunity for market growth. Various contract riders may be added to provide different guaranteed levels of growth or death benefits for a fee.

As disclosed in Note 2, these contracts are held in underlying pooled separate account investments, which are recorded at net asset value as a practical expedient. However, withdrawals from the account within seven (7) years of deposit may be subject to a sliding surrender charge, from 8% to 3%. At December 31, 2024 and 2023, the cash surrender value of these contracts is \$220,795 and \$198,180, respectively, compared to the net asset value of \$223,544 and \$200,642, respectively.

5. TRANSACTIONS WITH PARTIES IN INTEREST

Certain Plan investments are held in deferred variable annuity contracts managed by The Guardian Insurance & Annuity Company, Inc. (“Guardian”), one of the custodians of the Plan. In addition, certain Plan investments consist of mutual funds and a money market fund managed by The Vanguard Group, Inc., the recordkeeper of the Plan. Further, The Vanguard Group, Inc. has entered into an agreement with Ascensus, LLC (“Ascensus”), an affiliate of one of the custodians of the Plan, to provide certain administrative services on its behalf. Therefore, these transactions and account balances qualify as a party in interest.

The Plan incurs various management fees for its investments in registered investment companies and deferred variable annuity contracts. These costs are not reflected separately, but are included in the net investment return of these investments.

5. TRANSACTIONS WITH PARTIES IN INTEREST (continued)

An asset-based fee is deducted from participant accounts quarterly to cover costs of plan administration, including recordkeeping and Plan investment advisory services. Other direct expenses paid from the Plan assets include loan initiation and withdrawal fees deducted from the respective participant accounts. In addition, various riders, surrender charges and other fees were incurred related to the deferred variable annuity contracts.

6. INCOME TAX STATUS

The Plan is qualified pursuant to Section 401(a) of the IRC and, accordingly, the related trust's net investment income is exempt from income taxes. The Plan has obtained a favorable tax determination letter from the Internal Revenue Service dated June 30, 2020. The Plan has been amended since receiving the determination letter. However, the Plan Sponsor believes that the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC. The Plan Sponsor is not aware of any course of action or series of events that have occurred that might adversely affect the Plan's qualified status.

7. CERTIFIED INVESTMENT INFORMATION

The following is a summary of the unaudited information regarding the Plan, included in the Plan's financial statements and supplemental schedule. The information was prepared by Ascensus, as agent for Ascensus Trust Company, and Guardian, custodians of the plan, and furnished to the Plan Sponsor. Ascensus and Guardian have certified that the following information is complete and accurate:
