1. Plan Description

The following brief description of the Baxter Auto Welfare Benefits Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined benefit health and welfare plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was established to provide health benefits covering substantially all active employees of Baxter Shares Services, LLC and its Affiliates (the Sponsors). The restated Plan was effective January 1, 2023, and the related Baxter Auto Welfare Benefits Trust (the Master Trust) was established effective January 1, 2023.

Benefits

The Plan provides self-insured health benefits (dental, vision, and FSA) to eligible participants and covered dependents. Employees are eligible to participate on the first day of the month following the employee's date of hire or change to an eligible status. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA). Benefits are recorded when paid.

Contributions and Funding Policy

The Plan's benefit payments, premiums and other costs are funded through a combination of employer and participant contributions. Participants pay an annually pre-determined premium for coverage. The Sponsors pay the cost of the coverage in excess of the employee contributions on an as needed basis to ensure claims, premiums, and administrative expenses are paid.

Other

Although they have not expressed any intention to do so, the Sponsors have the right under the Plan to modify the benefits provided and to terminate the Plan subject to the provisions set forth in ERISA.

Upon termination of the Plan, claims incurred prior to the termination date will be settled. The remaining or deficient funds, if any, will be returned to or paid by the Sponsors.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting and in conformity with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amount of assets, liabilities, benefit obligations and changes therein, claims incurred but not reported, claims payable, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investments

Investments are stated at fair value. Fair value is the price that would be received to sell an investment in an orderly transaction between market participants at the measurement date. See Note 5 for further discussion of fair value measurements.

Interest income is recorded when received.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

Expenses

Claim administration fees are paid by the Plan.

Subsequent Events

Subsequent events are events or transactions that occur after the statement of net assets available for benefits date but before the financial statements are available to be issued and may require potential recognition or disclosure in the financial statements. Management has considered such events or transactions through October 8, 2025, noting no items requiring disclosure.

3. Interest in Master Trust

The Plan's investment assets are held in a trust account at First National Bank of Omaha (FNBO) and consist of an interest in an investment account of the Master Trust, which is a master trust established by the Sponsors and administered by FNBO. Use of the Master Trust permits the commingling of trust assets of the Baxter Auto Health Plan 511, Baxter Auto Health Plan 512, Baxter Auto Health Plan 513, Baxter Auto Health Plan 514 (related parties, see Note 7) and the Plan for investment and administrative purposes. The investment income of the investment assets and the administrative expense directly related to the trust accounts are allocated to each participating Plan based on the relationship of each interest of each individual Plan to the total of the interests of the participating Plans.

4. Benefit Obligations

Plan benefit obligations as of December 31, 2024 and 2023, for health claims incurred by active participants and their covered dependents, reported at that date to the plan administrator or claims processor have been accrued and recorded as health claims payable in the accompanying statements of plan benefit obligations. Also, plan benefit obligations for health claims incurred by active participants, and their covered dependents, but not reported as of December 31, 2024 and 2023, have been reported in the accompanying statements of plan benefit obligations as estimated by the Sponsors taking into consideration prior claims history and the expected time period from the date such claims are incurred to the date that the related claims are submitted and paid.

5. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs, other than quoted prices, that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Money Market Fund: Valued at the daily closing price as reported by the fund.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

7. Related Party Transactions

During the years ended December 31, 2024 and 2023, the Plan received upfront funding (from a Sponsor) of \$10,000 and \$20,000, respectively, for the Plan’s funding of claim payments and administrative expenses. At December 31, 2024 and 2023, the payable to this sponsor was \$30,000 and \$20,000, respectively, and is included in other payables in the accompanying statements of net assets available for benefits.
