## INDEPENDENT AUDITOR'S REPORT

To the Benefits Committee and participants of the  
Elekta, Inc. 401(k) Savings Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of the Elekta, Inc. 401(k) Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements (the financial statements).

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section of the report,

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP); and
- the certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

### 1. Description of Plan

The following description of the Elekta, Inc. 401(k) Savings Plan (the Plan) provides only general information. Participants should refer to the Plan document, copies of which are available from the plan administrator, for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan covering substantially all full-time employees and part-time employees who worked over 1,000 hours for Elekta, Inc. (the Company or Sponsor) and certain other affiliated companies, as defined by the Plan document. Employees may enter the Plan on the first day of the month following their date of hire. Effective January 1, 2024, the Plan was amended to remove the 1,000 hours requirement and allow all eligible employees to participate immediately. Effective November 1, 2024, the Plan was amended to allow self-employed individuals to participate and change the entry date to daily for all contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### Contributions

Each participant may make pre-tax and/or Roth contributions of up to 50% of eligible compensation as defined by the Plan document, generally not to exceed \$23,000 in 2024 plus additional catch-up contributions of up to \$7,500 for those participants who have attained age 50 by the end of the Plan year. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

The Plan provides for discretionary matching and profit-sharing contributions. The discretionary matching contributions include discretionary per payroll match contributions and a discretionary annual true-up match contribution. For 2024, the discretionary matching contributions were 100% of amounts contributed by participants, up to 5% of eligible compensation. The Sponsor did not make a discretionary profit-sharing contribution in 2024.

#### Participant Accounts

Each participant's account is credited with the participant's contributions, rollovers, the Sponsor's contributions, and earnings and losses on the investments in their account and is charged with certain administrative expenses. Upon enrollment in the Plan, a participant may direct any contributions to any of the investment options offered by the Plan. Participants may change their investment options on a daily basis. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **Vesting**

Participants are immediately vested in their contributions plus actual earnings or losses thereon. Vesting in the Sponsor's discretionary annual matching and profit-sharing contribution portion of their accounts is based on years of continuous service. A participant is 50% vested after completion of two years of service, and 100% vested after three years of service. In the event of death, disability, early retirement, or attainment of normal retirement age while employed with the Company, a participant will become 100% vested in the Sponsor's contribution portion of their account.

### **Notes Receivable from Participants**

Participants may borrow from their account a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. A participant may have two notes outstanding at any time. The notes are secured by the balance in the participant's account. During 2024, notes receivable had fixed rates ranging from 4.25% to 9.50% for the term of the note, not to exceed 5 years, or 15 years if used for the purchase of a residence. Principal and interest are paid through payroll deductions. Notes receivable from participants also qualify as party-in-interest transactions.

### **Payment of Benefits**

At the time of death, disability, termination of service or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. If the value of the vested interest in the account is \$5,000 or less, the account will be cashed out by distributing the vested interest in the account in a single-sum payment or by direct rollover to an IRA or other eligible retirement plan as soon as reasonably practicable. The participant's vested amount may also be withdrawn for in-service distributions upon reaching age 59½ or for certain hardship situations.

### **Forfeited Accounts**

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$801 and \$48,211, respectively. These accounts may be used to pay administrative expenses of the Plan or to reduce employer contributions. In 2024, the Sponsor used \$165,037 to reduce employer contributions. No forfeitures were used to pay Plan administrative expenses during 2024.

### **Administrative Expenses**

The Plan document permits certain administrative expenses to be paid by the Plan. All other expenses are paid by the Sponsor. The Sponsor does not expect reimbursement from the Plan for these expenses. Administrative fees paid by participants include loan initiation fees and distribution fees. Additionally, participants are charged a fee based on the balance in their accounts for investment management and administrative services. These fees are netted with

investment returns in each participant's account. These expenses are paid to a service provider of the Plan and therefore qualify as party-in-interest transactions.

The Plan has an ERISA account where the qualified institution deposits revenue sharing payments that can be used to pay administrative expenses or allocated to participant accounts. In 2024, \$200,238 was deposited into the revenue sharing account. During 2024, \$100,104 was allocated to eligible participants and \$100,134 was used to pay administrative expenses. Deposits to this account are included in net change in fair value of investments in the accompanying statement of changes in net assets available for benefits. At December 31, 2024 and 2023, the balance in this account was \$605 and \$575, respectively, which is included in mutual funds on the statements of net assets available for benefits.

## 2. Summary of Significant Accounting Policies

### Basis of Accounting

The financial statements of the Plan are presented on the accrual basis of accounting.

### Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates, and such differences may be material to the financial statements.

### Contributions

Participant contributions are considered payable to the Plan upon the withholding of contributions from the participant's paycheck. The Sponsor discretionary matching and the discretionary profit-sharing contributions, if any, are considered payable to the Plan upon approval of the Sponsor. Any unfunded participant or Sponsor matching contributions are included in the participant or employer contributions receivable on the statements of net assets available for benefits as of December 31, 2024 and 2023.

In accordance with Financial Accounting Standards Board's Accounting Standards Codification 326, *Financial Instruments—Credit Losses*, the Plan estimated the current credit risk associated with the employer contributions receivables. After giving consideration to the risk characteristics, including historical payment experience, the Plan determined that no allowance for credit loss was necessary as of December 31, 2024 and 2023, and there was no activity in the allowance for credit losses during 2024.

### Valuation of Investments and Income Recognition

The Plan's investments are stated at fair value except for the stable value fund, which is stated at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Net change in fair value and contract value of investments includes interest, dividends, and realized and unrealized gains and losses on those investments. Interest income is recorded when received.

### Notes Receivable from Participants

Notes receivable from participants are carried at their outstanding balance. Interest income on the notes receivable is recognized when received by the Plan, primarily monthly. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make note repayments and the plan administrator deems the note to be in default, the participant's note receivable balance is reduced, and a benefit payment is recorded.

### Payment of Benefits

Benefits are recorded when paid.

### Subsequent Events

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through October 7, 2025, which is the date the financial statements were available to be issued.

### 3. Information Certified by the Qualified Institution

All information in the accompanying financial statements and supplemental schedule, including investments held and notes receivable from participants as of December 31, 2024 and 2023, and the net change in fair value and contract value of investments and interest on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by T. Rowe Price Trust Company (T. Rowe Price), the Plan's qualified institution.

### 4. Investments

Plan investments include mutual funds, certain units in common/collective trusts, and a stable value fund managed by T. Rowe Price. T. Rowe Price is a service provider for the Plan; therefore, transactions in these investments qualify as party-in-interest transactions. Fees

incurred by the Plan for investment management services are included in net change in fair value and contract value of investments as they are paid through revenue sharing, rather than a direct payment.

Investments are exposed to several risks, such as interest rate, market, currency, and credit risks. Market risks include U.S. and global events which could impact the value of Plan investments. Such events would include healthcare crises, such as a pandemic, international conflicts, supply chain disruptions, global monetary policy decisions, significant exogenous economic influences, significant cybersecurity attacks, and other similar events. It is at least reasonably possible that changes in fair value will occur in the near term and that such changes could materially affect participants' account balances.

The Financial Accounting Standards Board established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value into three levels. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities, and the lowest priority to unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 – unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access

Level 2 – other observable data, including quoted prices for identical assets in inactive markets

Level 3 – unobservable inputs

Observable inputs are those based on market data obtained from sources independent of the Plan, and unobservable inputs reflect the Plan's own assumptions based on the best information available. The input levels are not necessarily an indication of the risk or liquidity associated with financial instruments at that level but rather the degree of judgment used in determining those values.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Investments in mutual funds are stated at quoted market prices for the identical security in an active market (Level 1).

Fair value of the common/collective trusts is determined by prices published daily by the trust manager, which is the NAVs of the common/collective trusts (Level 1). Net asset value is determined by the fair value of the mutual funds, stocks, and other securities in the common/collective trusts. Participants can trade the common/collective trusts daily at the published NAV.

The Plan invests in a stable value fund held in a common/collective trust. The stable value fund invests in fully benefit-responsive guaranteed investment contracts (GICs), which are general obligations of the insurance companies that issue the contracts, as well as synthetic GICs. The stable value fund trades at the net asset value (NAV), which is based on the contract value of the underlying investments. Participants transact at NAV daily in an active market. Contract value approximates fair value. The stable value fund includes certain redemption restrictions. If the Plan chooses to redeem all or a significant portion of the stable value fund, the issuer may require a 12-month wait period to redeem.

### 5. Plan Termination

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Upon termination of the Plan, all participants would become fully vested in their account balances.

### 6. Income Tax Status

The Plan uses a prototype plan document prepared by T. Rowe Price Retirement Plan Services, Inc. The Internal Revenue Service has provided an opinion letter dated August 19, 2020 stating that the prototype plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has not obtained an individual determination letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. The Plan's income tax returns for the past three years are subject to examination by taxing authorities and may change upon examination.
