We further certify that, in our opinion, the actuarial assumptions, methods and techniques used (a) in the aggregate are reasonable and (b) in combination represent our best estimate of the anticipated experience under the plan. To the best of our knowledge, the report is complete and accurate and the information presented herein, in our opinion, fully and fairly disclosed the actuarial position of the Plan.
