- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter—Plan Mergers

As discussed in Note 1 to the financial statements, the American Guardian Warranty 401(k) Plan, TSD 401(k) Plan and Opus VTR 401(k) Plan were merged into the Reynolds and Reynolds Company 401(k) Savings Plan effective March 1, 2024, November 15, 2024, and August 1, 2024, respectively, which was also the date all plan assets were transferred to the Reynolds and Reynolds Company 401(k) Savings Plan. Our opinion has not been modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and, therefore, is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audits.

Other Matters—Supplemental Schedule Required by ERISA

The supplemental schedule, Schedule H, line 4i—schedule of assets (held at end of year), as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Notes to Financial Statements

Note 1. Description of Plan

The following description of The Reynolds and Reynolds Company 401(k) Savings Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering substantially all employees of Universal Computer Systems Holding, Inc. and subsidiaries (the Company, the Employer or Plan Sponsor). Such employees are immediately eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended.

Plan Mergers: Effective March 1, 2024, November 15, 2024, and August 1, 2024 the Plan was amended to approve the mergers of the American Guardian Warranty 401(k) Plan, TSD 401(k) Plan, and Opus VTR 401(k) Plan into the Plan, respectively. The transfer of the related plan assets of \$22,477,816 is reported on the financial statements for the year ended December 31, 2024.

Administration: The Plan is administered by the Company. Empower Trust Company, LLC serves as the Plan trustee and record keeper.

Contributions: Eligible employees may contribute from 1% to 80% of their earnings through tax-deferred and or Roth payroll deductions. The Company contributes an amount equal to the first 6% of a participant's contribution to the Plan. Additionally, in 2024, the Company made a non-elective employer contribution to the Plan of \$5,749,951.

Employees are automatically enrolled in the Plan at a default contribution rate of 6%, which is invested in the retirement income fund appropriate for the participant's age. Participants will automatically increase contribution rate 1% each year to a maximum of 15%. Employee may opt out of this automatic election, and automatic increase, or choose to change their deferral percentage.

Rollovers: The Plan allows rollovers received by a participant as a distribution from another qualified plan after approval from the Plan Sponsor. Participants are fully vested in these amounts.

Participant accounts: Participants may invest their account balances in any of the investment options offered by the Plan. Each participant's account is credited with the participant's contribution and his or her proportionate share of the Company's contributions and the Plan's earnings. Allocations are based on daily valuation accounting, as provided in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting and distributions: Participants are 100% vested in Company contributions upon the completion of two years of eligible service. Employee contributions are 100% vested at all times. A participant who has reached the age of 59½ may elect to withdraw all or a portion of his or her vested account balance.

Participants may also apply for hardship withdrawals from their vested tax-deferred contribution accounts, subject to approval by the Plan Sponsor.

Notes receivable from participants: Participants may borrow from their vested accounts. The maximum loan amount is defined in the Plan document and, in any case, cannot exceed the lesser of \$50,000 or 50% of the participant's vested account balance, and the repayment period shall not exceed five years (unless proceeds are used to acquire a principal residence). A loan to a participant is funded by a reduction of the participant's 401(k) account and is prorated based on the current balance of each respective fund. Each loan is collateralized by the remaining balance in the participant's account.

Note 1. Description of Plan (Continued)

Interest charged to participants is based upon prevailing interest rates for similar loans in the surrounding community. Interest on the loan is paid back directly into the participant's account. Interest rates on participant loans ranged from 2.53% to 9.50% as of December 31, 2024 and 4.25% to 9.50% as of December 31, 2023. Loan repayments are made through payroll deductions but can be repaid in full at any time.

Forfeited accounts: Funds that are forfeited by participants are transferred to a forfeiture holding account. The forfeiture holding account is used to offset Company contributions or Plan expenses. The account is also used to rebuild a rehired participant's account if the ERISA break-in-service rules determine the participant is entitled to any previously forfeited funds. The balance of forfeited funds totaled \$109,892 and \$105,153 as of December 31, 2024 and 2023, respectively. Forfeitures totaling \$1,061,431 were used to reduce employer matching contributions for the year ended December 31, 2024.

Note 2. Summary of Significant Accounting Policies

Basis of presentation: The accompanying financial statements are prepared on the accrual basis in conformity with accounting principles generally accepted in the United States of America in accordance with the Financial Accounting Standards Board (FASB) Accounting Standards Codification.

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect certain amounts and disclosures reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Risks and uncertainties: The Plan provides for various investment options. These investment options are exposed to market risk, which generally means the risk of loss in the value of certain investment securities due to changes in interest rates, commodity prices and general market conditions. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the value of investment securities will occur in the near-term and such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Investment valuation and income recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. Capital gain distributions are included in interest and dividend income.

Payment of benefits: Benefits are recorded when paid.

Administrative expenses: The Plan and the Company both contribute in paying the Plan's administrative expenses.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent loans are treated as distributions based upon the terms of the Plan document.

Subsequent events: The Plan has evaluated subsequent events for potential recognition and/or disclosure through October 10, 2025, the date the financial statements were available to be issued.

Note 3. Information Certified by the Plan's Trustee

The information related to the Plan's assets that is included throughout the Plan's financial statements and supplemental schedule as of December 31, 2024 and 2023, and for the year ended December 31, 2024, was prepared by or derived from information provided by the trustee, Empower Trust Company, LLC and furnished to the Plan administrator. The Plan administrator has obtained certifications from the trustee that information provided to the Plan administrator by the trustee related to these Plan assets is complete and accurate.

Accordingly, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information in Note 4 and the supplemental schedule related to the Plan's assets.

The trustee also certified to the completeness and accuracy of \$100,040,996 of net appreciation in fair value of investments, \$12,840,210 of dividends related to investments and \$456,863 of interest income from notes receivable from participants for the year ended December 31, 2024.

Note 4. Fair Value Measurements

The Plan has determined the fair value of certain assets through application of accounting guidance that establishes a framework for measuring fair values. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value.

The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under this standard are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Note 4. Fair Value Measurements (Continued)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the closing price reported on the active market on which the individual securities are traded.

Self-directed brokerage accounts: Accounts primarily consist of mutual funds, common stock and money market funds. These investments use the valuation methodology of like investments within the Plan.

Pooled separate account: The daily unit values for the pooled separate account are calculated by the annuity provider according to the methods described in the annuity contract.

Common/collective trusts and stable value fund: Common/collective trusts are valued at the net asset value (NAV) of units of the collective trusts which are readily determinable fair value. The stable value fund is composed primarily of fully benefit-responsive investment contracts that is valued at the NAV of units of the collective trust. NAV is used as a practical expedient to estimate fair value and is based upon the fair value of the underlying investments comprising the trust less its liabilities. This practical expedient would not be used if it is determined to be probable that the fund will sell the investments for an amount different from the reported NAV.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Assets measured at fair value on a recurring basis: The following tables summarize assets measured at fair value on a recurring basis as of December 31, segregated by the level of the valuation inputs within the fair value hierarchy utilized to measure fair value:

Plan management evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits.

Note 5. Income Tax Status

The Internal Revenue Service has determined and informed the Company, by a letter dated April 17, 2017, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's legal counsel believe that the Plan was designed and operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The Plan administrator evaluated the Plan's tax positions and concluded that there are no uncertain tax positions that require recognition or disclosure in the financial statements. With few exceptions, the Plan is no longer subject to income tax examinations by tax authorities for years before 2021.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 7. Parties-In-Interest Transactions

Certain plan investments are managed by Empower Trust Company, LLC, the trustee as defined by the Plan; therefore, these transactions qualify as party-in-interest transactions under ERISA. Consequently, such transactions are permitted under the provisions of the Plan and are exempt from the prohibitions of party-in-interest transactions under ERISA. Fees paid by the Plan for trustee services amounted to \$889,967 for the year ended December 31, 2024.
