## INDEPENDENT AUDITOR'S REPORT

To the Plan Trustees of

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of Serve Electric 401(k) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Serve Electric 401(k) Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. **1. Summary of Significant Accounting Policies**

Basis of Accounting – The financial statements of Serve Electric 401(k) Retirement Plan (the Plan) are prepared under the accrual method of accounting.

Investments – Investments are reported at fair value, except for the fully benefit-responsive investment contracts, which are reported at contract value (see Note 9). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions – Contributions from Plan participants and the matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

Payment of Benefits – Benefits to participants are recorded when paid.

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Administrative Expenses – Administrative expenses are shown on the Statement of Changes in Net Assets Available for Benefits. This amount represents administrative costs paid to third party service providers for custodial, recordkeeping, and investment advisory services.

Risk and Uncertainties – The Plan provides for various investment options. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least probable that changes in values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

Subsequent Events – The Plan has evaluated events and transactions that occurred through October 9, 2025, which is the date the financial statements were available for issue.

**2. Plan Description**

The following description of Serve Electric 401(k) Retirement Plan is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. The Plan was amended and restated effective July 1, 2024, coinciding with its change in retirement plan service providers from Standard to Principal.

General – The Plan is a defined contribution plan covering substantially all employees of Serve Electric LLC (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility – Employees of the Company who have completed three months of service and are 18 years of age or older are eligible to participate in the Plan.

Contributions – Contributions to participants' accounts may be made through voluntary reductions in their compensation, rollover contributions from other qualified plans, as well as discretionary employer matching contributions. Employees participating in the Plan may contribute up to 100% of their total pay up to the limit in effect for the year (\$23,000 in 2024). Participants aged fifty or older may make an additional "catch-up" contribution (\$7,500 for 2024). The Plan includes an auto-enrollment feature provision whereby all eligible employees are automatically enrolled at a set deferral rate, unless they elect otherwise. Effective July 1, 2024, the automatic deferral rate was increased from 3% to 6% of eligible compensation. In 2024, the Company made matching contributions equal to 25% of the employee's deferral up to 6%.

Participant Accounts – Each participant's account is credited with the participant's contribution and an allocation of the (a) employer's contribution, (b) Plan earnings or loss, and (c) administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. All contributions are invested based on participant-directed investment programs.

Investment Options – Participants' accounts are self-directed within a limited number of investment options offered by the Plan. Participants may change their investment elections at their discretion.

Vesting – Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the portion of their accounts funded by employer's matching contributions plus earnings thereon is based on years of continuous service according to the following schedule:

Forfeitures – At December 31, 2024 and 2023, forfeited non-vested amounts totaled \$13,055 and \$3,155, respectively. This amount will be used to offset future employer contributions or to pay allowable costs of plan administration. For the year ended December 31, 2024, \$6,987 of forfeited accounts were used to offset employer contributions and \$5,147 were used to pay plan expenses.

Payment of Benefits – Participants or their beneficiaries may receive distributions of their account balances upon the earlier of reaching age 59 1/2, disability, death, or termination of service, as defined in the Plan. Further, the trustee may permit a participant who experiences a qualified financial hardship, as defined by the Plan, to receive a distribution of all or a portion of the participant's elective account balance. Distributions may be in the form of a single sum or partial payment, installments, or distributions in kind.

**3. Related Party and Party-In-Interest Transactions**

Certain Plan investments are managed by Reliance Trust Company and Principal Trust Company, the trustees, and therefore, these transactions are considered to be party-in-interest transactions. Fees paid by the Plan for investment management services are included as a reduction of the return earned on each fund. Certain administrative costs incurred by the Plan are paid by the plan sponsor. The Plan uses the staff, resources, and facilities of the plan sponsor to perform certain administrative activities related to the Plan. These transactions qualify as party-in-interest transactions.

**4. Tax Status**

The Plan obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

**5. Termination of The Plan**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**6. Certification of Financial Information**

The following information included in the accompanying financial statements and supplementary schedule as of December 31, 2024 and 2023, and for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company and Principal Trust Company: cash, investments at fair value, investments at contract value, dividends, interest, and net appreciation or depreciation in fair value of investments. Principal Trust Company held the Plan's investment assets and executed investment transactions from August 1, 2024 to December 31, 2024, and Reliance Trust Company held the Plan's investment assets and executed investment transactions as of December 31, 2023, and for the period January 1, 2024, to July 31, 2024.

**7. Nonparticipating Participant Account Balances**

Included in the net assets available for benefits at December 31, 2024 and 2023 are balances due to participants who had terminated employment with the employer, as such they are no longer participating. These accounts are payable on request.

**8. Fair Value Measurements**

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable input (Level 3 measurement). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include: 1) quoted prices for similar assets or liabilities in active markets, 2) quoted prices for identical or similar assets or liabilities in inactive markets, 3) inputs other than quoted prices that are observable for the asset or liability, 4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are op-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Pooled Separate Accounts:* Investments in shares of pooled separate accounts held with an insurance company are stated at estimated fair market value and are valued by the insurance company based on the net asset value of shares held by the Plan at year end. The net asset value is determined by the insurance company based on the market value of the underlying investments held in the pooled fund.

*Collective Trusts:* The fair value of participation units held in collective trust funds are based upon their net asset values as reported by the managers of the collective trust funds and as supported by the unit prices of actual purchase and sale transactions occurring as of or close to the financial statement date.

The preceding methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**9. Group Annuity Contracts**

The Plan had a fully benefit-responsive investment contract with Standard Insurance Company, which terminated during the year ended December 31, 2024, coinciding with the Plan's change in retirement plan service providers from Standard to Principal. Effective July 1, 2024, the Plan entered into another fully benefit-responsive investment contract with Principal Life Insurance Company. In accordance with these contracts, Standard Insurance Company and Principal Life Insurance Company, respectively, maintain the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1%, for the Standard Insurance Company contract, or zero, for the Principal Life Insurance Company contract. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

The contracts meet the fully benefit-responsive investment contract criteria and therefore are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. As of December 31, 2024, and 2023, the contract value of the fully benefit-responsive investment contracts was \$5,684 and \$294,494, respectively. Contract value approximates fair value.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the contract issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or a merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with the contract issuer and with participants are probable of occurring.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include the following: (1) an uncured violation of the Plan's investment guidelines, (2) a breach of a material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreements without the consent of the issuer.

**10. Prohibited Transactions**

During 2023, the Company failed to remit an employee contribution totaling \$86 to the Plan's trustee within the period prescribed by Department of Labor's regulations. The Company has made contributions to the affected participant's account to compensate the participant for the late remittance and potential lost income due to the delay.
