INDEPENDENT AUDITORS' REPORT

To the Plan Administrator of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Matthews International Corporation 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Note 1 - Description of the Plan:

The following description of the Matthews International Corporation 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

The Plan has been amended and restated effective January 1, 2023 to conform the Plan to new tax laws and some provisions were retroactively effective. With the amendment, provisions were updated regarding the calculation of safe harbor employer contributions. Instead of being calculated per pay period, the contribution amount will be based off of eligible participant compensation and employee withholdings for the plan year.

General

The Plan, established as of February 1, 1997, is a defined contribution plan covering all employees of Matthews International Corporation (the “Company”) who have begun employment and are not party to a collective bargaining agreement. It is subject to the provision of the Employee Retirement Income Security Act of 1974 (ERISA). The Pension Committee is responsible for oversight of the Plan. On December 31, 2024, the Plan had transferred the balances belonging to Schawk USA, Inc. employees to the Matthews International – SGK Group 401(k) Retirement Plan.

Contributions

Participants may contribute to the Plan through payroll deductions at a rate of 1 to 75 percent of their compensation not to exceed annual limits set by the tax laws. The limits for 2024 and 2023 are \$23,000 and \$22,500, respectively. Participants age 50 and over are eligible to contribute up to an extra “catch up” of \$7,500 in 2024 and 2023. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly-hired eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 2 percent of eligible compensation and their contributions invested in a designated balance fund until changed by the participant. The Company has implemented a "safe harbor" matching contribution where the Company will make contributions equal to 100% of participant salary deferrals that do not exceed 3% of eligible compensation, plus 50% of salary deferrals between 3% and 5% of eligible compensation for all plan participants. The Company may also make a discretionary contribution to all participants regardless of whether not they make pre-tax contributions.

Note 1 - Description of the Plan (continued):

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of the Company's contributions as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants

Participants may borrow from the vested portion of their accounts that may not exceed the lesser of \$50,000 or one-half of the total value of the vested portion of the participant's account. The participant loans are secured by the balance in the participants' accounts and bear interest at a rate which is commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest is paid ratably through payroll deductions.

Vesting

Participants are immediately vested in their elective deferrals, safe harbor contributions, rollover contributions, and earnings thereon. Participants who were members of the Schawk, Inc. Retirement Plan for Imaging Employees, Compass Engineering Group 401(k) Plan, Sheidow 401(k) Profit Sharing Plan, York Group, Inc. 401(k) Plan, and the Aurora Casket Company, LLC Retirement Savings 401(k) Plan prior to merging into the Plan on January 1, 2017 are subject to the vesting provisions of those respective plans prior to the merger date, see the plan document for the specific vesting provisions. Vesting in the Company's non-elective contribution portion of accounts in the Plan is based on continuous years of service. The vesting schedule is as follows as of December 31, 2024 and 2023.

Forfeitures

If a participant leaves the Company prior to the vesting period, the unvested employer contributions are retained by the Plan. The forfeitures can be used to pay Plan expenses, or used to reduce Company contributions. As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$1,267,765 and \$882,490, respectively. Also, in 2024, \$109,104 was used to reduce Plan expenses and \$104,363 was used to reduce Company contributions from forfeited nonvested accounts.

Note 1 - Description of the Plan (continued):

Payment of Benefits

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over a period of not more than the participant's or their beneficiary's assumed life expectancies. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Note 2 – Summary of Significant Accounting Policies:

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade- date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from the Plan participants and contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation and for which participant compensation is earned.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company and are excluded from the financial statements. Fees related to the administration of notes receivable from participants and benefit payments are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Consideration of Subsequent Events

The Company has acquired another organization which sponsored the Dodge Company Savings and Retirement Plan ("Dodge"). Effective September 2, 2025, Dodge was merged into the Plan.

For the year ended December 31, 2024, the Plan has evaluated the subsequent events for potential recognition and disclosure through October 7, 2025, the date the financial statements were available to be issued.

Note 3 – Certified Investments:

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest, interest income on notes receivable, and dividends for the year ended December 31, 2024, were derived from information supplied to the plan administrator and certified as complete and accurate by Great-West Trust Company, LLC, an agent of Empower Retirement.

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

Note 4 – Fair Value Measurements:

Financial Accounting Standards Board (*FASB*) Accounting Standards Codification (*ASC*) 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of fair value hierarchy under FASB ASC 820 are described below:

Level 1- Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.

Level 2- Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3- Inputs that are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a brief description of the valuation methodologies used for assets measured at fair value for the years ended December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 4 – Fair Value Measurements (continued):

Money Market Accounts: These investments are public investments vehicles value using \$1 for the net asset value (NAV). The money market funds are classified within Level 2 of the valuation hierarchy.

Common stocks: Valued at the closing price reported on the active market on which the individual securities are traded.

Pooled Separate Accounts: Valued by pricing determined by the custodian. The number of units are calculated to match the current fair market value of the underlying mutual fund holdings, known as utilizing the underlying assets. The units are adjusted daily to reflect investment results based on the quoted market prices of the underlying mutual funds for the accounts.

Common collective trust: Values based on the NAV of units of a collective trust as published by the trustee. The NAV is used as a practical expedient utilizing the net asset valuation to estimate fair value. The practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an account different for the reported asset value.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 – Related-Party Transaction and Party-in-Interest Transactions:

Certain Plan investments are managed by Empower Retirement. Empower Retirement is the trustee and record-keeper for the Plan, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the investment management services are included in net appreciation in fair value of the investments, as they are paid through revenue sharing, rather than a direct payment. The Plan also allows for loans to eligible Plan participants, which are secured by the participant's account balance are identified as party-in-interest transactions.

Note 6 – Plan Termination:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their entire account balance.

Note 7 – Tax Status:

The Internal Revenue Service has determined and informed the Company by letter dated June 30, 2020, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although, the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified.

Accounting principles generally accepted in the United States of America requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken any uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service (IRS).

The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

Note 8 – Risks and Uncertainties:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risks associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
