## **INDEPENDENT AUDITOR'S REPORT**

To the Plan Administrator, Trustees, and Those In Charge of Governance of **KMW Ltd. 401(k) Retirement Plan:**

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements**

We have performed an audit of the accompanying financial statements of KMW Ltd. 401(k) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of KMW Ltd. 401(k) Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. **A. Description of Plan**

The following description of KMW Ltd. 401(k) Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement or the Summary Plan Description for a more complete description of the Plan's provisions.

General

KMW Ltd. (the "Company") is the Plan sponsor and serves as the Plan administrator. The Plan is a defined contribution, tax-deferred retirement savings plan covering employees of the Company who are at least 18 years of age, with certain exceptions. Employees may begin participation in the Plan after completing six months of employment with the Company with at least 500 hours in the six-month period. Otherwise, an employee becomes eligible after completing one year of service. Entry dates are monthly following completion of eligibility requirements. Leased employees are exempt from participation in the Plan.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

After meeting eligibility requirements, employees are automatically enrolled in the Plan at a 6% contribution rate. Employees have the option to affirmatively select a different deferral percent or amount, including zero. The participant contribution rate automatically increases by 1% annually on the first day of the second plan year after the year in which the initial automatic deferral became effective, and on the first day of each subsequent Plan year up to a maximum of a 10% of compensation. All participants deferring less than the automatic schedule amount will be increased to the scheduled amount annually unless a new deferral election is made.

Participants may contribute up to 100% of compensation, not to exceed the maximum salary deferral limit and other limitations established by law. Compensation includes wages, tips and other compensation as reported on Form W-2 plus pre-tax deferrals and pre-tax contributions made to a qualified cafeteria plan, minus taxable fringe benefits, reimbursements, and certain other items as defined in the Plan documents.

Participants may elect deferral contributions as either pre-tax or Roth elective deferrals, or both. Participants who have reached age 50 before the end of the Plan year are eligible to make catch-up contributions as allowed by the Internal Revenue Code (IRC). Participants also may make rollover contributions of distributions from other retirement plans and certain individual retirement accounts, subject to Plan provisions. Participant contributions are invested according to direction of the participants.

The Company makes safe harbor matching contributions to the Plan equal to 100% of deferrals on the first 3% of compensation and 50% of deferrals on the next 2% of compensation. The safe harbor matching contributions are calculated and deposited into participant accounts each pay period. The computation period for safe harbor matching calculations is the Plan year. Company safe harbor matching contributions are invested according to direction of the participants.

Participant Accounts

Each participant's account is credited with the participant's contributions and the Company safe harbor matching contributions. Investment earnings, losses, and changes in market value are allocated based upon the investment experience of each holding in a participant account. Certain transactional costs and service charges, if any, are allocated to the specific accounts involved in the transaction or receiving the service. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their own deferral contributions, safe harbor matching contributions, rollover contributions, and earnings thereon. Participants vest in Company non-elective contributions and earnings under a five-year vesting schedule, as follows: 20% vesting after completion of one year of service, 40% vesting after completion of two years of service, 60% vesting after completion of three years of service, 80% vesting after completion of four years of service, and 100% vesting after completion of five years of service. Participants become 100% vested under certain other circumstances, including attainment of age 65, the Plan's normal retirement age. Non-vested balances are subject to forfeiture upon termination of employment.

Participant Loans

Participants who are active employees may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their nonforfeitable account balance, subject to certain other Plan provisions. A participant may have one loan outstanding at any point in time. Loans are secured by the balance in the participant's account and bear interest at the prime rate of interest plus 1%. Principal and interest are paid ratably through payroll deduction from each regular paycheck.

Payment of Benefits

Plan participants are eligible to receive benefit payments from the Plan at retirement, prior to retirement under certain circumstances, upon termination of employment with the Company, upon disability and at death. Hardship distributions are allowed under certain conditions. In-service distributions are allowed for participants beginning at age 65. Benefit payments may be elected as a lump-sum payment, a partial withdrawal for the purpose of meeting minimum distribution requirements, or as a life annuity. Terminated or deceased participants whose account balances do not exceed \$5,000 may be automatically distributed in the form of a lump sum payment or rollover.

Forfeitures

At December 31, 2024 and 2023, forfeited non-vested balances held in the Stable Value Fund were \$0 and \$0, respectively. Forfeitures may be used to offset employer contributions or pay plan expenses. Forfeitures totaling \$1,007 were used to offset employer contributions or pay plan expenses during 2024.

**B. Summary of Accounting Policies**

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

Preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are valued at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as those held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Notes receivable from participants are secured by vested participant account balances. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Payment of Benefits

Benefits payments are recorded when paid.

Expenses

Certain administrative expenses of the Plan are paid by the Company and are excluded from these financial statements. Per-use transaction fees are charged directly to specific participant accounts for certain services, such as processing loans, in-service withdrawals, distributions, and other transactions. Investment related expenses are included in net appreciation or depreciation of fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events for disclosure in these financial statements through October 14, 2025, the date the financial statements were available to be issued.

**C. Information Prepared and Certified by the Plan Trustee**

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. Accordingly, Nationwide Trust Company has certified as to the completeness and accuracy of reported investment balances and related investment activity in these financial statements and supplemental schedule as of December 31, 2024, and for the year ended December 31, 2024, summarized as follows:

**D. Fair Value Measurements**

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurement). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability. Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled separate accounts are valued per the unit value methodology, which is calculated based on the observable net asset values of the underlying investments. The value is a readily determinable fair value and is the basis for current transactions. The separate accounts held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following tables sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2024 and 2023. Assets are classified in their entirety based on the lowest level of input that is significant to the fair value measurement.

**E. Guaranteed Interest Contract**

The Fixed Select Option contract is a traditional guaranteed investment contract with Nationwide Life Insurance Company for which the contract value was \$530 and \$306 at December 31, 2024 and 2023, respectively. The Plan holds no synthetic investment contracts. Nationwide Life Insurance Company maintains the contributions in a general company account and is contractually obligated to repay principal and a specified interest rate to the Plan. The crediting interest rates at December 31, 2024 and 2023 were 1.49% and 1.97%, respectively.

The guaranteed investment contract meets the fully benefit responsive investment criteria and therefore is presented at contract value on the statements of net assets available for benefits. Contract value is the relevant measure for fully benefit responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Nationwide Life Insurance Company, represents contributions made under the contract, plus interest credited, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its financial obligations may be affected by future economic and regulatory developments. There are no reserves against contract value for credit risk of the contract issuer or otherwise. Certain events, such as Plan termination or merger, bankruptcy of the Plan sponsor, or premature cancellation of the contract may limit the ability of the Plan to transact at contract value with the issuer of the guaranteed investment contract.

**F. Related Party and Party-In-Interest Transactions**

Nationwide Life Insurance Company (Nationwide) is the Plan provider and receives fees for services. Under contract with Nationwide, SS&C Retirement Services, LLC provides recordkeeper and plan administration services and receives fees for services. Nationwide Trust Company, FSB (Trust Company) is a wholly owned subsidiary of Nationwide that provides directed trustee and custodial services to the Plan and receives fees for services. MAP Retirement, Inc. provides third party administrator services and receives fees for services. A financial advisor receives fees for services. The company provides the Plan with accounting and administrative services, for which no fees are charged to the Plan. The Plan allows loans to participants. These transactions qualify as party-in-interest transactions.

**G. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants become 100 percent vested in their accounts and the Company will arrange for distributions as soon as administratively feasible.

**H. Tax Status**

The Internal Revenue Service has determined and reported in its opinion letter dated June 30, 2020, that the form of the adopted pre-approved plan was then designed in accordance with applicable sections of the Internal Revenue Code (IRC) for use by employers for the benefit of their employees. The Plan administrator believes the Plan is currently being operated in compliance with applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. Management believes that no uncertain tax positions have been taken or are expected to be taken that would require recognition or disclosure in the financial statements.

**I. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances, and the amounts reported on the statements of net assets available for benefits.
