Summary of Significant Accounting Policies December 31, 2024 and 2023

Basis of Accounting

Owner Operator Services, Inc. Profit Sharing/401(k) Retirement Plan (Plan) presents its financial statements on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect the reported amounts of net assets available for Plan benefits and changes therein and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's administrative committee determines the Plan's valuation policies utilizing information provided by the Plan's investment advisor and trustee. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as investments held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent loans are treated as distributions based upon terms of the Plan document. Interest income on notes receivable from participants is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of administering and maintaining the Plan are paid directly by Owner Operator Independent Drivers Association (OIDA) and its affiliates (the "Companies") and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and payment of benefits are charged directly to the participants' accounts and are included in administrative expenses. Direct investment related expenses are included in administrative expenses, and indirect investment related expenses are included in net appreciation in fair value of investments.

1. Description of Plan

The following description of the Owner Operator Services, Inc. Profit Sharing/401(k) Retirement Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all full-time employees of the Companies. See eligibility requirements below. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan and related trust were established in 1989. The Plan's administrative committee is responsible for oversight of the Plan, determining the appropriateness of the Plan's investment offerings, and monitoring investment performance.

Contributions

Employees are eligible to participate in the Plan for employee salary deferrals on the first day of the month following two consecutive months of eligible service. A participant specifies the amount, not to exceed Internal Revenue Service (IRS) limits, of eligible compensation to be contributed to the Plan (employee salary deferral contributions). New participants are automatically enrolled in the Plan at a 10% employee salary deferral rate, unless they opt not to participate or to defer a different percentage of their salary. The Plan allows discretionary employer matching contributions. The employer may also make a discretionary profit sharing contribution each year, which is allocated to participants based on their earnings. Employees are eligible for discretionary employer matching contributions and discretionary employer profit sharing contributions beginning on the first of the month following 10 consecutive months of eligible service. Discretionary employer matching contributions of 50% of the first 10% of participant deferrals were made in 2024. There were no profit sharing contributions made in 2024. The total of the annual employee and employer contributions on behalf of each participant cannot exceed certain IRS limits. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (employee rollover contributions). Rollover contributions are not subject to contribution limitations.

Participant Accounts

Participants have the option of making contributions to any of the investment options available from the trustee or to an individual self-directed brokerage account. Changes to contribution amounts, allocation changes, and fund transfers can be done daily. Each participant's account is credited/charged with an allocation of the directed investment's earnings/losses based on the participant's account balance and credited with the following contributions:

- Employee's salary deferral contributions
- Employee's rollover contributions
- Discretionary employer matching contributions
- Discretionary employer profit sharing contributions

Vesting

Upon becoming a participant in the Plan, an individual is fully vested in the portions of his account attributable to employee salary deferral contributions and employee rollover contributions. Upon death, disability, attainment of normal or early retirement age, or Plan termination, a participant also becomes fully vested in his accounts attributable to discretionary employer contributions; otherwise, the participant becomes fully vested in the employer contribution accounts in accordance with the following schedule:

Payment of Benefits

On termination of service, participants can elect to receive distributions in lump-sum or installment payments. If a participant's benefits are \$1,000 or less, benefits will be paid in a lump sum automatically if no direction is given by the participant. Through December 31, 2023, if a participant's benefits are over \$1,000 and less than \$5,000, benefits will be rolled over into an individual retirement account for the participant, if no direction is given by the participant. Effective January 1, 2024, as part of SECURE Act 2.0, if a participant's benefits are over \$1,000 and less than \$7,000, benefits will be rolled over into an individual retirement account for the participant, if no direction is given by the participant. Under terms of the Plan, normal retirement age is the date the participant attains age 65 and early retirement age is the date the participant attains age 55.

Forfeitures

The forfeited nonvested balances totaled \$17 and \$8 at December 31, 2024 or 2023, respectively. Forfeitures of \$12,676 were used to pay administrative expenses in 2024. Forfeitures are used to pay administrative expenses and any remainder can be reallocated in future years among the remaining participant accounts in the same manner as employer profit sharing contributions. There were no forfeited nonvested accounts that were reallocated among the participant accounts in 2024.

Notes Receivable from Participants

Participants may borrow from their account up to the lesser of \$50,000 or 50% of their vested account balance and are only permitted to have one loan outstanding at any time. New loans must be for a minimum of \$1,000. Loan terms range from one to five years except loans for the purchase of a primary residence, which may be for a longer term. The loans are secured by the balance in the participant's account. The interest rates charged on loans are determined by Plan management and ranged from 4.25% to 9.50% at both December 31, 2024 and 2023. Principal and interest are paid ratably through payroll deductions.

Future Changes in Laws and Regulations

On December 29, 2022, the Consolidated Appropriations Act of 2023 was signed into law, which includes the package of retirement provisions referred to as "SECURE Act 2.0." These provisions continue the themes and reforms that began with the 2019 SECURE Act, focusing on getting more participants into the retirement system, finding ways for them to accumulate more assets, and then ensuring they get connected with those assets when retirement comes. Plan management is monitoring the SECURE Act 2.0 provisions and will implement mandatory provisions as they become effective and relate to the plan.

2. Information Certified by the Plan's Trustee

Certain information in the accompanying financial statements and ERISA-required supplemental schedule related to investments and notes receivable from participants held as of the date of the financial statements under audit and covered by the certification, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024 was obtained by management and agreed to or derived from information certified as complete and accurate by Ascensus, LLC (Ascensus), as agent for Ascensus Trust Company and Newport Trust Company, LLC, collectively the trustee.

3. Fair Value Measurement of Investments

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used to determine the fair value of investments. There have been no changes in the methodologies used at December 31, 2024 and 2023:

- Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
- Self-directed brokerage accounts: Consist primarily of interest bearing cash, common stocks, which are valued at the closing price reported on the active market on which the securities are traded, and mutual funds and exchange traded funds, which are valued at their NAV as described above under mutual funds.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period. For the year ended December 31, 2024, there were no transfers into or out of level 3.

Net appreciation in fair value of self-directed brokerage accounts totaled \$1,034,819 during the year ended December 31, 2024.

4. Party-in-Interest Transactions

The Plan incurred expenses of \$18,571 from the Plan's investment advisors during the year ended December 31, 2024. The Plan paid fees to recordkeepers totaling \$22,485 during the year ended December 31, 2024. The investment advisors and recordkeepers are considered parties-in-interest to the Plan. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

Additionally, notes receivable from participants are considered party-in-interest transactions.

5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination, participants would become 100% vested in their employer contributions.

6. Income Taxes

The Plan has adopted a non-standardized pre-approved profit sharing plan with Ascensus, which has received an opinion letter dated June 30, 2020 from the IRS indicating that the Plan, as then designed, was qualified for tax-exempt status under the appropriate sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the opinion letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes the Plan is qualified and tax-exempt as of the financial statement date and no provision for income taxes has been recorded in the financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

7. Risks and Uncertainties

The Plan allows participants to invest in various investment securities. Investment securities are exposed to various risks, such as interest rate, market fluctuation, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for Plan benefits and the statements of changes in net assets available for Plan benefits.

8. Subsequent Events

Management of the Plan has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued.
