Reasonable Cause Statement

Taxpayer sold all its assets in tax year 2024 and wound down its business. The taxpayer's 401(K) plan was terminated before year end which resulted in Form 5500 being a final return/report for a short year rather than the full year ended 12/31/24. Taxpayer extended Form 5500 based on an anticipated full year return being filed and anticipated filing by the extended October 15,2025 deadline. Taxpayer's H.R. person for handling the filing was hospitalized and was unable to attend to the filing. Taxpayer respectfully requests that any penalties under IRC sections 6652 and 6692 for any requirements under IRC section 6047, 6058 and 6059 and any other filing requirement be abated for reasonable cause and not due to intentional disregard or neglect. Taxpayer has filed all prior years in a timely manner and is filing by the 10/15/25 extended deadline for a full year return.
