Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Sunflower Medical Group, P.A. Profit Sharing 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). Basis for Opinion

NOTES TO THE FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF THE PLAN

The following description of Sunflower Medical Group, P.A. Profit Sharing 401(k) Plan (the "Plan"), provides only general information. Participants should refer to the Plan Document for a complete description of the Plan's provisions.

General – The Plan is a defined contribution plan covering substantially all employees of Sunflower Medical Group, P.A (the "Company"), except for leased employees, non-resident aliens and employees subject to a collective bargaining agreement. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan was established January 1, 1995.

Charles Schwab Bank is the Plan's custodian and North American KTRADE Alliance, LLC ("KTRADE") is the Plan's participant recordkeeper. Employees of the Company serve as Trustees of the Plan.

Eligibility – An individual is eligible to participate in the Plan after one year of service and attaining the age of 21. Plan entry dates are the first day of January and July.

Contributions – Participants may contribute up to 100% of their annual compensation, as defined in the Plan, subject to certain Internal Revenue Code ("IRC") limitations. Participants may also contribute amounts representing distributions from other qualified plans (i.e. "rollover contributions").

The Company makes a safe-harbor matching contribution equal to 100% of each participant's salary reduction contributions up to 3% of compensation, and 50% of such participant's salary reduction contribution for amounts over 3% up to 5% of compensation. The safe-harbor matching contribution is deposited into the trust each payroll.

The Company may also make a discretionary non-elective contribution. To receive an allocation of the non-elective contribution, a participant must be employed on the last day of the year, and have at least 1,000 hours of service. In 2024, the non-elective contribution was 3% of compensation, plus 3% of a participant's compensation in excess of \$135,048.60 (80.1% of \$168,600, the 2024 taxable wage base.) The discretionary non-elective contribution is deposited to the trust subsequent to year end.

Participants' Accounts – Each participant's account is credited with the participant's voluntary contribution, the employer contributions, and an allocation of investment earnings, and is charged with participant's withdrawals and distribution, and share of Plan expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Investment Options – Participants direct the investment of all contributions into various investment options offered by the Plan. The Plan currently offers mutual funds, a money market account, and self-directed brokerage accounts as investment options.

Vesting – Participants are immediately vested in their contributions and safe harbor contributions, plus actual earnings thereon. Vesting of the Company's discretionary non-elective contribution plus actual earnings thereon is based on years of continuous service. A participant vests in 20% increments, with 20% vested after 2 years of service. A participant is 100% vested after six years of service. In the event of permanent disability, death, reaching normal retirement age, or termination of the Plan, Company contributions become fully vested.

Forfeitures – Forfeitures occur upon termination of employment by a participant who is not fully vested in the Plan. Forfeitures may be used to either pay certain plan administrative expenses or as a reduction of employer non-elective contributions. During 2024, \$21,525 was used to reduce the non-elective contribution. As of December 31, 2024 and 2023, there were \$18,750 and \$10,049, respectively, of forfeitures available.

Payment of Benefits – Upon termination of service, the participant, or in the case of death, the participant's beneficiary, may elect to receive the vested value of the participant's account in a lump-sum. If the vested portion of the account balance is less than \$7,000, the participant's vested account balance will be automatically distributed if the participant does not elect to roll-over the balance to another qualified plan. Balances between \$1,000 and \$7,000 will be automatically rolled over to an IRA account.

In-Service Withdrawals – Certain participants may make withdrawals prior to termination of employment. Participants who have obtained the age of 59 ½ may elect to receive a distribution of all or any portion of their vested account balances in a single lump sum payment.

Notes Receivable from Participants – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The maximum loan term is 5 years, unless the loan is for the purchase of a home, in which case the maximum loan term is 15 years. The loans are secured by the balance in the participant's account, and bear interest at the Prime rate, plus 1%. A participant may have three loans outstanding at a time. Principal and interest are paid ratably through payroll deductions.

Other Income – Other income consists of revenue sharing credits of \$1,780. These funds are used to reduce administrative expenses.

Administrative Expenses – Plan fees and expenses, including fees and expenses connected with providing investment advisory and administrative services by external service providers are paid from Plan assets. Administrative expenses paid by the Plan totaled \$73,272 for 2024. The Company may pay other professional fees associated with the Plan.

Termination of the Plan – Although the Company has not expressed any intent to do so, it has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the Plan and under ERISA. Upon such termination of the Plan, participants will become 100% vested in their accounts.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting – The accompanying financial statements have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Contributions – Contributions are recorded in the year service is rendered by the participant.

Investments Valuation and Income Recognition – The Plan's Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Management fees and operating expenses charged to the Plan for investments in the mutual funds and the money market funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. No allowance for doubtful accounts is considered necessary.

Payment of Benefits – Benefit payments are reported in the year paid.

Date of Management's Review – Subsequent events have been evaluated through October 7, 2025, which is the date the financial statements were available to be issued, and there were no material events requiring adjustment or disclosure.

3. FAIR VALUE MEASUREMENTS

FASB ASC 820, *Fair Value Measurements*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs consist of unadjusted quoted prices for identical assets in active markets that the plan has the ability to access.

Level 2 – Inputs consist of 1) quoted prices for similar assets in active markets, 2) quoted prices for identical or similar assets in inactive markets, 3) inputs other than quoted prices that are observable, and 4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term.

Level 3 – Inputs consist of unobservable inputs where there is little or no market activity, and the reporting entity makes estimates and assumptions related to the pricing of the asset including assumptions regarding risk.

The assets fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds – Valued at the net asset value (NAV) of shares held by the plan at year end based on published quoted prices.

Money market fund – Valued at cost plus accrued interest, which approximates fair value.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. RISKS AND UNCERTAINTIES

The Plan invests in investment securities, which hold securities including U.S. Government securities, corporate debt instruments, and corporate stocks. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

5. INFORMATION CERTIFIED BY THE CUSTODIAN

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Charles Schwab Bank, the custodian of the Plan, has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate with respect to investments as of December 31, 2024 and 2023, and for the year ended December 31, 2024:

- Investments, at fair value
- Notes receivable from participants and related interest
- Interest and dividends
- Net appreciation in fair value of investments
- Schedule of Assets (Held at End of Year)

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

6. EXEMPT PARTY-IN-INTEREST TRANSACTIONS

A Plan investment is a money market fund managed by Charles Schwab Bank. Charles Schwab Bank is the custodian as defined by the Plan, and therefore, these transactions qualify as party-in-interest. The Plan pays certain fees to Charles Schwab Bank, KTRADE, and other service providers to administer the Plan. These transactions qualify as part-in-interest. Notes receivable from participants are party-in-interest transactions.

The Plan has a revenue-sharing agreement whereby certain investment managers return a portion of the investment fees to offset Participant's administrative expenses.

7. TAX STATUS

The Company has adopted a Prototype Non-standardized Pre-approved Profit-Sharing Plan with CODA which received a favorable opinion letter from the IRS on March 22, 2021, stating that the prototype plan and related trust are designed in accordance with the applicable sections of the IRC. The Plan has been amended since the date of the opinion letter. However, the Company believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and that, therefore, the Plan qualifies under Section 401(a) and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Generally accepted accounting principles requires Plan management to evaluate tax positions taken by the Plan and recognizes a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. PROHIBITED TRANSACTIONS

During the year ended December 31, 2024, employee deferrals and loan payments of \$15,048 were withheld from participants' payroll and not remitted to the trust by the plan sponsor on a timely basis (as defined by the Department of Labor "DOL"). The Plan Sponsor subsequently remitted all such deferrals to the trust and will contribute lost earnings to the affected participants. These transactions are prohibited according to the provisions of the DOL.
