Opinion

We have audited the accompanying financial statements of E.W. James & Sons, Inc. Employees Profit-Sharing and Stock Ownership Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits – liquidation basis as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits – liquidation basis for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

NOTE 1 – PLAN ADMINISTRATION AND DESCRIPTION

The following brief description of the E.W. James & Sons, Inc. Profit-Sharing and Stock Ownership Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

A. General

The Plan dated January 10, 1975, as amended and restated, covers substantially all employees. Each employee over the age of 21 will be eligible to participate in the Plan in the year during which the employee has completed one year of service. The entry date is the first day of such Plan year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

B. Contributions

Effective January 1, 2007 the employer froze all contributions to the Plan.

C. Participants’ Accounts

Each participant account is credited with allocations of any Employer contribution and the participant’s share of investment earnings and charged with an allocation of administrative expenses. Allocations of Employer contributions are based on participant salaries, and allocations of investment earnings and administrative expenses are based on participant beginning account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

D. Payments of Benefits

The Plan is designed to invest primarily in Employer stock. All purchases of the Employer’s stock shall be at a price not to exceed fair market value of such shares and may be acquired for cash or paid on an installment basis. The Employer did not contribute any shares to the Plan, as its employer contribution, for the years ended December 31, 2024 and 2023.

E. Vesting

Effective January 1, 2007, participants became 100% vested in their account balances.

F. Plan Termination

On August 17, 2023 the Board of Directors of E.W. James & Sons, Inc. adopted a resolution to terminate the Plan effective August 24, 2023. Distributions to participants will be made based on the December 31, 2022 stock valuation.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

The financial statements are prepared using the liquidation basis of accounting. Assets are valued at their estimated liquidation basis instead of fair market value.

B. Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

C. Payment of Benefits

Benefits are recorded when paid.

D. Administrative Fees

Expenses of the Plan may be paid by the Plan or the Employer. Administrative fees consist of fees for recordkeeping services provided by Blue Ridge Associates and fees for audit services provided by ATA, PC.

E. Subsequent Events

Subsequent events were evaluated through October 14, 2025, which is the date the financial statements were available to be issued.

NOTE 3 – INCOME TAXES

The Plan qualifies under Internal Revenue Code Section 401(a), and the trust is tax-exempt under Section 501(a) of the Internal Revenue Code (IRC). The Internal Revenue Service has determined and informed the Company by a letter dated May 20, 1999, that the Plan and related trust are designed in accordance with applicable sections of the IRC. The Plan has been amended since that date in order to remain in compliance with Internal Revenue Code revisions. Management believes the amendments would not affect the qualified status of the Plan and therefore, the Plan qualifies under Internal Revenue Code Section 401(a) and the trust is exempt from federal income taxes. The Company is required to file and does file Form 5500 with the Internal Revenue Service.

NOTE 4 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 5 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that the Plan can access.

Level 2 – quoted prices for similar assets in active markets, quoted prices for identical or similar assets in inactive markets, inputs other than quoted prices that are observable for the asset or inputs that are derived from or corroborated by observable market data by correlation or other means. If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset.

Level 3 – inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.
