We have performed audits of the financial statements of ChromaScape Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Notes to Financial Statements

Note 1. Description of Plan

The following description of the ChromaScape Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General: The plan was established on January 1, 2017. The Plan is a defined contribution plan sponsored by ChromaScape Holdings, LLC (the Company) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Each employee, with the exception of excluded employees as defined in the Plan document, is eligible to participate in the Plan following the completion of one month of service and attainment of age 21. Part-time employees are eligible for the plan if they have greater than 1,000 hours in a plan year. Once participants are eligible for the plan, they can enroll the first day of the following month and begin making participant deferrals and receive discretionary employer contributions. Participants direct the investments of contributions into various investment options offered by the Plan. The Plan currently offers several mutual funds and one guaranteed annuity contract as investment options.

Contributions: Participants may contribute to the Plan each year up to the maximum percentage of their compensation allowable on a pre-tax and after-tax basis not to exceed the limits imposed by the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan year are eligible to contribute additional catch-up contributions, as allowed under the IRC. Participants may increase or decrease their contribution amount at any time. Participants may also contribute amounts representing distributions from other qualified plans. During 2024, the Company's discretionary employer contributions were made in an amount equal to 50% of elective deferrals that do not exceed 6% of participant deferral. All contributions are invested in the investment options at the direction of the participant. Contributions are subject to certain limitations.

Participant accounts: Each participant's account is credited with the participant's contributions and an allocation of: (a) Company discretionary employer contributions, and (b) Plan earnings and losses. Allocations are based on participant compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately vested in their contributions plus actual earnings thereon. All other amounts credited to participants' separate accounts are vested under a 2-year cliff provision.

Investment options: Upon enrollment in the Plan, participants may elect to allocate contributions between the fund options available under the Plan in increments of 1%. If a participant does not elect a deferral percentage, the Plan has an automatic deferral percentage of 4%. The automatic deferral percentage will increase by 1% per year up to a maximum of 8% of compensation. Earnings on all funds, including appreciation and depreciation in the fair value of investments, are determined daily through published market sources for the registered investment companies or by the annuity provider for the guaranteed annuity contract. Participants may transfer account contributions on a daily basis and may transfer account balances in 1% increments on a daily basis.

If a participant does not make an investment option election, contributions are automatically allocated in accordance with the default investment alternatives established under the Plan. These default investments would be made in accordance with specific rules under which the fiduciaries of the Plan, including the employer, the custodian and the plan administrator, are relieved of any legal liability for any losses resulting from the default investments.

Notes to Financial Statements

Note 1. Description of Plan (Continued)

Notes receivable from participants: Participants may borrow a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their vested account balance. A participant is only permitted to have one loan outstanding at a time. The loan amount will process as a reduction of the elected investment funds on a pro-rata basis. Loan terms may extend from 12 to 60 months. The loans are secured by the balance in the participant's account and have a fixed interest rate equal to the prime interest rate at the time the loan is originated. As of December 31, 2024 and 2023, the prime interest rate was 7.50% and 8.50%, respectively. Principal and interest are paid ratably through payroll deductions.

Payments of benefits: A participant may receive the value of his or her vested account upon retirement, attainment of age 59 ½, disability or termination as a lump-sum distribution. Upon death of a participant, the beneficiary shall be entitled to the full value of the account. Hardship withdrawals, as defined in the Plan, are also available to participants.

Administrative expenses: Administrative expenses are paid by the Company, except for participant fees related to distribution and loan withdrawals, which are paid from the participants' accounts.

Plan termination: Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA.

Note 2. Summary of Significant Accounting Policies

Basis of accounting: The financial statements of the Plan are prepared under the accrual basis of accounting.

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make certain estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Investment valuation and income recognition: Investments are reported at fair value (except for fully benefit-responsive contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions: Contributions from Plan participants and the matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

Payment of benefits: Benefits are recorded when paid.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Note 2. Summary of Significant Accounting Policies (Continued)

Risks and uncertainties: The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Forfeitures: As of 2024 and 2023, forfeited nonvested accounts totaled \$22,590 and \$9,487 respectively. \$27,033 of forfeitures were used to pay plan expenses or reduce the employer contribution, as permitted by the plan, in the year the forfeitures were incurred or the following year. The amount of the accumulated forfeitures will be applied to pay expenses or reduce the employer contribution by the end of 2025.

Subsequent events: The Plan Administrator has evaluated subsequent events through October 14, 2025, the date on which the financial statements were available to be issued.

Note 3. Tax Status

The Plan has adopted a preapproved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the preapproved plan document was in compliance with applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since adopting the preapproved plan document; however, the Plan Administrator believes the Plan is designed, and is being operated, in compliance with the applicable requirements of the IRC.

Note 5. Fair Value Measurements

Financial Accounting Standards Board (FASB) guidance establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB Accounting Standards Codification (ASC) 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value.

Registered investment companies: Shares of registered investments companies are valued at quoted market prices which represent the net asset value (NAV) of the shares held by the Plan at year end.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 6. Guaranteed Annuity Contract With Insurance Company

The Plan has a guaranteed annuity contract investment contract with Empower. The contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses. The contract value of the investment contract at December 31, 2024 and 2023, was \$476,041 and \$527,968, respectively. Fair value approximates contract value at December 31, 2024 and 2023.

The contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 0% and is reset at least as frequently as annually.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuers' ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. Certain events limit the ability of the Plan to transact at contract value with the issuer. Examples of such events include the following:

1. The Plan's failure to qualify under Section 401(a) of the Internal Revenue Code.
2. The Plan's total investment in the contract falls below an amount specified in the contract.
3. Premature termination of the contract.
4. Plan termination or merger.
5. Changes to Plan's prohibition on competing investment of other Plan provisions that have an adverse effect on the investment.
6. Bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that significantly affect the Plan's normal operations.

Note 6. Guaranteed Annuity Contract With Insurance Company (Continued)

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

Note 7. Parties-in-Interest and Related-Party Transactions

Parties-in-interest are defined under United States Department of Labor Regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employers and certain others. During the year ended December 31, 2024, fees for these services were \$76,796.

The Plan invests in certain funds issued by Empower. The guaranteed annuity contract investment options were issued by Empower; therefore, these qualify as party-in-interest.

Note 8. Prohibited Transactions

During 2022, the Plan Sponsor inadvertently failed to deposit \$11,616 of participant contributions and loan repayments within the required time frame as stated by the United States Department of Labor regulations. The Plan Sponsor intends to deposit lost earnings to correct this failure in 2025. The Plan Sponsor will file Form 5330 and pay applicable excise tax to the IRS. The correction and any excise taxes, if applicable, will be made from the Plan Sponsor's assets and not from assets of the Plan.
