Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Wyatt, Tarrant & Combs, LLP Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

Notes to the Financial Statements

1. Description of the Plan

The following description of the Wyatt, Tarrant & Combs, LLP Profit Sharing Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan adoption agreement for more complete information.

General

The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as well as applicable sections of the Internal Revenue Code (IRC). The Plan became effective January 1, 1984, and was restated effective January 1, 2022. The Plan covers all eligible employees of Wyatt, Tarrant & Combs, LLP (the Plan Sponsor and Plan Administrator).

Eligibility

Eligible partners, employees, and shareholder employees of Professional Corporation Partners (Classification A) may make salary deferral contributions following the completion of one hour of service and attainment of age 21. Eligible participants can enter the Plan on the first day of the first payroll coinciding with or following the employee's first hour of service. Participants become eligible for employer discretionary profit sharing contributions after one year of service with a minimum of 1,000 hours worked. A participant will be considered as actively employed on the last day of the Plan year if employment terminated during the Plan year due to death, disability, or retirement after attainment of age 65.

Contributions

Participants may contribute up to the maximum allowable contribution, as defined by the IRC. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute Roth 401(k) elective deferrals on a post-tax basis, as well as amounts representing distributions from other qualified defined contribution plans. The Plan Sponsor may elect to contribute a discretionary profit sharing contribution, to be determined by the Plan Sponsor, not limited to current or accumulated net profits. The total contribution to a participant's account for the Plan year cannot exceed the maximum limit determined by Internal Revenue Service (IRS) regulations.

During the year ended December 31, 2024, the Plan Sponsor made a discretionary profit sharing contribution of 10% of earnings for those participants classified as equity partners and Classification A, and 5% of earnings for all remaining participants not classified in Classification A. The discretionary profit sharing contribution totaled \$1,679,336 for the year ended December 31, 2024.

1. Description of Plan, continued

Participant Accounts

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contribution, the Plan Sponsor's discretionary profit sharing contribution, an allocation of Plan earnings or losses, and administrative expenses. Allocations are based on participant earnings or account balances, as defined by the Plan adoption agreement. Administrative expenses are charged to each participant's account when a loan or a benefit distribution is processed.

Investment Options

Participants direct the investment of their contributions into various investment options offered by the Plan, including self-directed accounts. If no such direction is made, participant accounts are invested in accordance with default investment alternatives as established under the Plan. The Plan Sponsor's contributions are automatically invested in the same investment options at the same percentage as participant deferral contributions.

Benefits and Vesting

The benefit to which a participant is entitled is the benefit that can be provided from the participant's account, which includes participant and Plan Sponsor contributions and related earnings thereon. Earnings are allocated on a daily basis in the manner described above. Participants are immediately vested 100% in their contributions plus actual earnings thereon. Vesting in the Plan Sponsor's contribution portion of their accounts plus actual earnings thereon is based on years of continuous service as follows:

In addition, participants become 100% vested upon termination of service due to death, disability, or the attainment of normal retirement age as defined in the Plan adoption agreement.

Notes Receivable from Participants

Participants may borrow up to a maximum of the lesser of \$50,000 or 50% of their vested balance, reduced by the highest outstanding loan balance in the preceding 12 months, with a minimum of \$1,000. Loan terms can be up to 5 years for general purposes, or 20 years for the purchase of a residence. The loans are secured by the balance in the participant's account and bear interest at 1% over the Prime rate on the first business day of the month when the funds are borrowed. Principal and interest are paid ratably through payroll deductions.

Forfeited Accounts

All forfeitures are applied to Plan Sponsor discretionary profit sharing contributions. As of December 31, 2024 and 2023, unused participant forfeited accounts totaled \$4,294 and \$8,573, respectively. Forfeitures of \$20,648 were used to reduce employer contributions during the year ended December 31, 2024.

Revenue Credit Program

The Plan provides for a revenue credit program in connection with revenue sharing with certain investment managers. The amounts may be used to pay Plan expenses or allocated to eligible participant accounts. During 2024, the Plan received \$7,431 with the revenue credit program, which was placed in an ERISA account. During 2024, revenue sharing of \$13,276 was allocated to eligible participant accounts, and \$2,125 was transferred to the forfeiture account. There were no unused revenue credit program accounts at December 31, 2024. Unused revenue credit program accounts totaled \$7,415 at December 31, 2023.

Payment of Benefits

On termination of service due to death, disability, retirement, or other reasons, a participant whose vested account balance is greater than \$1,000 (excluding amounts attributable to rollover contributions) may elect to receive either a single lump sum amount equal to the value of the participant's vested interest in his or her account, roll it over into an Individual Retirement Account or other qualified retirement plan, or receive payments in equal installments. On termination of service, a participant whose vested account balance is not greater than \$1,000 (excluding amounts attributable to rollovers) will receive his or her benefits as a single lump sum payment.

Upon approval by the Fidelity Management Trust Company (Fidelity), the trustee of the Plan, participants may make hardship withdrawals. Hardship withdrawals are limited to the determined level of need not to exceed the vested account balance, with a minimum hardship distribution of \$1,000. Upon reaching the age of 59 1/2 or older, a participant may elect an in-service distribution from the vested portion of his or her account.

2. Summary of Significant Accounting Policies

The financial statements have been prepared in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) which require management to make estimates and assumptions that affect the reported amounts and disclosures in the financial statements. Actual results could differ from those estimates. The following is a summary of the significant accounting policies consistently followed by the Plan in the preparation of its financial statements:

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains or losses on investments bought and sold as well as held during the year. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the investment advisor or custodian.

Contributions

Contributions from Plan participants are recorded in the year in which the employee contributions are withheld from compensation.

Risk and Uncertainties

The Plan provides for participant directed investment options in various securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent loans are treated as distributions based on the terms of the Plan adoption agreement.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Certain administrative expenses of the Plan are paid by the Plan as provided in the Plan adoption agreement. All other administrative expenses are paid by the Plan Sponsor.

Subsequent Events

The Plan Sponsor has evaluated subsequent events for accounting and disclosure requirements through September 29, 2025, the date through which the financial statements were available to be issued.

3. Information Certified and Provided by Trustee

The Plan's asset information included in this note and throughout the Plan's financial statements and supplemental schedule was prepared by or derived from information provided by Fidelity, the trustee of the Plan, and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the trustee that asset information provided to the Plan Administrator by the trustee related to the asset information is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to asset information in this note and which appears throughout the financial statements and the ERISA-required supplemental schedule.

The trustee also certified to the completeness and accuracy of \$15,432,840 of net realized and unrealized appreciation in the fair value of investments, \$3,057,228 of interest and dividends related to the investments, and \$13,281 of interest income on notes receivable from participants for the year ended December 31, 2024.

4. Fair Value Measurement

The Plan classifies its investments based on a hierarchy consisting of: Level 1 (valued using quoted prices from active markets for identical assets), Level 2 (not traded on an active market but for which observable market inputs are readily available), and Level 3 (valued based on significant unobservable inputs). The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

4. Fair Value Measurement, continued

Following is a description of the valuation methodologies used for assets measured at fair value on a recurring basis:

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Self-directed accounts: Accounts consist of certificates of deposit, money market funds, common stocks, and mutual funds. Certificates of deposit and money market funds are valued at cost, which approximates fair value. Common stocks are valued at the closing price at the closing price reported on the active market on which the individual securities are traded. Mutual funds are valued at the daily closing price as reported by the fund.

Money market fund: Valued at cost which approximates fair value.

Collective trust fund: Valued based on the NAV of units of the collective trust fund. The NAV, as provided by the trustees, is used as a practical expedient to estimating fair value. The NAV is based upon the fair value of the underlying investments comprising the trust less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

These valuation methodologies may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period. 5. Exempt Party-in-Interest Transactions

Indirect fees are paid to the trustee based on investment account values; therefore, these transactions qualify as party-in-interest. For the year ended December 31, 2024, indirect fees paid to the trustee ranged from 0.02% and 0.86% of the investment account. The fees are included in net appreciation in fair value of investments on the statement of changes in net assets available for benefits.

Administrative expenses of \$54,759 for the year ended December 31, 2024 are comprised of fees paid by the Plan to third-party service providers for investment management services and withdrawal charges.

6. Tax Status

The Plan uses a volume submitter plan document sponsored by the Plan Sponsor. An opinion letter was received from the IRS, dated June 30, 2020, which states that the volume submitter plan document satisfies the applicable provisions of the IRC. The Plan itself has not received a determination letter from the IRS. However, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

7. Plan Termination

Although it has not expressed any intention to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become fully vested in their accounts.
