INDEPENDENT AUDITORS' REPORT

To the Plan Administrator
Aurora Casket Company, LLC Union Employees 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Aurora Casket Company, LLC Union Employees 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Aurora Casket Company, LLC Union Employees 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

Note 1 - Description of the Plan:

The following description of the Aurora Casket Company, LLC Union Employees 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Aurora Casket Company, LLC and subsidiaries (the "Company") under collective bargaining agreements with the International Brotherhood of Boilermakers, Iron Ship Builders, Blacksmiths, Forgers, and Helpers, AFL-CIO, Local Union No. M-300 (the "Boilermakers" union), and Chauffeurs, Teamsters, Warehousemen & Helpers, Local Union No. 135 (the "Teamsters" union). Employees are eligible to participate in the Plan upon completing 3 months of service. The Teamsters union is not eligible to receive employer matching contributions and, effective January 1, 2018, the Boilermakers union is no longer eligible to receive employer non-elective contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

Contributions

Participants may contribute to the Plan up to 100% of eligible compensation not to exceed annual limits set by the tax laws. The limits for 2024 and 2023 are \$23,000 and \$22,500, respectively. Participants age 50 and over are eligible to contribute an extra "catch up" of \$7,500 in 2024 and 2023. Participants may also contribute amounts representing distributions from other qualified defined contribution and benefit plans (rollover). Participants direct the investment of all contributions into various investment options offered by the Plan. The Company makes matching contributions to the Plan on the behalf members of the Boilermakers union as negotiated by their respective collective bargaining agreement and upon meeting certain service requirements as defined by the Plan document. The Company contributes 50 percent of each employee's contributions of the first 6 percent of base compensation that a participant contributes to the Plan. The Company can also make non-elective contributions on behalf of the Teamsters union as negotiated by their respective collective bargaining agreement and upon meeting certain service requirements as defined by the Plan document. The contribution amount will be a flat dollar amount approved by the Company. For 2024, the Company had approved a quarterly contribution of \$505 per eligible employee.

Note 1 - Description of the Plan (Continued):

Participant Accounts

Each participant's account is credited with the participant's and Company's contributions and a pro-rata allocation of the Plan's earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their account is based on the participant's union affiliation. Boilermaker union employees are immediately 100% vested in the Company contribution portion of their account. The Teamsters union employees vest in the Company contribution portion of their account based on continuous years of service. The vesting schedule for Teamsters union participants is as follows:

<u>Years of Vesting Service</u>	<u>Vesting Percentage</u>
1 Year	20%
2 Years	40%
3 Years	60%
4 Years	80%
5 Years or more	100%

Forfeitures

As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$12,338 and \$11,856, respectively. Forfeited balances of terminated participants' non-vested accounts can be used to restore participant accounts, pay Plan expenses, or reduce future employer contributions. During the year ended December 31, 2024, forfeited accounts of \$151 were used towards Plan expenses.

Payment of Benefits

On termination of service due to death, disability, retirement, a participant may receive a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over a period of not more than the participant's or their beneficiary's assumed life expectancies. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution.

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from the Plan participants and contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation and for which participant compensation is earned.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from the Plan's financial statements. Fees related to the administration of benefit payments are charged directly to the participant's account and are included in administrative expenses. Management fees and operating expenses charged to the Plan for investments are deducted from income earned on a daily basis and are not separately reflected. Consequently, these management fees and operating expenses are included in net appreciation of fair value of investments.

Consideration of Subsequent Events

For the year ended December 31, 2024, the Plan has evaluated the subsequent events for potential recognition and disclosure through October 6, 2025, the date the financial statements were available to be issued.

Note 3 – Certified Investments:

Certified information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Empower Retirement, an agent for Great-West Trust Company, Inc.

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedules.

Note 4 – Fair Value Measurements:

Financial Accounting Standards Board (*FASB*) Accounting Standards Codification (*ASC*) 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of fair value hierarchy under FASB ASC 820 are described below:

Level 1- Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.

Level 2- Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;

Note 4 - Fair Value Measurements (Continued):

- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3- Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a brief description of the valuation methodology used for assets measured at fair value at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission (SEC). These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Money Market Funds: These investments are public investments vehicles value using \$1 for the net asset value (NAV). The money market funds are classified within Level 2 of the valuation hierarchy.

Common collective trust: Values based on the NAV of units of a collective trust as published by the trustee. The NAV is used as a practical expedient utilizing the net asset valuation to estimate fair value. The practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported asset value.

Pooled separate accounts: Valued by pricing determined by the custodian. The number of units are calculated to match the current fair market value of the underlying mutual fund holdings, known as utilizing the underlying assets. The units are adjusted daily to reflect investment results based on the quoted market prices of the underlying mutual funds for the accounts.

Note 4 - Fair Value Measurements (Continued):

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 – Related-Party Transactions and Party in Interest Transactions:

Certain Plan investments are managed by Empower Retirement. Empower Retirement is the trustee and record-keeper for the Plan therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the investment management services are included in net appreciation in fair value of the investments, as they are paid through revenue sharing, rather than a direct payment. There were also identified delinquent participant contributions, which also represents a party-in-interest transaction.

Note 6 – Plan Termination:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their entire account balance.

Note 7 – Tax Status:

The Internal Revenue Service (IRS) has determined and informed the Company by a letter on June 30, 2020, that the Plan qualifies under the applicable provisions of the Internal Revenue Code (IRC) and therefore, is exempt from federal income taxes. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8 – Risks and Uncertainties:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risks associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
