## INDEPENDENT AUDITORS' REPORT

To the Trustee and Committee of  
24 Carrots Employee Stock Ownership Plan

### Opinion

We have audited the financial statements of 24 Carrots Employee Stock Ownership Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets (deficit) available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets (deficit) available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets (deficit) available for benefits of the Plan as of December 31, 2024 and 2023, and the changes in its net assets (deficit) available for benefits for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

### Emphasis of Matter

As discussed in Note 3, the financial statements include investments in employer securities that represent 100% of total assets as of December 31, 2024. The fair value of these securities has been estimated by an independent appraisal, in the absence of readily ascertainable fair values, with the assistance of management, and approved by the trustee. Because of the inherent uncertainty of the valuation, those estimated values may differ significantly from the values that would have been used had a market for the investments existed, and the differences could be material. Our opinion is not modified with respect to this matter.

### Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date of the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditors' Responsibilities for the Audit of the Financial Statements**

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and, therefore, is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. ### NOTES TO THE FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

#### NOTE 1 – Description of the Plan

The following description of 24 Carrots Employee Stock Ownership Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### *General*

24 Carrots Holding Company, Inc. and participating employers (the Company) established the Plan retroactively effective January 1, 2023. The Plan operates as a leveraged employee stock ownership plan (the Plan or ESOP) and is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code of 1986, as amended (the IRC), and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The ESOP is primarily designed to invest in the Company's common stock. In addition, the Plan includes a profit-sharing component, which holds assets not invested in employer securities and is not intended for use in repaying an exempt loan or for other purposes within the ESOP portion of the Plan.

On May 3, 2024, the Plan purchased 750,000 shares of common stock for \$18,060,000 from the Company's selling shareholders, which represented 100% of the Company's outstanding stock. The transaction was completed using \$2,000,000 in cash to purchase 83,056 shares and a note payable to purchase the remaining 666,944 shares. The note payable was reassigned from the Plan to the Company. After the reassignment, the Plan had a note payable (see Note 5) to the Company (ESOP loan) and holds the stock in a trust established under the Plan.

The ESOP loan is collateralized by the unallocated shares of the Company's common stock (Company stock). As the Plan makes payments of principal and interest on the ESOP loan, an appropriate percentage of the Company stock will be allocated to eligible participants' accounts in accordance with applicable regulations under the IRC. Once shares are allocated under the ESOP, the Company no longer retains any rights to those shares. Accordingly, the Plan's financial statements separately present the assets and liabilities pertaining to:

- The accounts of employees with vested rights in allocated common stock (allocated); and
- Common stock not yet allocated to employees (unallocated).

#### NOTE 1 – Description of the Plan (Continued)

##### *Administration*

The Plan is administered by the Committee, which is appointed by the Company's Board of Directors. Under the terms of the Plan, the Company has appointed an independent trustee (Trustee) and a third-party administrator. The third-party administrator processes and maintains the records of participant data. The Trustee administers each payment of principal and interest on the ESOP loan, which is reimbursed to the Trustee through contributions as determined by the Company. Expenses incurred for administering the Plan are paid by the Plan to the extent they are not paid by the Company.

##### *Eligibility*

Employees of the Company are eligible to participate in the Plan if they are at least 21 years of age and have completed one year of service in which they are credited with at least 1,000 hours. Eligible employees may enter the Plan on the first entry date following satisfaction of these requirements, which occurs on either January 1<sup>st</sup> or July 1<sup>st</sup>. Each employee as of December 31, 2023 was automatically eligible January 1, 2023. To receive an allocation of Company stock or contributions for a given plan year, participants generally must have completed at least 1,000 hours of service during the year and be employed on the last day of the plan year, unless termination of employment occurred due to retirement, death, or disability. Nonresident aliens with no U.S. source income, employees covered by a collective bargaining agreement, and leased employees are not eligible to participate in the Plan.

##### *Company Contributions*

The Company is obligated to make contributions in cash to the Plan which, when aggregated with the Plan's dividends and interest earnings, if any, equal the amount necessary to enable the Plan to make the regularly scheduled payments of principal and interest due on the ESOP loan. The Company may also make contributions to fund benefit payments to terminated or retired participants. For the plan year ended December 31, 2024 and 2023, the Company made a cash contribution of \$977,211 and \$2,000,000, respectively. Employee contributions are not permitted.

#### NOTE 1 – Description of the Plan (Continued)

##### *Dividends*

The Company may, in addition to its contributions to the Plan, contribute cash in the form of dividends. Such dividends may first be used to repay the ESOP loan. If there is no outstanding indebtedness with respect to the ESOP loan, the Company shall allocate dividends to participants. The Company did not contribute any dividends for the years ended December 31, 2024 and 2023.

##### *Participant Accounts*

The Plan is a defined contribution plan under which a separate individual account is established for each participant. As of the last day of each plan year, each participant's account receives an allocation of shares of the Company's common stock released by the Trustee from the unallocated account and forfeitures of terminated participants' non-vested accounts. On an annual basis a participant is awarded one point per year of service and one point per every \$10,000 of eligible annual compensation. On an at least annual basis, contributions, common stock, and forfeitures are allocated based on the ratio of the individual participant's points to the points for all participants in the Plan for that year, subject to allocation limits. Appreciation or depreciation in the value of Company stock is allocated to each participant's Company stock account based on the ratio of the participant's Company stock account balance to all participants' Company stock account balances.

##### *Payment of Benefits*

Distributions on account of death, disability, or attainment of the normal retirement age shall begin generally no later than the plan year following the plan year in which the event occurs. Distributions for other reasons for separation from service are offered no later than the sixth plan year following the plan year in which the participant terminated employment with the Company.

Vested account balances that are less than or equal to \$7,000 but greater than \$1,000 will be distributed as soon as administratively practicable. If a participant does not provide instructions, the amounts will be directly rolled over to an individual retirement account designated by the plan administrator.

#### NOTE 1 – Description of the Plan (Continued)

##### *Payment of Benefits (Continued)*

If the value of the vested account balance of a participant exceeds \$7,000, as of the distribution date, no portion of the participant's account may be distributed before the participant attains age 65 without written participant consent. Payments will generally be made in substantially equal payments, at least annually, over a period not to exceed five years, plus one year for each \$265,000 by which the value of the participant's vested account balance exceeds \$1,330,000, subject to annual cost of living adjustments.

##### *Diversification*

Participants who are at least age 55 and with at least 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25% of the number of shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changes to 50%. Participants who elect to diversify may transfer the eligible portion of his or her account balance directly to another qualified plan of the Company that accepts such transfers or may elect a distribution.

##### *Administrative Expenses*

As provided in the plan agreement, administrative expenses may be paid either by the Plan or by the Company. The Company has paid the operating expenses for the Plan for the years ended December 31, 2024 and 2023.

##### *Voting Rights*

In general, shares of Company stock are voted by the Trustee as further described in the plan document. With respect to certain corporate matters such as a merger, consolidation, recapitalization, liquidation, dissolution, or sale of substantially all assets of a trade or business, each participant is entitled to direct the Trustee as to the voting of shares of Company stock allocated to his or her account. In those matters, unallocated shares or participant shares without a proxy statement will be voted by the Trustee as directed by the Committee. The Trustee is required to vote all shares in a manner determined by the Trustee to be consistent with ERISA.

#### NOTE 1 – Description of the Plan (Continued)

##### *Vesting*

If a participant's employment with the Company ends for any reason other than attainment of normal retirement age, permanent disability, or death, he or she will vest in the balances in his or her account based on years of participation in the Plan. Participants are 20% vested after two years of service and are 100% vested after six years of service. Participant service prior to the Plan's effective date of January 1, 2023 is credited for vesting at a rate of one year of service credit for each five full years of continuous service prior to January 1, 2023.

##### *Put Option*

Under federal income tax regulations, the Company stock that is held by the Plan and its participants which is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The first put option period runs for a period of at least sixty days commencing on the date of distribution of the Company's common stock to the participant. The second put option period runs for a period of at least sixty days commencing on the first day after the new determination of the appraised value of the Company's common stock is made in the subsequent plan year. The Company can pay for the purchase with a lump-sum cash payment of the purchase price or an installment method together with interest over a maximum period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

##### *Forfeited Accounts*

Forfeitures represent the non-vested portion of a participant's account that is upon the participant's termination of employment after incurring a five-year break in service. The forfeitures shall be allocated to eligible participants as of the allocation date of the plan year in which the forfeitures occur. As of December 31, 2024 and 2023, there was no balance in the forfeited non-vested account as all forfeitures were used in the same year they were forfeited. During the year ended December 31, 2024, 2,808 forfeited shares were allocated to participants. There were no forfeitures during the year ended December 31, 2023.

#### NOTE 2 – Summary of Accounting Policies

##### *Basis of Accounting*

The financial statements of the Plan are prepared on the accrual basis of accounting.

##### *Use of Estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

##### *Allocations*

The financial statements of the Plan present separately the assets and liabilities and changes therein pertaining to (a) the accounts of employees with rights in allocated stock (allocated) and (b) stock not yet allocated to employees (unallocated), including shares that are committed to be released. Shares are released from collateral and become allocated generally in the period in which debt service is actually paid.

##### *Investment Valuation and Income Recognition*

Investments are reported at fair value. The fair value of the Company's common stock is determined at least annually by an independent appraisal. Fair value is the price that would be received to sell an asset or transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. Dividend income is accrued on the ex-dividend date and dividends on Company stock are recorded on the date declared. Purchases and sales of securities are recorded on a trade-date basis. Realized gains and losses from security transactions are reported using the specific identification method. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### *Payment of Benefits*

Benefits are recorded when paid.

#### NOTE 4 – Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under Topic 820 are described as follows:

**Level 1** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The preceding methods described may produce a fair value calculation that may not be indicative of net realized value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 – ESOP Loan

In May 2024, the Plan entered into a loan agreement with the Company for \$16,060,000. The proceeds of the loan were used to purchase shares of the Company's common stock. The Company's common stock acquired by the proceeds of the loan is pledged as collateral against the loan, less shares allocated to the Plan's participants. Shares are released from collateral and allocated to participants as payments of principal and interest are made on the loan. The number of shares released in any year is the number of shares held as collateral, times the ratio of the current year's payments, divided by the total of the current year's payments, plus all future years' principal and interest payments. The loan bears interest at a fixed rate of 4.55%, requires annual principal and interest payments of \$977,211, and matures December 2053. During the year ended December 31, 2024, 22,231 shares were released and allocated.

#### NOTE 6 – Related-Party Transactions and Party-in-Interest Transactions

The Plan invests in the Company's common stock and has an ESOP loan payable to the Company, which are considered related-party and party-in-interest transactions. As described in Note 1, the Company pays all plan expenses. The Plan has a number of service providers. Such providers are parties-in-interest under ERISA.

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation for these duties from the Plan.

#### NOTE 7 – Risks and Uncertainties

The Plan's investments consist primarily of the Company's common stock, which is exposed to various risks such as interest rate, market, and credit risks, as well as valuation assumptions based on earnings, cash flows, and/or other such techniques. Due to the level of risk associated with the investment in the Company's common stock and to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in the value of the Company's common stock will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets (deficit) available for benefits.

#### **NOTE 8 – Plan Termination**

The Company reserves the right to terminate the Plan at any time, subject to plan provisions. Upon termination of the Plan, the Committee directs the Trustee to pay all liabilities and expenses of the ESOP and to sell shares of financed common stock held as collateral to the extent it determines such sale to be necessary in order to repay the loan. Subsequently, the interest of each participant in the trust fund will be distributed to such participant or his or her beneficiary at the time prescribed by the plan terms and the IRC.

#### **NOTE 9 – Tax Status**

The Plan has received a determination letter from the IRS dated April 28, 2025, stating that the Plan is qualified under the IRC and, therefore, the related trust is exempt from taxation. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan administrator believes that the Plan is currently designed, and being operated, in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Company has taken an uncertain position that more likely than not would not be sustained upon examination by federal and state taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
