Independent Auditor's Report

Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of Dykema Gossett PLLC Savings & Investment Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023 and the related statement of changes in net assets available for benefits for the year ended December 31, 2024 and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024 stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the *Auditor's Responsibilities for the Audits of the Financial Statements* section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audits of the Financial Statements* section of our report. Note 1 - Plan Description

The following description of Dykema Gossett PLLC Savings & Investment Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all permanent employees and members of Dykema Gossett PLLC (the "Firm"), except for any member who owns or has owned at any time more than a 10 percent interest in the capital or the profits of the Firm. The Plan also covers temporary employees who have completed 1,000 hours of service during the calendar year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

The Plan provides for pretax employee salary 401(k) deferral contributions up to a maximum of 75 percent of the participant's annual compensation subject to deferral limitations established by the Internal Revenue Code. The Plan allows participants to elect to have any portion of their compensation contributed to the Plan as a Roth elective deferral in lieu of all or a portion of the before-tax contributions the participant is otherwise eligible to make. A participant who has attained the age of 50 before the close of the plan year can make additional catch-up contributions of up to \$7,500. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

At the discretion of the Firm's executive board, the Firm may contribute a matching contribution in an amount equal to a percentage of the total before-tax employee contributions made for the plan year (excluding catch-up contributions). There was no matching contribution for the year ended December 31, 2024. In addition, the Firm, at its discretion, may contribute a nonmatching profit-sharing contribution to certain allocation groups in the Plan, as defined in the plan document. For the year ended December 31, 2024, the Firm provided a profit-sharing contribution of \$6,487,510.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Firm's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. Each participant instructs the trustee as to the percentage of his or her account balance to be invested in the investment funds offered by the Plan.

Vesting

All participants are immediately fully vested in all employee deferrals, discretionary firm matching contributions, and discretionary firm profit-sharing contributions.

Benefit Payments

Distributions are payable upon retirement, death, disability, termination of employment, or attainment of 59½ years of age in the form of a lump-sum amount equal to the vested balance of a participant's account. The Plan also provides for in-service post-age 59½ distributions and profit-sharing in-service distributions at age 55.

Distributions payable upon retirement, death, disability, or termination of employment may be made in the form of monthly or annual installments.

Participants may request that all or a portion of their accounts be distributed in the case of financial hardship, as defined in the plan document.

Note 1 - Plan Description (Continued)

Participant Notes Receivable

Participants may borrow from their accounts up to the lesser of their account balances or \$50,000, reduced by the highest outstanding balance of plan loans during the one-year period prior to the date of the loan. The notes receivable must have a term no longer than five years and must bear a reasonable rate of interest comparable to that being charged by local financial institutions on loans of similar character. The notes receivable are collateralized by 50 percent of the participant's nonforfeitable account balance as of the date of the loan or, if the plan administrator otherwise determines to be appropriate, shall be collateralized by other collateral comparable to that customarily required by local financial institutions.

Termination

While it has not expressed any intent to do so, the Firm has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, Fidelity Management Trust Company shall distribute all assets remaining in the Plan, after payment of any expenses properly chargeable against the Plan, to the participants.

Party-in-interest Transactions

Certain plan assets are in investment funds managed by Fidelity Management Trust Company or its affiliates. Fidelity Management Trust Company is the trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines, but are not prohibited under ERISA guidelines.

In addition, various administrative costs are paid by the Firm that also qualify as party-in-interest transactions.

Note 2 - Summary of Significant Accounting Policies

Investment Valuation and Income Recognition

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

Participant Notes Receivable

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Administrative expenses of \$8,580 for the year ended December 31, 2024 were paid by the Firm.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the statement of net assets available for benefits.

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including October 1, 2025, which is the date the financial statements were available to be issued.

Note 3 - Certified Information

Fidelity Management Trust Company (the "Trustee") holds certain of the Plan's investments and participant notes receivable and executes all related transactions. The investment and participant notes receivable balances other than self-directed brokerage account investments and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Trustee.

The Plan's self-directed brokerage account investments, totaling \$31,964,320 as of December 31, 2024, and related investment income of approximately \$3,340,000 for the year ended December 31, 2024 were not certified.

Note 4 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

The following valuation methodologies have been used to value the Plan's investments:

Mutual Funds

Mutual funds are valued at quoted prices reported in active markets.

Note 4 - Fair Value Measurements (Continued)

Money Market Fund

The money market fund is valued at quoted prices reported in active markets.

Common/Collective Trust Funds

The common/collective trust funds are valued at net asset value per share or its equivalent of the funds, which is based on the fair value of the funds' underlying assets.

Self-directed Brokerage Accounts

The Plan allows participants to invest in self-directed brokerage accounts. The self-directed brokerage accounts include various investments, such as publicly traded securities, money market funds, and fixed-income securities. The publicly traded securities and money market funds are valued based on quoted market prices. The fixed-income securities are valued using quoted market prices and other market data for the same or comparable instruments and transactions in establishing the prices, discounted cash flow models, and other pricing models. These models are primarily industry-standard models that consider various assumptions, including time value and yield curve, as well as other relevant economic measures. All other investments are valued based on quoted market prices.

The Plan has not individually sought its own determination letter.
