We have performed audits of the accompanying financial statements of Orion Bancorporation, Inc. Notes to Financial Statements

Note 1: Description of Plan

The following description of the Orion Bancorporation, Inc. Retirement Savings Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering employees (excluding janitors) of Orion Bancorporation (the "Plan Sponsor") who have three months of service and are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions

Each year, participants may contribute from their annual compensation (pre-tax or Roth), as defined in the Plan Document. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan also includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions are invested in a designated balanced fund. There is also an auto-escalation clause that increases this deferral rate over time.

The Plan Sponsor provides for safe harbor nonelective contributions equal to 3% of participant's eligible compensation. The Plan Sponsor also provides a discretionary additional matching contribution equal to 50% of up to 6% of the participant's eligible compensation. Additional profit sharing amounts may also be contributed at the discretion of the Plan Sponsor. During the year ended December 31, 2024, the Plan Sponsor made discretionary additional matching contributions of \$166,891, safe harbor contributions of \$198,420, and discretionary profit sharing contributions of \$120,627 to the Plan. During the year ended December 31, 2023, the Plan Sponsor made discretionary additional matching contributions of \$165,885, safe harbor contributions of \$186,652, and discretionary profit sharing contributions of \$119,274 to the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Plan Sponsor's contributions, and allocations of plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Note 1: Description of Plan (Continued)

Vesting

Participants are immediately vested in their voluntary contributions and actual earnings (losses) thereon.

Vesting in the Plan Sponsor's safe harbor contributions, discretionary profit sharing, and discretionary additional matching portions of their accounts plus actual earnings (losses) thereon is based on years of continuous service. For safe harbor contributions, participants become fully vested after two years of service. For discretionary profit sharing and additional matching contributions, participants vest at a rate of 20% per year beginning with the second year of service and become fully vested after six years of service. Participants are considered to have completed one year of service for purpose of vesting upon the completion of 1,000 hours of service during the Plan year.

Participants may also become fully vested upon attaining the age of 60, death, termination due to disability or termination of the Plan.

Payment of Benefits

On termination of service due to death, disability or retirement, a participant or beneficiary will receive an amount equal to the value of the participant's vested interest in his or her account by lump-sum or other forms of payments. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum or installment distribution. In addition, hardship distributions out of the participant's voluntary contributions account are permitted if certain criteria are met. The Plan also allows for in-service distributions upon attaining age 59 ½ from all sources.

Forfeitures

Forfeitures arise as a result of participants who terminate service with the Plan Sponsor before becoming fully vested in the Plan Sponsor's contributions. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$57,937 and \$72,068, respectively. These accounts may be used as future Plan contributions or to pay administrative expenses of the Plan in accordance with the Plan document. During the years ended December 31, 2024 and 2023, the Plan Sponsor's contributions were reduced by \$59,190 and \$10,756 from forfeited nonvested accounts, respectively.

SECURE 2.0 Act

The SECURE 2.0 Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. Management has evaluated those provisions and determined there is no material impact on the Plan.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of investments are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Plan Sponsor. Expenses that are paid by the Plan Sponsor are excluded from these financial statements. Investment-related expenses are allocated proportionately to plan participants based on their respective account balances and are included in net appreciation in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through October 14, 2025, which is the date the financial statements were available to be issued.

Note 3: Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments.

Note 3: Fair Value Measurements (Continued)

When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no Plan assets requiring the use of Level 2 and 3 inputs for the periods presented.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common collective fund: Valued at NAV as determined by using estimated fair values of the underlying assets held in the fund at year-end. The objective of the common collective fund is to provide preservation of principal with stability and consistency of returns. It invests in primarily synthetic guaranteed investment contracts. Investments in the common collective fund can be purchased or sold continuously. A notice of redemption is not required. The Plan has no obligation to buy additional units.

Note 4: Information Prepared and Certified by the Custodian

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the years then ended, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Empower Trust Company LLC, the Custodian of the Plan, as of December 31, 2024 and 2023.

Note 5: Related-Party and Party-in-Interest Transactions

Administrative expenses and fees incurred by the Plan for investment management services are included in investment income, since they are paid through revenue sharing rather than a direct payment. Specific detail for management fees is not available from the Custodian.

Note 6: Tax Status

The Plan adopted a nonstandard prototype document with an IRS notification letter dated November 14, 2022, which states the prototype plan document is in compliance with the applicable sections of the Internal Revenue Code (IRC). Therefore, no provision for income taxes has been included in the Plan's financial statements.

The Plan has been amended since receiving the determination letter; however, the Plan Administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax.

Note 7: Plan Termination

Although it has not expressed any intent to do so, the Plan has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Plan Sponsor contributions.

Note 8: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
