INDEPENDENT AUDITORS' REPORT

To the Participants and Plan Administrator
Toray Advanced Composites USA Savings Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Toray Advanced Composites USA Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

NOTE 1: PLAN DESCRIPTION

The following description of the Toray Advanced Composites USA Savings Plan (the "Plan") provides only general information. For a more complete description, refer to the Plan document, which is available from the Plan administrator.

General

The Plan is a defined contribution plan covering substantially all employees of Toray Advanced Composites USA, Inc. (the "Sponsor" and formerly known as TenCate Advanced Composites USA, Inc.) and the related participating employer (collectively, the "Company" and/or the "Employer"). The Plan was formed in July 2018 when the Company's ownership changed, ceased its participation in a former plan (the TenCate USA Savings Plan), and subsequently established the Plan with the effective date of August 1, 2018. As a result, the accounts of participants employed by the Company were transferred to the new Plan. The Sponsor serves as the Plan administrator.

Contributions

Participants may contribute to the Plan from 1% to 85% of their compensation up to the allowable Internal Revenue Service ("IRS") maximum. Participants reaching age 50 or older during the calendar year may also make additional catch up contributions up to the allowable IRS maximum. Matching contributions are equal to 100% of up to 3% of participant compensation and 50% of up to the next 2% of participant compensation.

Both participant and Company matching contributions are remitted to the Plan trustee and allocated to the investment fund(s) elected by the participants.

Participant Accounts and Investments

A separate account is maintained for each participant. The account balance of each participant is adjusted daily for contributions and investment income transactions. Plan participants may elect to place contributions in the investment accounts listed in the supplemental schedule.

Vesting

Participants are immediately vested in their voluntary contributions, Plan earnings, and the Company's contributions.

Forfeitures

Forfeited amounts may be used to pay the Plan's administrative expenses or reduce Company contributions. At December 31, 2024 and 2023 there was no balance in the forfeiture account.

Termination

While the Company has not expressed any intention to terminate the Plan, it may do so at any time, subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). If the Plan is terminated, each participant shall receive a payment equal to the value of his or her account.

Withdrawals and Benefit Payments

Withdrawals of any portion of a participant's account prior to his or her termination of employment may be made only after the participant attains the normal retirement age of age 65, upon a participant becoming disabled, as a qualified reservist distribution, or in the event of a financial hardship as determined by the Plan administrator, and as specified by the Plan.

Upon death, retirement, or termination of employment, the balance in the participant's account will be paid to the participant or the participant's beneficiaries in accordance with the distribution option elected.

Notes Receivable from Participants

In accordance with the Plan, participants may borrow funds from their individual accounts, subject to certain limitations. Participants may borrow up to 50% of their account balance, except that total borrowings may not exceed \$50,000 for any participant. The minimum permissible loan amount is \$1,000. The term for repaying such loans shall be level payments over a period of at least 1 year but no more than 5 years, except for loans used to purchase a principal residence, for which the repayment period may be extended over a reasonable amount of time but is not to exceed 10 years. Such loans bear interest at the Prime rate plus 1%. Interest and principal paid by participants are deposited to their individual Plan accounts.

Effective March 27, 2020, the Plan adopted the distribution provision of the Coronavirus Aid, Relief, and Economic Security ("CARES") Act that was signed into law on March 27, 2020. A CARES Act distribution allowed qualified Plan participants to take penalty-free and tax-favored COVID-19 related distributions up to \$100,000 from the Plan from January 1, 2021 until December 31, 2021. In addition, effective March 27, 2020, the Plan adopted the temporary loan repayment deferral provision of the CARES Act. The deferral provision adopted by the Plan allowed qualified Plan participants who have Plan loan repayments to defer such repayments for up to one year.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("US GAAP") and, accordingly, reflect all significant receivables, payables and other liabilities.

Use of Estimates

The preparation of the financial statements in conformity with US GAAP requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan

management determines the Plan's valuation policies utilizing information provided by the custodians. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade date basis. Interest income is accrued when earned. Dividend income is recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are recorded at their unpaid balance. According to the Plan document and the Plan's loan policy, when conditions of default arise, such as missed payments or broken terms under the promissory note, the participant is given a period of time to cure the default. If default is not cured in a timely manner, the loan is offset or deemed distributed and reported to the IRS. Offset loans satisfy the repayment obligation but are only available when a participant is eligible for a distribution. Accordingly, offset loans are reported as distributed and removed from the statement of net assets available for benefits. When distributions are not available, defaulted loans are deemed distributed, which does not remove the participant's repayment obligations. Accordingly, the deemed loan balances of active participants are included in the notes receivable in the statements of net assets available for benefits.

Payments of Benefits

Benefits are recorded when paid.

Plan Expenses

Certain expenses for Plan administration (participant recordkeeping, statements, and reporting platforms), education and communication, legal and compliance services, and trustee services were paid to Principal Life Insurance Company by the Plan sponsor according to an asset-based service fee. Such expenses are not included in the statement of changes in net assets available for benefits. Investment management fees are paid from the various investment fund earnings based on disclosed expense ratios. Transaction-specific fees, such as for distributions and loans, are deducted directly from participant accounts. Distribution and loan processing fees were \$22,418 and \$20,738 for the years ended December 31, 2024 and 2023, respectively.

NOTE 3: PARTIES IN INTEREST

The Plan used the services of Principal Life Insurance Company (recordkeeping and participant services), Principal Trust Company (trustee and custodian), Gallagher Benefits Services, Inc. (benefits advisor), and Mersereau, Lazenby & Rockas, LLC (Plan auditor), which are parties in interest with respect to the Plan. Transactions with these service providers are not considered prohibited transactions under the IRC and are not prohibited by ERISA. Substantially all of the Plan's administrative costs are paid by the sponsor.

NOTE 4: FAIR VALUE MEASUREMENTS

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. US GAAP establishes a hierarchy of inputs to valuation of that price using three levels described below:

- Level 1 - Observable inputs such as quoted prices in active markets.
- Level 2 - Inputs other than quoted prices in active markets that are either directly or indirectly observable.
- Level 3 - Unobservable inputs about which little or no market data exists, therefore requiring an entity to develop its own assumptions.

The hierarchy gives the highest priority to Level 1 inputs and the lowest to Level 3 inputs. Accordingly, the degree of judgement exercised in determining fair value is greatest for Level 3 assets. The Plan measures assets at fair value on a recurring basis, and does not have any liabilities measured at fair value. Additionally, there are no assets or liabilities measured at fair value on a nonrecurring basis.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds - Mutual funds are publicly traded investments and are valued at the daily closing price reported on the active market on which the funds are traded.

Collective investment fund - The investment in a public investment vehicle is valued using the NAV provided by the administrator of the fund. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. NOTE 5: INCOME TAX STATUS

In accordance with Internal Revenue Service Announcement 2014-16, the Plan adopted the Principal Life Insurance Non-Standardized Pre-Approved Profit Sharing Plan with CODA in October of 2021 in conjunction with a change in recordkeepers to Principal Life Insurance Company. The Plan relies on the prototype sponsor's favorable opinion letter, dated June 30, 2020, that the Plan document is a qualified plan under 401(a) of the Internal Revenue Code ("IRC"). The Plan administrator and the Plan's advisors believe that the Plan is designed and is currently being operated in compliance with applicable requirements of the IRC. Accordingly, the Plan is not subject to tax under present income tax law. The Plan files Form 5500 Annual Return/Report of Employee Benefit Plan.

US GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by a federal or state tax jurisdiction. Plan management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there were no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 6: INFORMATION PREPARED AND CERTIFIED BY THE TRUSTEE

The Plan's investments are held in trust and administered by Delaware Charter Guarantee & Trust Company, conducting business as Principal Trust Company. All investment information, including participant loans, disclosed in the accompanying financial statements and supplemental schedule of assets held for investment purposes at December 31, 2024 and 2023, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by the trustee.
