Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of LUSA Associates/Ultima Services 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of LUSA Associates/Ultima Services 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the year ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note E to the financial statements, is complete and accurate.

Opinion on the Financial Statements

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section –

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the accounting principles generally accepted in the United States of America.

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion on the Financial Statements

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of LUSA Associates/Ultima Services 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about LUSA Associates/Ultima Services 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and, therefore, is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with the accounting principle generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements.

The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

A. DESCRIPTION OF PLAN

The following description of LUSA Associates/Ultima Services 401(k) Plan (Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan was formed effective January 1, 2007, and restated effective as of January 1, 2022, upon adoption of the current 401(k) plan which contains a cash or deferred arrangement pursuant to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Participation

Eligible individuals consist of employees rendering services for LUSA Associates, Inc. and Ultima Services Corporation on contracts subject to the Davis-Bacon Act, Service Contract Act or other federal, state or municipal prevailing wage laws. Other employees whose services are not subject to such prevailing wage laws may be included. There is no age or service requirement for participation. Only certain union employees are eligible for employer matching contributions.

Contributions

Participants may elect to defer a portion of their compensation (as defined). The Plan may make employer nonelective contributions and employer matching contributions. Additionally, the Plan may make prevailing wage contributions, determined by the employer based on rates that satisfy the wage determination issued by the governmental agency responsible for certain contracts. Such contributions cannot exceed the lesser of 100% of the employee's compensation or \$69,000 for a year. Rollover contributions are also allowed.

Participant Accounts

Each participant's account is credited with the participant's elective deferral and an allocation of the employer's contribution. Each participant has the authority to direct the investment of their account to one or more of the investment funds designated as investment options by the Plan sponsor. Investment gain or loss is recognized in participants' accounts on a daily basis as the unit values of the funds change. The benefit to which a participant is entitled is the benefit that can be provided from the distributable value of the participant's account.

NOTES TO FINANCIAL STATEMENTS – CONTINUED

A. DESCRIPTION OF PLAN – Continued

Vesting

Participants are immediately 100% vested in their elective deferral contributions, employer prevailing wage contributions and accumulated earnings thereon. Employer nonelective contributions and employer matching contributions vest according to the following schedule:

2	20%
3	40%
4	60%
5	80%
6 or more	100%

Regardless of the vesting schedule above, a participant is automatically, fully vested in their share of employer nonelective contributions and employer matching contributions upon death, total and permanent disability, or reaching the age of early retirement, which is age 55.

Forfeited Accounts

Non-vested balances of participants' accounts may be subject to forfeiture upon termination of their employment with the company. A forfeiture occurs in the plan year in which the participant either receives a full distribution of their vested account balance or has five consecutive one-year breaks in service, as defined by the Plan. Forfeitures will first be used to by the Plan to restore previously forfeited balances for reemployed participants who have repaid their distribution and to pay plan administrative expenses. Forfeitures not used to restore a participant's account or pay plan administrative expenses, are used to reduce employer contributions to the Plan. There were no outstanding forfeiture balances at December 31, 2024 or 2023, and no forfeiture balances used during the year ended December 31, 2024.

Payment of Benefits

Upon termination of service due to death, disability, retirement, or termination of employment, a participant is entitled to receive an amount equal to the vested interest in his or her account, payable in a single lump sum or in partial distributions, as defined.

In-service withdrawals of all or a portion of a participant's vested account balance may be withdrawn by the participant after reaching age 59½. In-service withdrawals of all or a portion of a participant's rollover account balance may be withdrawn at any time.

Withdrawals from the Plan may also be made under circumstances of financial hardship, in accordance with the provisions specified in the Plan.

Payment of Benefits – Continued

Distributions from the Plan will generally be subject to income taxes and in certain circumstances may also be subject to IRS penalties, unless the distribution is transferred to another qualified plan or individual retirement account

Plan Termination

The employer has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA.

B. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation

The accompanying financial statements have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”). Under the accrual basis of accounting, benefit payments to participants are recorded when paid and administrative expenses are accrued monthly by the Plan.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan provides for investments in various investment securities, which in general, are exposed to various risks, such as interest rate, credit, and overall market volatility risks. Market risks include global events, which could impact the value of investment securities, such as international conflicts. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the financial statements and supplemental schedule.

B. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES – Continued

Investment Valuation and Income Recognition

Investments are reported at fair value, (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information by the investment advisers and custodian. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Management fees and expenses charged to the Plan for some investment accounts are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

Benefit Payments

Benefits to participants are recorded by the Plan when actual payment is made.

Expenses

Certain expenses to maintain the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to benefit payment transactions are charged directly to the participant's account and are included in administrative expenses.

C. FAIR VALUE MEASUREMENTS

The Plan follows FASB ASC 820, *Fair Value Measurements and Disclosures*, which defines and establishes a framework for measuring fair value and expands disclosures about fair value measurements. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (i.e. an exit price). FASB ASC 820 includes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

C. FAIR VALUE MEASUREMENTS – Continued

Level 1 – Unadjusted quoted prices in active markets that are accessible to the Plan at the measurement date for identical assets and liabilities.

Level 2 – Inputs other than quoted market prices in active markets for identical assets and liabilities that are observable either directly or indirectly for substantially the full term of the asset or liability. Level 2 inputs include the following:

- Quoted prices for similar assets and liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in active markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from, or corroborated by observable market data by correlation or other means

Level 3 – Unobservable inputs for the assets or liabilities (i.e., supported by little or no market activity). Level 3 inputs include management's own assumption about the assumptions that market participants would use in pricing the asset or liability (including assumptions about risk).

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes to the methodologies used as of December 31, 2024 and 2023. There are no unfunded commitments as of December 31, 2024 or 2023. The funds have a daily redemption frequency and redemption notice period.

Mutual Funds: These investments are public investment vehicles valued using the NAV provided by the administrator of the fund. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, then divided by the number of shares outstanding. The NAV is a quoted price in an active market and classified within Level 1 of the valuation hierarchy.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

D. INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan participated in an insurance contract whose contract value represents contributions made less withdrawals and administrative expenses, plus interest credited. Net deposits invested in the Standard Stable Asset A become part of Standard Insurance Company’s general account, and there are no segregated or identifiable assets ascribed to the plan’s investment. Net deposits and interest credited become liabilities against Standard Insurance Company on the plan’s behalf. Daily liquidity is available for participants contributions and withdrawals at contract value regardless of market conditions. Contract value is guaranteed by the full faith and credit of Standard Insurance Company; there are no wrap contracts supporting the liquidity of the fund. The fund is neither a mutual fund nor a bank product. Standard Insurance Company’s obligations are not insured by the FDIC or any other federal government agency.

Crediting rates for the Plan’s Standard Stable Asset A are set by the Standard Insurance Company using a process similar to that used by banks or other insurance companies for similar products. Quarterly they declare a crediting rating for all assets in the fund during the coming quarter. This crediting rate take into account yield forecasts from our asset advisory group and the margins required for our business. The crediting rate is declared in advance and is reset quarterly. The fund’s declared crediting rate will never be below one percent annually. The contract value of the investment contract as of December 31, 2023, was \$130. The rate for the Plan year ending December 31, 2023, was 2.78%. As of December 31, 2024, there are no longer funds held in this investment contract.

D. INVESTMENT CONTRACT WITH INSURANCE COMPANY – Continued

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan or other Plan events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the Plan to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

E. INVESTMENTS AND INFORMATION CERTIFIED BY THE CUSTODIAN

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information was certified by The Charles Schwab Trust Company as complete and accurate, and was not subjected to any auditing procedures performed by the Plan's independent auditor other than comparing such information certified by the custodian to information included in the Plan's financial statements and supplemental schedule:

- Investments, at fair value and contract, shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Total investment income as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule H, line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024.

F. RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain administrative services are provided by the Company at no cost to the Plan. The Plan paid expenses related to the Plan's operation and investment management to various providers. Fees paid for directly by the Plan are considered party-in-interest transactions. The Charles Schwab Trust Company is the Trustee of the Plan and, therefore, transactions with this entity qualify as exempt party-in-interest transactions.

G. INTERNAL REVENUE SERVICE STATUS

On June 30, 2020, the IRS stated that the prototype adopted by the Plan, as then designed, qualifies under the Internal Revenue Code (IRC) Section 401(a). The Plan has not received a determination letter specific to the plan itself; however, the Plan Administrator and the Plan's tax counsel believe that the Plan was designed and was being operated in compliance with the applicable requirements of the IRC. Therefore, no tax provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America requires Plan Management to evaluate tax positions taken by the Plan and recognizes a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the applicable authorities. The Plan is subjected to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

H. EXCESS CONTRIBUTIONS REFUNDABLE

In 2025, the Plan refunded a highly compensated employee (HCE) amounts representing 2024 employee contributions that exceeded allowable amounts. The HCE was refunded excess contributions in the amount of \$4,534, plus approximate investment earnings of \$819, which is recorded as a liability on the statement of net assets available for benefits as of December 31, 2024.

In 2024, the Plan refunded an HCE amounts representing 2023 employee contributions that exceeded allowable amounts. The HCE was refunded excess contributions in the amount of \$24,355, which was recorded as a liability on the statement of net assets available for benefits as of December 31, 2023.

J. PARTIAL PLAN TERMINATION

During the year ended December 31, 2023, the Plan Sponsor experienced the loss of one large contract resulting in the termination of more than 20% of the Plan participants; accordingly, the Plan Sponsor determined that a partial plan termination had occurred. All affected plan participants were fully vested in their account balances as a result of the partial plan termination.

K. PROHIBITED TRANSACTIONS

During the year ended December 31, 2024, LUSA Associates/Ultima Services, the Plan's sponsor, failed to deposit employee deferral contributions for three payroll periods to the Plan's trust in a timely manner in accordance with Department of Labor and Regulations. Contributions totaling \$7,783 relating to multiple pay periods during the year ended December 31, 2024, were deposited late. These instances of late deposits resulted in prohibited nonexempt transactions in the form of a loan between the Plan and the Plan Sponsor. The company will make an interest payment to compensate the Plan for lost earnings related to this prohibited transaction.

L. SUBSEQUENT EVENTS

The Plan evaluated its December 31, 2024 financial statements for subsequent events through October 14, 2025, which is the date the financial statements were available to be issued.
