INDEPENDENT AUDITOR'S REPORT

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Power 401(k) Retirement Plan and Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

NOTE 1 – DESCRIPTION OF PLAN

The following description of the Power 401(k) Retirement Plan and Trust (the “Plan”) provides only general information. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

General: The Plan, as amended and restated January 1, 2021, is a defined contribution plan maintained for the benefit of eligible employees of Power Construction Company, LLC, and Power Contracting and Engineering Corp. (collectively, the “Companies”). The Plan is subject to the provisions for the Employee Retirement Income Security Act (“ERISA”) of 1974, as amended.

Participation: Eligible employees can participate in the Plan on a non-matching basis, beginning the month following their initial date of employment and on a matching basis, six months subsequent to their initial date of employment, as defined by the Plan. The Plan has adopted automatic enrollment for all eligible employees who have not declined enrollment.

Contributions: The Plan is designed as a qualified cash deferred arrangement pursuant to Section 401(k) of the Internal Revenue Code and provides for the following contributions, which are to be maintained in separate accounts for each participant:

Employee’s Elective Deferrals: Employee contributions made by the Companies at the direction of the employee in amounts up to 90% of the employee’s compensation (as defined) and which amounts are deducted from the employee’s direct compensation (and are excluded from the employee’s reportable wages for the year). Participants are also allowed to make both Roth and after-tax contributions. The automatic enrollment is set up to defer 3% automatically from the employee’s compensation and automatically increases each year at a rate of 1%, up to a maximum of 8% deferral. The aggregate amount of the employee-directed contributions cannot exceed the statutory limits. Participants who are age 50 or older could contribute an additional amount into the Plan.

Employee’s Rollover Contributions: Employees may contribute amounts rolled over from other qualified plans.

Employer’s Matching Contributions: The Companies may, at their own discretion, match up to a maximum of 50% of each participant’s eligible elective deferrals. However, in applying the match, only salary reductions up to 8% of payroll period compensation (as defined) are considered.

Employer’s Discretionary Contributions: The Companies may, at their own discretion, make additional contributions to the Plan to be allocated to the accounts of eligible participants. The Companies declared no such contributions for 2024.

Participant Accounts: Each participant’s account is credited with an allocation of (a) the participant’s contribution, (b) the Companies’ contributions, and (c) the Plan’s earnings. Allocations are based on participant contributions, account balances, or compensation, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Investments: All contributions, including employer matching contributions and employee discretionary contributions, are participant-directed into various investment options offered by the Plan.

Payment of Benefits: On termination of service, death, disability, or retirement, participants may receive a lump-sum or other payment methods as described in the Plan equal to the vested value of their accounts. In certain circumstances, participants may make “hardship withdrawals” as defined in the Plan. Active participants may also take distributions from the Plan upon attainment of age 59 ½. Benefit amounts under \$1,000 are automatically distributed to participants.

NOTE 1 – DESCRIPTION OF THE PLAN (Continued)

Vesting: Participants are fully vested in their elective cash deferral contributions. Vesting of employer matching contributions and employer discretionary contributions occurs at a rate of 20% per year of service. Participants are fully vested after five years, or upon normal or early retirement, death, or permanent disability. In the event of termination of employment before full vesting has occurred, the non-vested portion of the employer contribution shall be used to reduce the employer's contribution for the Plan year.

Administrative Expenses: The Plan's recordkeeping and custodial expenses are paid by the Plan. Audit fees and other administrative expenses are paid directly by the Companies.

Notes Receivable from Participants: Notes receivable from participants are made in accordance with the Plan provisions and ERISA regulations whereby interest is calculated and charged to the individual participant. Notes are to be repaid over a maximum period of 5 years through employee payroll deductions, except for loans used to acquire a principal residence of the participant for which the maximum loan term is 30 years. Notes bear interest at the prime rate of interest and are secured by the participants' account balance. Participants may borrow from accounts up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Investment Valuation and Income Recognition: The Plan's investments, other than a fully benefit-responsive investment contract, are reported at fair value. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Contract value is the relevant measure for the Plan's fully benefit-responsive investment contracts, because contract value is the amount Plan participants generally receive when executing transactions under the terms of the contract and Plan provisions. The effect of a change in valuation technique or its application on a fair value estimate is accounted for prospectively as a change in accounting estimate. When evaluating indications of fair value resulting from the use of multiple valuation techniques, the Plan is to select the point within the resulting range of reasonable estimates of fair value that is most representative of fair value under current market conditions.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Fully Benefit-Responsive Investment Contract: The Plan holds a fully benefit-responsive traditional investment contract that is reported at contract value, which is generally the amount a participant would receive if he or she would initiate a withdrawal or transfer from the contract under the provisions of the Plan. Contract value represents contributions made to a contract, plus earnings, less participant withdrawals and administrative expenses.

The Plan holds a direct interest in a fully benefit-responsive investment contract through its investment in the Anchor Account IV, which is a group annuity contract (Stable Value Fund (“SVF”)) managed by New York Life Insurance Company (“NYLIC”). Contributions to the contract are deposited into a guaranteed separate account of NYLIC, which is a participating stable value separate account that is not unitized, and the assets of the separate account are accounted for at amortized cost. There are no reserves against contract value of the issuer or otherwise.

The Plan’s investment contract specifies certain conditions under which distributions from the contract would be payable at amounts below contract value. Such circumstances may include a partial plan termination, mergers, spin-offs, layoffs, early retirement incentive programs, sales or closings of all or a portion of the plan sponsor’s operations, bankruptcy, or receivership, if these events would lead to a request for payments of more than 10% of the Plan’s value in the fund. The contract does not limit the circumstances under which the issuer may terminate the contract. At contract termination, the Plan may receive a book value distribution of the Plan’s interest in the SVF, provided a twelve-months advance written notice is given to NYLIC. Distributions resulting from terminations initiated without providing twelve months advance written notice will be subject to a market value adjustment pursuant to the provisions of the SVF contract, provided a minimum of thirty days written notice is given. Currently, management believes that the occurrence of an event that would cause the Plan to transact contract distributions at less than contract value is not probable.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants’ account balances. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded only when a distributable event occurs. If no such distributable event occurs, the Companies continue to record the loan and the participant is still obligated to make future payments.

Payment of Benefits: Benefits are recorded when paid.

Risks and Uncertainties: The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity and credit risks. Due to the level of risk associated with certain investments and the sensitivity of certain fair value estimates to changes in valuation assumptions, it is at least reasonably possible that changes in the fair values of investments and derivative instruments will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

Income Taxes: Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. A tax position is recognized as a benefit only if it is “more likely than not” that the tax position would be sustained in a tax examination, with a tax examination presumed to occur. The amount recognized is the largest amount of tax benefit that is greater than 50% likely of being realized upon examination. For tax positions not meeting the “more likely than not” test, no tax benefit is recorded.

The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by the Internal Revenue Service; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 3 – CERTIFIED INFORMATION

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Charles Schwab Trust Bank, the trustee of the Plan.

NOTE 4 – FAIR VALUE MEASUREMENTS

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following presents the valuation methods and assumptions used by the Plan to estimate the fair values of investments.

Mutual Funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

NOTE 5 – INCOME TAX STATUS

The Internal Revenue Service issued an opinion letter dated September 21, 2020 indicating that the prototype adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code. Although the Plan has been amended from the original prototype document, Plan management believes that the Plan is currently being operated in accordance with the Internal Revenue Code.

NOTE 6 – PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under Department of Labor’s regulations as any fiduciary of the Plan, any party rendering services to the Plan, the employer, and certain others. Certain plan investments are managed under a guaranteed investment contract with the New York Life Insurance Company and therefore these investments qualify as party-in-interest investments. Certain professional and administrative fees related to the operation of the Plan were paid by the Companies. Recordkeeping and administrative fees of \$74,096 were paid by the Plan to Charles Schwab Retirement Plan Services for the year ended December 31, 2024 and thus qualify as a party-in-interest transaction.

Participants in the Plan are permitted to borrow funds from their vested balance as described in Note 1, which qualify as party-in-interest transactions.

NOTE 7 – RIGHTS UPON PLAN TERMINATION

Although it has not expressed an intention to do so, the Companies have the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested to the extent of the balance in their separate account.

NOTE 8 – SUBSEQUENT EVENTS

Plan management has evaluated subsequent events for recognition and disclosure through October 13, 2025, which is the date the financial statements were available to be issued.
