### Note 1 - Plan Description

The following description of Delaco Companies 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan sponsored by the following related employers: Delaco Steel Corporation and DKP Buffalo, LLC. The Diez Group Kansas City, LLC and April Steel Processing, Inc. are unrelated employers that also participate in the Plan, thereby making the Plan a multiple-employer plan. Delaco Steel Corporation; DKP Buffalo, LLC; April Steel Processing, Inc.; and the Diez Group Kansas City, LLC are collectively referred to as the "Companies."

Effective December 23, 2024, the DKP Buffalo, LLC location was permanently closed and all employees were either transferred to a new location or terminated.

The Plan provides benefits to eligible participants, as determined by the provisions of the plan agreement. Employees are eligible to participate in the Plan after completing three months of service and attaining 18 years of age. Upon satisfying the eligibility requirements, participants may enroll in the Plan on the first day of the calendar month following the date the eligibility requirements are met. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions and allocations of the Companies' contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

#### **Contributions**

Participants are eligible to make elective (pretax-basis) contributions to the Plan. Elective contributions can be up to 75 percent of the earned income that would otherwise be paid to the participant, not to exceed Internal Revenue Service annual limitations. The Plan allows participants to contribute on an after-tax basis subject to maximum tax-deferred limitations established by the Internal Revenue Code. Participants are 100 percent vested in their elective contributions, as well as any employer contributions made.

Employer contributions are discretionary, as determined by each of the individual companies. Employees of DKP Buffalo, LLC receive an employer match of 50 percent of the first 6 percent of employee deferrals. Effective December 23, 2024, the DKP Buffalo, LLC location permanently closed; thus, transferred employees will no longer receive the employer match as of the effective date. The Plan also allows for discretionary profit-sharing contributions. There were no profit-sharing contributions made to the Plan for the years ended December 31, 2024 and 2023.

#### **Benefit Payments**

On termination of service due to death, disability, or retirement or upon attainment of age 59½, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or various installment annuities. Upon termination of service, mandatory distributions are made to eligible participants with a plan value of \$1,000 or less. The accounts of eligible participants who terminate service with balances of more than \$1,000 but less than or equal to \$5,000 have their account balances transferred to an individual retirement account in accordance with the regulations of the Department of Labor.

**Note 1 - Plan Description (Continued)**

Participants may request that all or a portion of their accounts be distributed in the case of financial hardship, as defined in the plan agreement.

***Participant Notes Receivable***

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balances. The notes receivable are secured by the balance in the participant's account and bear interest at market rates, which are commensurate with local prevailing rates determined periodically by the plan administrator. Principal and interest are paid ratably through monthly payroll deductions.

***Vesting***

Participants' contributions, the employer match contribution, and the employer discretionary contributions and related earnings are fully vested at all times and are not subject to forfeiture for any reason.

***Termination***

While they have not expressed any intent to do so, the Companies have the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions set forth in the plan document and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances.

***Party-in-interest Transactions***

Certain plan assets are in investment funds managed by Fidelity Management Trust Company or its affiliates. Fidelity Management Trust Company is the trustee of the Plan, and the Companies are the plan sponsors; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

**Note 2 - Summary of Significant Accounting Policies**

***Investment Valuation and Income Recognition***

The Plan's investments are stated at fair value.

The common/collective trust funds are valued at net asset value per share (NAV) (or its equivalent) of the funds, which is based on the fair value of the funds' underlying assets. There were no unfunded commitments or redemption restrictions on the common/collective trust funds. All other investments are valued based on quoted market prices reported in active markets. See Note 5 for additional information.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

***Participant Notes Receivable***

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

***Benefit Payments***

Benefits are recorded when paid.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Note 2 - Summary of Significant Accounting Policies (Continued)**

***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

***Administrative Expenses***

Various administrative costs are paid by the Companies.

***Subsequent Events***

The financial statements and related disclosures include evaluation of events up through and including October 13, 2025, which is the date the financial statements were available to be issued.

**Note 3 - Certified Information**

Fidelity Management Trust Company (the "Trustee") holds the Plan's investments and participant notes receivable and executes all related transactions. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Trustee.

**Note 4 - Tax Status**

The Plan uses a preapproved plan. The preapproved plan has received a favorable opinion letter from the Internal Revenue Service (IRS) indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter.

**Note 5 - Fair Value Measurements**

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

***Level 1***

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

***Level 2***

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

***Level 3***

Fair values determined by Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

**Note 5 - Fair Value Measurements (Continued)**

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.
