Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Tyndale Enterprises, Inc. Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Basis for Opinion

Notes to Financial Statements

December 31, 2024 and 2023

(1) Description of Plan

The following description of the Tyndale Enterprises, Inc. Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of Tyndale Enterprises, Inc. (the Company) and Tyndale Logistics, with the exception of union, leased and temporary employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan Trustee is responsible for oversight of the Plan, determine the appropriateness of the Plan's investment offerings, and monitor investment performance.

Contributions

Each year, participants may contribute pretax annual compensation, as defined in the Plan, up to the maximum allowable under Internal Revenue Code (IRC) guidelines. Participants may designate all or a portion of their elective deferrals as Roth elective deferrals. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit and defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. Effective March 1, 2012, the Plan adopted an auto enrollment provision. Those participants that are hired subsequent to that date are enrolled in the Plan at a 3% deferral rate unless they communicate otherwise.

For the year ended December 31, 2024, the Company made employer contributions equal to 100% of each employee's deferral, up to a maximum of \$2,750. The Company may make a discretionary profit sharing contribution. Any discretionary employer contribution will be allocated based on grouping of classification of employees, as defined in the Plan, and requires completion of a year of service and employment as of the end of the year. For the year ended December 31, 2024, the Company did not make a profit sharing contribution to the Plan.

Participant Accounts

Each participant's account is credited with the participant's contributions and Company's matching contribution, as well as the Company's profit sharing contribution and plan earnings. Participants' accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of service according to the following schedule:

Participants will become fully vested upon death or total and permanent disability while employed by the Company.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The maximum loan term is five years, unless the loan is acquired for the purchase of the participant's primary residence. The notes are secured by the balance in the participant's account and bear interest rates ranging from 5.25% to 10.50%. The loan interest rate is set at 2% over the prime interest rate at the date of loan issuance. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

Upon termination of service due to death, disability, or retirement, a participant or beneficiary may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account or in the form of installment payments if permitted by the plan administrator. For distributions less than \$5,000, a lump sum payment will be made. Participants age 59 ½ and over may elect an in-service distribution.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$43,273 and \$14,734 respectively. These accounts will be used to pay either plan expenses or to reduce future employer contributions. During 2024, forfeitures in the amount of \$48,673 were used to reduce administrative expenses. No amounts were used to reduce employer matching contributions.

(2) Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Contributions

Contributions from plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Trustee determines the Plan's valuation policies utilizing information provided by the trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participants' accounts and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through October 7, 2025, the date the financial statements were available to be issued.

(3) Investment Information Certified by a Qualified Institution

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from the information certified as complete and accurate by Ascensus, LLC, as an authorized representative of Ascensus Trust Company, a qualified institution.

(4) Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies and money market account: Valued at the daily closing price as reported by the fund. Registered investment companies and the money market account held by the Plan are open-end investments that are registered with the Securities and Exchange Commission. Registered investment companies and the money market account are required to publish their daily net asset value (NAV) and to transact at that price. Registered investment companies and the money market account held by the Plan are deemed to be actively traded.

(5) Related Party and Party-In-Interest Transactions

Certain plan investments are shares of mutual funds managed by Vanguard; Vanguard has outsourced recordkeeping of the Plan to Ascensus, LLC, the Plan trustee. In addition, the Plan's third-party administrator provides recordkeeping services to the Plan. Both the custodial services and the recordkeeping services qualify as party-in-interest transactions. Fees paid by the Plan for the recordkeeping and custodial services amounted to \$121,064 for the year ended December 31, 2024. The plan sponsor pays directly any other fees related to the Plan's operations.

(6) Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

(7) Tax Status

The Plan adopted a pre-approved plan document sponsored by Newport Group Inc. The Internal Revenue Service (IRS) has determined and informed Newport Group Inc by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(8) Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

(9) Nonexempt Transactions

During 2023, the Company failed to remit certain participants contributions and loan repayments within the timeframe prescribed by the Department of Labor's regulations. This transaction is considered a prohibited transaction under ERISA. The Company corrected this failure by contributing lost earnings to the affected participant accounts during 2024.
