## INDEPENDENT AUDITOR'S REPORT

**(1) DESCRIPTION OF PLAN**

The following description of the M. Cohen and Sons, Inc. 401(k) Plan (“the Plan”) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

***General***

The Plan, sponsored by M. Cohen and Sons, Inc. (the “Company”), is a defined contribution plan covering all eligible employees who have completed six months of service and are 21 years old or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

***Contributions***

Participants may contribute between 1% and 15% of pretax annual compensation, up to the maximum dollar amount permissible under the Internal Revenue Code. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. The Company may contribute to the Plan at its discretion. There were no Company contributions to the Plan during 2024. Participants may also contribute amounts representing distributions from other qualified plans.

***Participant Accounts***

Each participant’s account is credited with the participant’s contribution and rollovers and an allocation of (a) the Company’s contribution and (b) Plan earnings, and charged with (c) certain administrative expenses and (d) allocation of Plan losses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

***Vesting***

Participants are immediately vested in their contributions, plus actual earnings thereon. Company matching contributions and income thereon are vested over five years, according to a graded schedule of years of credited service, as defined in the Plan.

***Investment Options***

Upon enrollment in the Plan, participants direct employee and related employer contributions into any of a range of mutual funds. All investments are participant directed. Investment options can be changed daily.

***Forfeitures***

Forfeitures of non-vested Company contributions may be used to pay plan expenses or reduce Company contributions. Amounts available for future use as of December 31, 2024 and 2023 was \$1,314 and \$349, respectively. No forfeitures were utilized in 2024.

***Payment of Benefits***

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account or in installments. For termination of service or for other reasons, a participant will receive the value of the vested interest in his or her account as a lump sum distribution.

***Hardship Withdrawals***

Participants are generally not permitted to make in-service withdrawals from their accounts prior to the attainment of age 59½; however, the employer may authorize withdrawals from a participant's account in the event of "proven financial hardship." Hardship withdrawals are subject to specific statutory and regulatory requirements. A participant who receives a hardship withdrawal will be prohibited from making elective contributions to the Plan for a period of six months following the date of withdrawal.

***Participant Loans***

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loans must be repaid within a period not to exceed five years. Loans to purchase a primary residence may be repaid over a period greater than five years as determined by the Plan administrator. The loans are secured by the balance in the participant's account and bear interest at a rate determined by the Plan administrator based on regulatory guidelines.

**(2) SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

***Basis of Accounting***

The financial statements of the Plan are prepared using the accrual method of accounting.

***Estimates***

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

***Payment of Benefits***

Benefits are recorded when paid.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid balance plus any accrued but unpaid interest. Delinquent notes receivable are reclassified as distributions based upon the terms of the Plan document.

*Expenses*

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation/depreciation in fair value of investments.

*Investment Valuation and Income*

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note 4 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

(UNAUDITED)**

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedules, including investments held at December 31, 2024 and 2023, dividends and interest, and net appreciation (depreciation) in fair value of investments for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Matrix Trust Company (custodian of the Plan).

**(4) FAIR VALUE MEASUREMENTS**

Accounting principles establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes inputs to valuation techniques used to measure fair value. The hierarchy gives priority to unadjusted quoted prices in an active market for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 Inputs to the valuation methodology include

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

Money market funds: Valued at quoted market prices as of year-end.

Mutual funds: Valued at the daily closing prices as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/collective trusts: Valued at the NAV of units of the common/collective trust. The NAV, as provided by the custodian, is used as a practical expedient to estimating fair value.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value as of December 31, 2024 and 2023:

**(5) PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company reserves the right to amend or terminate the Plan at any time. In the event of a Plan termination, all participants are 100% vested and the assets of the Plan are to be distributed to the participants.

**(6) TAX STATUS**

The Internal Revenue Service has determined and informed TD Ameritrade Trust Company, as the designer of the prototype plan the Company has adopted, in a letter dated March 31, 2014, that the Plan and related trust are designed in accordance with applicable sections of the IRC. The Plan was determined to be top-heavy for the plan years 2019 and 2018. As a result, contributions from the Plan sponsor were due to the Plan by December 31, 2020 and December 31, 2019. These contributions were not made. As a result, the Plan was not in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and, with exception of the Plan's top-heavy status, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examination for years prior to 2021.

**(7) RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**(8) DELINQUENT PARTICIPANT CONTRIBUTIONS**

Certain participant contributions and loan repayments were not remitted to the Plan within the time frame specified by the Department of Labor's Regulation 29 CFR 2510.3-102, thus constituting nonexempt transactions between the Plan and the Company during the 2016, 2015, 2014, 2013 and 2012 Plan years. Late remittances amounted to \$21,380, \$112,838, \$84,561, \$127,703 and \$120,295 for the years ended December 31, 2016, 2015, 2014, 2013, and 2012, respectively.
