Note 1 – Description of the Plan:

The following brief description of the Universal Stainless & Alloy Products, Inc. Employees' 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible hourly and salary employees of Universal Stainless & Alloy Products, Inc. (the Company). Participants are eligible to begin Plan enrollment on the first day of the calendar month following their date of hire. Effective July 1, 2024, the Plan was amended whereby all full-time employees are eligible for enrollment immediately upon hire. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Company trustee is responsible for oversight of the Plan.

Contributions

Participants are permitted to make contributions to the Plan by payroll deduction, in 1% increments, up to 75% of their total compensation, limited to the maximum amount permitted by regulations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. Effective April 1, 2024, the Plan was amended to include an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3 percentage of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. For eligible hourly Dunkirk, North Jackson and Titusville facility employees who are members of the United Steelworkers (USW), the Company makes contributions to the Plan based on the number of hours worked, at rates specified in the applicable collective bargaining agreement. For hourly employees associated with the Bridgeville facility who are members of the USW, the Company participates in and makes contributions to the Steelworkers Pension Trust, a multi-employer defined benefit pension plan. As such, the Company does not make contributions to the Plan for these Bridgeville hourly employees. For eligible salaried employees, the Company makes contributions to the Plan based on a Company match and fixed monthly contributions as defined in the Plan document.

Note 1 – Description of the Plan (Continued):

Participant Accounts

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's non-elective contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions and earnings thereon. Once participants complete six months of service, they are 100% vested in the Company contributions and earnings thereon.

Notes Receivable from Participants

Participants may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance to in the participant's account. The loan interest rate is implemented at the established Prime rate plus 2%, as defined. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

Upon termination of employment, retirement or death, a participant's account is distributed in a single lump-sum if the value of the vested account does not exceed \$1,000. If the value of the vested account is between \$1,000 and \$7,000 and the participant does not request a distribution, the Company may transfer the funds to an IRA established for the participant's benefit. If the account is \$7,000 or more, the participant may elect to defer the distribution of the account until April 1 following the calendar year in which the participant reaches age 72.

Forfeited Accounts

As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$26,290 and \$33,423, respectively. These accounts are available as designated by the plan document. For the year ended December 31, 2024, \$20,333 were used to reduce Company contributions and \$15,463 to pay administrative fees from forfeited nonvested accounts.

Note 2 – Summary of Significant Accounting Policies:

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Note 2 – Summary of Significant Accounting Policies (Continued):

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual estimates could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value), which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan participants and the contributions from the Company are recorded in the year in which participant compensation is earned.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2023 excess contributions to the applicable participants prior to March 15, 2024.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Payment of Benefits

Benefits are recorded when paid.

Consideration of Subsequent Events

Effective January 1, 2025, the Plan was amended to increase the Company contribution for salaried employees. For additional information regarding specific changes, see the updated Plan amendments. In addition, the Plan's vesting schedule has also been adjusted whereas one year of service will now be required for 100% vesting in Company contributions. Employees hired prior to January 1, 2025, will automatically be 100% vested in the Company's matching contributions and employees with six months of service prior to January 1, 2025 will be 100% vested in Company non-elective contributions.

For the year ended December 31, 2024 the Plan has evaluated subsequent events for potential recognition and disclosure through October 8, 2025, the date the financial statements were available to be issued.

Note 3 – Certified Investments:

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023 and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained and derived from information supplied to the plan administrator and certified as completed and accurate by Voya Retirement Insurance and Annuity Company ("Voya"), the custodian of the Plan.

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

Note 4 – Fair Value Measurements:

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, establishes a framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3- Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a brief description of the valuation methodologies used for assets measured at fair value, except for those measured and reporting using NAV. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Shares held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission ("SEC"). These funds are required to publish their daily Net Asset Value (NAV) and to transact at that price. The shares held by the Plan are deemed to be actively traded.

Money Market Funds: These investments are public investment vehicles valued using \$1 for the net asset value. The money market funds are classified within Level 2 of the valuation hierarchy.

Note 4 – Fair Value Measurements (Continued):

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 – Related Party Transaction and Party-in-Interest Transactions:

Certain administrative functions of the Plan are performed by officers or employees of the Company at no cost to the Plan. Certain plan investments are managed by the Plan's trustee, and therefore, these transactions qualify as party in interest transactions. Additionally, the Plan issues loans to participants, which are secured by the participant's account balances. These transactions qualify as party-in-interest transactions. There were also identified delinquent participant contributions representing a party-in-interest transaction.

Note 6 – Plan Termination:

Although it has not expressed any intent to do so, the Company has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their entire account balance.

Note 7 – Fully Benefit-Responsive Investment Contract:

The Plan offers a fully benefit-responsive guaranteed annuity contract with Voya that comprises a traditional investment contract totaling \$6,639,364 and \$6,533,943. This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses.

The traditional investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at the specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer. The crediting rate is reviewed on a quarterly basis for resetting. The contract cannot be terminated before the scheduled maturity date.

The Plan's ability to receive amounts due in accordance with the fully benefit-responsive investment contract is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity with provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemptions under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact and contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligations under the contract, (3) a material misrepresentation or, (4) a material amendment to the agreement without the consent of the issuer.

Note 8 – Tax Status:

The IRS has determined and informed the Company by a letter dated July 13, 2021, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America (U.S. GAAP) requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9 – Risks and Uncertainties:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
