We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Minot Builders Supply Association 401(k) Profit Sharing Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Minot Builders Supply Association 401(k) Profit Sharing Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Minot Builders Supply Association 401(k) Profit Sharing Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Supplemental Schedules Required by ERISA

The supplemental Schedule of Assets (Held at End of Year) as of December 31, 2024 and Schedule of Delinquent Participant Contributions for the year ended December 31, 2024 are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements.

The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion—

- the form and content of the supplemental schedules, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedules related to assets held by and certified to by a qualified institution agrees to or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

NOTE 1 DESCRIPTION OF PLAN

The following description of the Minot Builders Supply Association 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of Minot Builders Supply Inc. (the Company) and its Subsidiaries, MBS Truss – Minot and MBS Truss – Mandan, who have worked with one of the companies for two months or more. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan is administered by the Company. Matrix Trust Company serves as the trustee of the Plan and holds the Plan assets and EPIC Retirement Plan Services serves as the Plan's recordkeeper.

Contributions

Each year, participants may contribute an amount equal to a dollar amount or percentage of compensation, not to exceed IRS limits. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan allows participants to allocate contributions between pretax and after tax (Roth 401(k)) deferrals. The Company will make a matching contribution equivalent to 50% of the employee's deferral up to 12% for a maximum of 6% of the employee's compensation. The Plan requires an employee to be employed or if terminated, to have attained at least 500 hours of service as of the last day of the plan year to receive the employer match. Effective January 1, 2024, the Plan was amended to allow for the matching contribution amount to be at the Company's discretion. In addition, at this time, allocation conditions were removed from the Plan document. During 2024, no discretionary matching contributions were made to the Plan.

Effective January 1, 2024, the Plan elected safe harbor provisions, in which the Company will make a safe harbor matching contribution up to 4% of an employee's compensation.

In addition, the Plan allows for a discretionary profit-sharing contribution to be made by the Company. When contributions are made, they are allocated among employees of the Company based on a level of compensation. No profit-sharing contributions were made during the years ended December 31, 2024 and 2023.

Participants may make rollover contributions for amounts representing distributions from other qualified defined benefit plans, defined contribution plans or individual retirement accounts.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's contributions, and an allocation of Plan earnings. Plan earnings are allocated based on participant account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account. The value of each participant's account is determined daily.

Participants' Investment Options

Participants must direct their deferrals and Company contributions as offered by the Plan. Participants may change their investment options throughout the year by contacting the recordkeeper.

Vesting

Participants are immediately vested in their contributions, and all employer contributions, plus actual earnings thereon.

Payment of Benefits

Upon termination of service, death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of his or her account, partial payments, or regularly scheduled installment payments. Distribution of benefits upon termination become automatic if the participant's account balance is less than \$7,000 and are subject to the automatic rollover provisions. If the vested amount does not exceed \$1,000, the participant will automatically receive a lump-sum distribution.

Hardship distributions and in-service retirement distributions are also permitted for participants who have not separated from service. Participants must have attained age 59 ½ to qualify for in-service retirement distributions. Distributions are also allowed from rollover accounts at any time. Generally, certain minimum distributions are required for participants who have separated from service and have reached the required minimum distribution age.

Forfeitures

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$35,277 and \$32,615, respectively. This account consists of (a) excess employer contributions as a result of overpayment or compliance test failures and (b) amounts forfeited due to a participant not meeting the employer match requirement of being employed on the last day of the year or working 500 hours during the Plan year. This account is used to reduce employer contributions. During the years ended December 31, 2024 and 2023, \$8,387 and \$9,414 of forfeitures, respectively, were used to reduce employer contributions.

Reclassifications

Certain investments in the prior year have been reclassified for comparative purposes to conform with the presentation in the current year. Those changes have no effect on net assets available for benefits as previously reported.

NOTE 2 SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting.

Basis of Presentation

The accompanying financial statements are presented in accordance with accounting principles generally accepted in the United States of America, ("GAAP"), as codified by the Financial Accounting Standards Board.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Company's management determines the Plan's valuation policies utilizing information provided by investment advisors and the trustees of the Plan. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are reflected on a trade date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year and are reflected in the statements of changes in net assets available for Plan benefits.

Contributions

Contributions from Plan participants and contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

Payment of Benefits

Benefits to participants are recorded when paid.

Administrative Expenses

The investment funds in the Plan are subject to investment fees based on a percentage of invested assets, as disclosed in the fund's prospectus. All such fees are charged directly against the fund's investment performance and thus are not separately disclosed in the accompanying financial statements. Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements.

Income Taxes

The Plan's policy is to evaluate the likelihood that its uncertain tax positions will prevail upon examination based on the extent to which those positions have substantial support within the Internal Revenue Code and Regulations, Revenue Rulings, court decisions, and other evidence.

Excess Contributions Payable

Amounts payable to the Company and participants for contributions in excess of amounts calculated or allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2023 excess contributions to the Company and applicable participants prior to March 15, 2024. No excess contributions payable was recorded as of December 31, 2024.

NOTE 3 INFORMATION PREPARED AND CERTIFIED BY THE TRUSTEE

NOTE 4 FAIR VALUE MEASUREMENTS

FASB ASC Topic 820, *Fair Value Measurements*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under Topic 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:
 Quoted prices for similar assets or liabilities in active markets;
 Quoted prices for identical or similar assets or liabilities in inactive markets;
 Inputs other than quoted prices that are observable for the asset or liability;
 Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There has been no change in methodology used at December 31, 2024 and 2023.

Collective trust funds: Valued at the net asset value (NAV) of units of the collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the trustee reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan does not have any investments to be classified within the fair value hierarchy as of December 31, 2024 and 2023. See *Investments Measured Using the Net Asset Value per Share Practical Expedient* in the following table to reconcile to investments at fair value on the Statements of Net Assets Available for Benefits.

Balanced collective trust funds seek a blend of equities for consistent long-term returns, paired with conservative holdings to reduce short-term market fluctuations and produce income. The portfolio's assets are invested in equities, alternative assets and fixed income securities. This account is for investors with a time horizon between 10-20 years with the ability to accept greater risk.

Growth collective trust funds seek equities for a high level of consistent long-term returns, with some conservative holdings to reduce short-term market fluctuations and produce income. The portfolio's assets are invested in equities, alternative assets, and fixed income securities. Increased market value fluctuations over the short-term due to market volatility are expected. This collective trust fund is for investors with a time horizon of 15-20 years or greater.

Income collective trust funds seek to maximize current income with reduced market risk. The portfolio's assets are invested in fixed income securities. This account is for investors with a time horizon between 0-10 years with the objective of stability.

Moderate balanced collective trust funds seek a blend of conservative holdings to reduce short-term market fluctuations and produce income, coupled with equities for long-term returns. The portfolio's assets are invested in fixed income, equities, and alternative assets. This collective trust fund is for investors with a time horizon between 10-15 years with the ability to accept some risk.

Aggressive growth collective trust funds seek equities for a high level of consistent long-term returns. The majority of the portfolio's assets are invested in equities, while the remainder is in alternative assets. Increased market fluctuations over the short-term due to market volatility are expected. This collective trust fund is for investors with a time horizon greater than 20 years with the ability to accept greater risk.

NOTE 5 INCOME TAX STATUS

The Plan adopted a non-standardized pre-approved profit sharing plan with CODA sponsored by the recordkeeper, EPIC Retirement Plan Service. The Internal Revenue Service informed the recordkeeper by an opinion letter dated June 30, 2020, that the non-standardized pre-approved profit sharing plan is acceptable under Section 401 of the Internal Revenue Code. The Company and plan administrator believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and the Plan continues to be tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken a significant uncertain tax position that more likely than not would not be sustained upon examination by taxing authorities. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

NOTE 7 EXEMPT TRANSACTIONS WITH PARTIES-IN-INTEREST

First Western Bank & Trust is a third party provider of the Plan and EPIC Retirement Plan Services is the recordkeeper of the Plan and, therefore any transactions with First Western Bank & Trust and EPIC Retirement Plan Services, are parties-in-interest transactions. First Western Bank & Trust and EPIC Retirement Plan Services provides certain administrative services to the Plan pursuant to the service agreement between the Company, First Western Bank & Trust and EPIC Retirement Plan Services. Distribution fees paid to First Western Bank & Trust totaled \$350 and \$490 for the years ended December 31, 2024 and 2023, respectively. Distribution fees paid to EPIC Retirement Plan Services totaled \$998 and \$528 for the years ended December 31, 2024 and 2023, respectively.

NOTE 8 PLAN TERMINATION AND AMENDMENTS

Minot Builders Supply Inc. has the right to amend the Plan if it determines it is necessary or desirable to do so. Further, although the Company intends to continue the Plan, it reserves the right to terminate it. Any termination of the Plan is subject to the provisions of ERISA.

NOTE 9 RISKS AND UNCERTAINTIES

Participants direct the investment of their accounts into various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 10 SUBSEQUENT EVENTS

No significant events occurred subsequent to the Plan's year end. Subsequent events have been evaluated through October 2, 2025, which is the date these financial statements were available to be issued.


