### Report on the Audit of the Financial Statements

#### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed an audit of the accompanying financial statements of Discovery Energy 401(k) Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the period from May 1, 2024 (inception) to December 31, 2024, and the related notes to the financial statements.

**NOTE 1 DESCRIPTION OF THE PLAN**

The following description of the Discovery Energy 401(k) Savings Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan that was established, effective May 1, 2024, as amended, to enable eligible employees to accumulate funds through systematic savings, on a tax-advantageous basis, in order to provide additional retirement and other benefits and to provide Discovery Energy, LLC (the Company) a vehicle to attract and retain qualified employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan was most recently amended effective July 1, 2025.

Effective May 1, 2024, Kohler Co. sold their wholly owned Kohler Energy Division to Discovery Energy, LLC. As of the effective date, Discover Energy, LLC, became a separate company, and as a result of the sale, employees of the Energy Division became employees of Discovery Energy, LLC. The effective date of the Plan is May 1, 2024.

**Eligibility**

Eligible employees are active factory hourly employees of the Company who have reached age 18. Employees with customary employment of at least 1,000 hours of service during a 12-month period are eligible after 30 days of service. Employees with customary employment of less than 1,000 hours of service during a 12-month period are eligible after completing one year of eligibility service during which they work at least 1,000 hours.

**Contributions**

Contributions to the Plan are made by participants and the Company. Participants may elect to contribute, in multiples of 1%, amounts from 0% to 75% of their annual compensation, not to exceed that allowed for such contribution plans, which are limited by statutory provisions. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation, and their contributions invested in the designated default fund until change by the participant.

Company matching contributions for employees of the Hattiesburg and Sauk Technologies locations are 75% of the first 1%, 50% of the next 4%, and 25% of the next 1% a participant contributes.

**Contributions (Continued)**

Company matching contributions for Kohler, Wisconsin Factory Hourly employees are as follows:

- Associates, defined as any employee hired or rehired on or after May 1, 2024, or who transferred into coverage under this Plan: 50% of the first 6% a participant contributes.
- Tenured Associates, defined as any employee whose Kohler Co. employment began before December 20, 2010 (and who was previously covered under the Kohler 401(k) Savings Plan): 50% of the first 2% and 25% of the next 2% a participant contributes.

Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers). Participant, Company, and rollover contributions are invested based on investment fund elections established by the Benefits Planning Committee and selected by the participant.

**Participant Accounts**

Each participant's account is credited with the participant's contributions, the Company's contributions, and an allocation of Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided by the participant's vested account.

**Vesting**

Participants are 100% vested in their contributions and the earnings on their contributions. Vesting for Company contributions and earnings on Company contributions for participants commencing employment before January 1, 2002, is as follows:

A participant also becomes fully vested upon the attainment of normal retirement age (age 65), or upon death or total disability while an employee of the Company.

**Notes Receivable from Participants**

Participants are allowed to take loans from the Plan. Loan amounts are limited to 50% of the participant's vested account balance, with a maximum loan amount of \$50,000 and a minimum of \$1,000. Participants may have a maximum of one outstanding loan. Loan terms range from one to five years, or up to 15 years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at the prime rate. The interest paid by a participant on their loan balance is credited directly to their individual account. Principal and interest is paid ratably through payroll deductions.

**Benefit Payments**

Upon termination of service due to death, disability, or retirement, a participant may elect to receive the value of the vested interest in his or her account in the form of a lump sum distribution or installments over a period not to exceed 15 years. The Plan allows for in-service distributions if a participant reaches age 59½ and hardship distributions subject to Plan provisions. If a participant terminates employment and the participant's account balance does not exceed \$1,000, the Plan administrator will authorize the benefit payment without the participant's consent. If the balance of the terminated participant's account is between \$1,000 and \$7,000, the Plan Sponsor may authorize that the benefit payment be rolled into an individual retirement account in the participant's name.

**Forfeited Accounts**

Forfeited nonvested accounts can be used to reduce future Company matching contributions and to pay administrative expenses. Forfeited nonvested accounts as of December 31, 2024, totaled \$31,507. There were no forfeitures used to reduce Company matching contributions or pay administrative expenses for the period from May 1, 2024 (inception) to December 31, 2024.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Investment income and administrative expenses relating to the Master Trust are allocated to the Plan based on individual participant earnings or account balances. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024. Delinquent notes receivable are recorded as distributions on the basis of the terms of the Plan document.

**Payment of Benefits**

Benefit payments to participants are recorded upon distribution. There were no amounts allocated to accounts of participants who have elected to withdraw from the Plan, but have not yet been paid at December 31, 2024.

**Plan Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefits paid to participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value investments.

**Transfers**

As of the effective date of the plan as disclosed in Note 1, net assets of \$73,334,548, which related to account balances of former employees of the Kohler Energy Division, were transferred from the Kohler Co. 401(k) Savings Plan to this Plan.

**Subsequent Events**

The Plan has evaluated subsequent events through October 10, 2025, the date the financial statements were available to be issued.

Effective January 1, 2025, the Plan was amended to change the name to Rehlko 401(k) Savings Plan, to expand the options for applying forfeitures, to clarify the definition of eligible compensation, to add alternative eligibility provisions for part-time employees, and to treat catch-up contributions for high earners as Roth contributions.

Effective April 1, 2025, the Plan was amended to add separate deferral elections for bonuses and other irregular pay.

Effective July 1, 2025, the Plan was amended to add a one-time, nonelective Company contribution for participants who forfeited their prior Kohler Co. retiree medical savings account balances.

**NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION AND INVESTMENT IN MASTER TRUST**

Certain information related to investments disclosed in the accompanying financial statements and as shown below, including investment in Master Trust and notes receivable from participants as of December 31, 2024, interest income on notes receivable from participants and net investment gain from Master Trust for the period from May 1, 2024 (inception) to December 31, 2024, and the supplemental schedule of assets (held at end of year) as of December 31, 2024, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Voya Institutional Trust Company, the Plan's qualified institution.

The assets of the Plan are commingled with the Discovery Energy 401(k) Savings Plan for Administrative Associates in the Discovery Energy 401(k) Master Trust (the Master Trust). The Plan has a divided interest in the Master Trust, and this interest is allocated its respective share of commingled assets based on the number of units owned by the respective plan. The value of the Plan's interest in the Master Trust is based on the beginning of year value of the Plan's interest in the trust plus actual contributions and allocated investment income less actual distributions and allocated administrative expenses. The qualified institution is not responsible for investment-making decisions.

**NOTE 4 FAIR VALUE OF INVESTMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; or
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

**NOTE 4 FAIR VALUE OF INVESTMENTS (CONTINUED)**

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used as of December 31, 2024.

*Mutual Funds* – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective Funds* – Valued at the NAV of units of the bank collective trust. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily.

**NOTE 5 RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE 6 PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the participants would become 100% vested in their Company contributions.

**NOTE 7 PLAN TAX STATUS**

The Plan is an individually designed plan that has not received a determination letter from the Internal Revenue Service (IRS). However, the plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code (IRC), and, therefore, believes that the plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 8 PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are managed by the qualified institution of the Plan; therefore, the investment transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

### Report on the Audit of the Financial Statements

#### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed an audit of the accompanying financial statements of Discovery Energy 401(k) Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the period from May 1, 2024 (inception) to December 31, 2024, and the related notes to the financial statements.

**NOTE 1 DESCRIPTION OF THE PLAN**

The following description of the Discovery Energy 401(k) Savings Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan that was established, effective May 1, 2024, as amended, to enable eligible employees to accumulate funds through systematic savings, on a tax-advantageous basis, in order to provide additional retirement and other benefits and to provide Discovery Energy, LLC (the Company) a vehicle to attract and retain qualified employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan was most recently amended effective July 1, 2025.

Effective May 1, 2024, Kohler Co. sold their wholly owned Kohler Energy Division to Discovery Energy, LLC. As of the effective date, Discover Energy, LLC, became a separate company, and as a result of the sale, employees of the Energy Division became employees of Discovery Energy, LLC. The effective date of the Plan is May 1, 2024.

**Eligibility**

Eligible employees are active factory hourly employees of the Company who have reached age 18. Employees with customary employment of at least 1,000 hours of service during a 12-month period are eligible after 30 days of service. Employees with customary employment of less than 1,000 hours of service during a 12-month period are eligible after completing one year of eligibility service during which they work at least 1,000 hours.

**Contributions**

Contributions to the Plan are made by participants and the Company. Participants may elect to contribute, in multiples of 1%, amounts from 0% to 75% of their annual compensation, not to exceed that allowed for such contribution plans, which are limited by statutory provisions. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation, and their contributions invested in the designated default fund until change by the participant.

Company matching contributions for employees of the Hattiesburg and Sauk Technologies locations are 75% of the first 1%, 50% of the next 4%, and 25% of the next 1% a participant contributes.

**Contributions (Continued)**

Company matching contributions for Kohler, Wisconsin Factory Hourly employees are as follows:

- Associates, defined as any employee hired or rehired on or after May 1, 2024, or who transferred into coverage under this Plan: 50% of the first 6% a participant contributes.
- Tenured Associates, defined as any employee whose Kohler Co. employment began before December 20, 2010 (and who was previously covered under the Kohler 401(k) Savings Plan): 50% of the first 2% and 25% of the next 2% a participant contributes.

Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers). Participant, Company, and rollover contributions are invested based on investment fund elections established by the Benefits Planning Committee and selected by the participant.

**Participant Accounts**

Each participant's account is credited with the participant's contributions, the Company's contributions, and an allocation of Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided by the participant's vested account.

**Vesting**

Participants are 100% vested in their contributions and the earnings on their contributions. Vesting for Company contributions and earnings on Company contributions for participants commencing employment before January 1, 2002, is as follows:

A participant also becomes fully vested upon the attainment of normal retirement age (age 65), or upon death or total disability while an employee of the Company.

**Notes Receivable from Participants**

Participants are allowed to take loans from the Plan. Loan amounts are limited to 50% of the participant's vested account balance, with a maximum loan amount of \$50,000 and a minimum of \$1,000. Participants may have a maximum of one outstanding loan. Loan terms range from one to five years, or up to 15 years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at the prime rate. The interest paid by a participant on their loan balance is credited directly to their individual account. Principal and interest is paid ratably through payroll deductions.

**Benefit Payments**

Upon termination of service due to death, disability, or retirement, a participant may elect to receive the value of the vested interest in his or her account in the form of a lump sum distribution or installments over a period not to exceed 15 years. The Plan allows for in-service distributions if a participant reaches age 59½ and hardship distributions subject to Plan provisions. If a participant terminates employment and the participant's account balance does not exceed \$1,000, the Plan administrator will authorize the benefit payment without the participant's consent. If the balance of the terminated participant's account is between \$1,000 and \$7,000, the Plan Sponsor may authorize that the benefit payment be rolled into an individual retirement account in the participant's name.

**Forfeited Accounts**

Forfeited nonvested accounts can be used to reduce future Company matching contributions and to pay administrative expenses. Forfeited nonvested accounts as of December 31, 2024, totaled \$31,507. There were no forfeitures used to reduce Company matching contributions or pay administrative expenses for the period from May 1, 2024 (inception) to December 31, 2024.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Investment income and administrative expenses relating to the Master Trust are allocated to the Plan based on individual participant earnings or account balances. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024. Delinquent notes receivable are recorded as distributions on the basis of the terms of the Plan document.

**Payment of Benefits**

Benefit payments to participants are recorded upon distribution. There were no amounts allocated to accounts of participants who have elected to withdraw from the Plan, but have not yet been paid at December 31, 2024.

**Plan Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefits paid to participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value investments.

**Transfers**

As of the effective date of the plan as disclosed in Note 1, net assets of \$73,334,548, which related to account balances of former employees of the Kohler Energy Division, were transferred from the Kohler Co. 401(k) Savings Plan to this Plan.

**Subsequent Events**

The Plan has evaluated subsequent events through October 10, 2025, the date the financial statements were available to be issued.

Effective January 1, 2025, the Plan was amended to change the name to Rehlko 401(k) Savings Plan, to expand the options for applying forfeitures, to clarify the definition of eligible compensation, to add alternative eligibility provisions for part-time employees, and to treat catch-up contributions for high earners as Roth contributions.

Effective April 1, 2025, the Plan was amended to add separate deferral elections for bonuses and other irregular pay.

Effective July 1, 2025, the Plan was amended to add a one-time, nonelective Company contribution for participants who forfeited their prior Kohler Co. retiree medical savings account balances.

**NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION AND INVESTMENT IN MASTER TRUST**

Certain information related to investments disclosed in the accompanying financial statements and as shown below, including investment in Master Trust and notes receivable from participants as of December 31, 2024, interest income on notes receivable from participants and net investment gain from Master Trust for the period from May 1, 2024 (inception) to December 31, 2024, and the supplemental schedule of assets (held at end of year) as of December 31, 2024, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Voya Institutional Trust Company, the Plan's qualified institution.

The assets of the Plan are commingled with the Discovery Energy 401(k) Savings Plan for Administrative Associates in the Discovery Energy 401(k) Master Trust (the Master Trust). The Plan has a divided interest in the Master Trust, and this interest is allocated its respective share of commingled assets based on the number of units owned by the respective plan. The value of the Plan's interest in the Master Trust is based on the beginning of year value of the Plan's interest in the trust plus actual contributions and allocated investment income less actual distributions and allocated administrative expenses. The qualified institution is not responsible for investment-making decisions.

**NOTE 4 FAIR VALUE OF INVESTMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; or
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

**NOTE 4 FAIR VALUE OF INVESTMENTS (CONTINUED)**

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used as of December 31, 2024.

*Mutual Funds* – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective Funds* – Valued at the NAV of units of the bank collective trust. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily.

**NOTE 5 RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE 6 PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the participants would become 100% vested in their Company contributions.

**NOTE 7 PLAN TAX STATUS**

The Plan is an individually designed plan that has not received a determination letter from the Internal Revenue Service (IRS). However, the plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code (IRC), and, therefore, believes that the plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Certain Plan investments are managed by the qualified institution of the Plan; therefore, the investment transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.
