Notes to Financial Statements

Note 1. Description of the Plan

The following description of Arrowhead Engineered Products 401(k) Plan (the Plan) provides general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering employees of AEP Holdings, Inc. (the Company), as defined by the Plan. Employees are eligible to make salary deferrals to the Plan on the earliest monthly date after completion of two months of eligible service, as defined by the Plan. Participants are eligible to receive a discretionary Company matching contribution after completion of two months of eligible service, as defined by the Plan. Part-time, temporary, or seasonal employees who are regularly scheduled to work less than 1,000 hours in a 12-month period defined in the Plan are not eligible for the Plan. The Plan is intended to satisfy all of the requirements for a qualified retirement plan under the appropriate provisions of the Internal Revenue Code (IRC) and similar state tax laws. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Administration: The Company has overall responsibility for the operation and administration of the Plan. The Trustee is responsible for holding assets of the Plan and for executing asset transactions at the direction of the Plan's participants. The Investment Committee is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Contributions: Each year, participants may make pretax or after-tax salary deferral contributions, as defined by the Plan, up to the maximum allowed by the Internal Revenue Code (the Code). Participants may change their contribution percentage or may elect to cease making deferrals at any time. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Plan includes an automatic enrollment provision whereby all newly eligible employees are automatically enrolled at a contribution rate of 3% of eligible compensation, unless they affirmatively elect not to participate in the Plan or elect a different percentage. In addition, each year the automatic enrollment contribution rate is increased 1% until it reaches 6%, unless the employee elects a different percentage.

The Company may make a discretionary matching contribution to eligible participants. For the year ended December 31, 2024, the Company made a discretionary matching contribution equal to 100% of employee deferrals, up to a maximum of 3% of the employee's eligible wages.

Participant accounts: Each participant's account is credited with the participant's contributions, Company discretionary contributions and investment results. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is equal to the vested balance in the participant's account.

Investment options: Upon enrollment in the Plan, a participant may direct contributions in a variety of investment options, which are described in more detail in the Plan's literature. Participants may elect, on a daily basis, to have all or part of their account balances and future contributions transferred from one fund to another or in any combination.

Vesting: Participants are vested immediately in their contributions plus actual earnings thereon. Participants vest in Company discretionary contributions plus actual earnings thereon at 25% after one year of credited service and at a rate of 25% per year thereafter, until 100% vested after four years of credited service. A participant is also fully vested in their entire account upon the earliest occurrence of death, permanent disability or Plan termination.

Note 1. Description of the Plan (Continued)

Notes receivable from participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000. The amount of the note cannot exceed the greater of 50% of their vested account balance or \$50,000 less any outstanding notes. Note terms range from one to five years or are extended to a reasonable period of time consistent with commercial home loan practices for the purchase of a primary residence. The notes are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan's management. Principal and interest are paid ratably through semimonthly payroll deductions. Participants may not have more than two notes outstanding at any time.

Payment of benefits: Upon termination of service, permanent disability or death, a participant or beneficiary may elect to receive a lump sum or may elect to withdraw at such amounts and at such times as they choose. If the vested account balance at the time of termination of service, permanent disability or death is less than or equal to \$1,000, the participant will automatically receive a lump-sum distribution equal to the value of the participant's vested interest in his or her account. If a terminated participant has a balance between \$1,000 and \$5,000, it will be transferred into a qualified individual retirement account for the participant, unless the participant elects to receive a lump-sum amount or have the balance paid directly to an eligible retirement plan. An active participant may request withdrawal of benefits upon attaining the normal retirement age of 59½. Hardship withdrawals are available, subject to restrictions, as defined by the Plan.

Forfeited accounts: Forfeited nonvested accounts are used to fund future Company contributions or to pay Plan expenses, as defined by the Plan. During 2024, approximately \$421,000 of forfeitures were used to reduce Company contributions. There were no forfeited nonvested accounts at December 31, 2024 or 2023.

Note 2. Summary of Accounting Policies

Basis of accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Contributions: Contributions from Plan participants and the matching contributions from employer are recorded in the year in which the employee contributions are withheld from compensation.

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition: The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the Plan's trustee, investment advisors or other third parties. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Note 2. Summary of Accounting Policies (Continued)

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Notes receivable from participants are due in various amounts through November 2049, with interest rates ranging from 4.25% to 9.50%. Related fees are recorded as administrative expenses and are recognized when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments, and the Plan Administrator deems the participant loan to be in default, the participant's loan balance is reduced, and a benefit payment is recorded.

Notes receivable from participants have been classified as an investment asset for Form 5500 reporting purposes and, accordingly, have been included as an investment in the supplemental schedule, schedule H, line 4i—schedule of assets (held at end of year).

Payment of benefits: Benefit payments to participants are recorded when paid.

Administrative expenses: Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses, along with other expenses of maintaining the Plan. Investment-related expenses are included in net appreciation in fair value of investments.

Risks and uncertainties: The Plan provides for investment in a variety of investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the 2024 statement of net assets available for benefits.

Subsequent events: The Plan Administrator has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued.

Note 4. Fair Value Measurements

Accounting standards establish the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Note 4. Fair Value Measurements (Continued)

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Mutual funds: Mutual funds are valued at quoted market prices for identical assets in active markets for the shares held by the Plan at year-end.

Collective trust funds: The collective trust funds are valued at net asset value (NAV) of shares or units held by the Plan based on quoted market value of the underlying assets. The net asset value, as provided by the trustee, is used as a practical expedient to estimate fair value. The net asset value is based upon the fair value of the underlying investments comprising the trusts less their liabilities. The practical expedient is not used when it is determined to be probable that the trusts will sell their investments for amounts different than the reported net asset value.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan Administrator believes its valuation methodology is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 6. Income Tax Status

The Plan operates under the T. Rowe Price Retirement Plan Services, Inc. Pre-Approved Defined Contribution Plan. The IRS determined and informed T. Rowe Price Retirement Plan Services, Inc. by their letter dated August 19, 2020, that the Pre-Approved Defined Contribution Plan was designed in accordance with the applicable sections of the Code. The Pre-Approved Defined Contribution Plan determination letter has been relied upon by the Plan. The Plan has been amended subsequent to the version covered by the Volume Submitter Plan's determination letter; however, the Plan Administrator believes the Plan has been operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan, as amended, is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the Plan's management to evaluate income tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7. Transactions With Parties in Interest

Investments were managed in 2024 and 2023 by T. Rowe Price Retirement Plan Services, Inc., the trustee. Because all investments were managed by the trustee, all Plan transactions qualify as party-in-interest transactions under ERISA. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of investments, as they are paid through revenue sharing, rather than a direct payment.

Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.
