## **Independent Auditor's Report**

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

### 1. Description of plan

KIHOMAC, Inc. 401(k) Plan (the Plan) is a defined contribution plan covering substantially all employees of the plan sponsor, KIHOMAC, Inc. (the Company). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Plan management is responsible for oversight of the Plan, determined the appropriateness of the Plan's investment offerings, and monitors investment performance.

The following description of the Plan provides only general information. The Plan agreement and summary plan description should be referred to for a more complete description of the Plan's provisions.

#### Contributions and funding

Each year, participants may elect to defer a percentage of their annual compensation, as defined in the Plan, to the Plan. Participants may also contribute amounts representing distributions from other qualified retirement plans. The Plan includes an auto-enrollment provision. Under this provision all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3 percent of eligible compensation and their contributions invested in a designated investment until changes are made by the participant. The Company may provide a matching contribution as determined at the discretion of the Company's board of directors. For the year ended December 31, 2024, the employer match was 100% of elective contributions up to 3 percent, plus 50 percent of employee contributions between 3 and 9 percent. Additionally, the Company may make a discretionary profit sharing contribution to the Plan that is determined annually for eligible participants who have completed at least 1,000 hours during the Plan year and are employed on the last day of the Plan year. Participants direct the investment of all contributions into various investment options offered by the Plan. Contributions are subject to certain limitations. No discretionary contributions were accrued for the years ended December 31, 2024 and 2023.

#### Participant accounts

Each participant's account is credited with the (a) participant's contribution, (b) allocations of the Company's contribution and (c) investment earnings, net of administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Other than for employees classified as "full time as needed," vesting in the Company's employer matching and profit sharing contributions are based on a three year vesting schedule whereby a participant is 100 percent vested after three years of credited service. For employees classified as "full time as needed," vesting in the Company's employer matching and profit sharing contributions are based on a one year vesting schedule whereby a participant is 100 percent vested after one year of credited service. Under the Fidelity plan effective March 1, 2024, employees classified as "full time as needed" are fully vested in the Company's employer match and profit sharing contributions at date of hire. A participant is 100 percent vested in Company's discretionary contributions after six years of credited service.

#### Payment of benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive his/her vested account balance in a lump-sum, receive the balance in monthly or annuity payments, or roll the account balance to an individual retirement account or to another employer's tax qualified plan. Vested account balances less than \$5,000 will be distributed in a single lump-sum payment. Pre-retirement withdrawals are allowed for participants who have attained age 59½, or who have a qualifying hardship subject to the plan agreement.

### **Administrative expenses**

Most costs and expenses of administering the Plan are paid by the Company except for fees paid to the investment managers from their respective funds, certain fees paid directly by the participants, and quarterly management fees which may be paid with forfeitures. Investment related expenses are allocated to participants based on the participant's investment income and are included in net appreciation in the fair value of investments.

### **Forfeited accounts**

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$12,362 and \$58,680, respectively. Forfeitures are available to pay Plan expenses and reduce Company contributions. During 2024, \$241,790 of forfeitures were used to offset employer contributions and \$22,467 of forfeitures were used to pay Plan expenses.

## **2. Summary of accounting policies**

### **Basis of accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting, in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP).

### **Use of estimates**

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates and assumptions.

### **Investment valuation and income recognition**

The Plan's investments are stated at fair value in the financial statements. Fair value of the financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recognized principally on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### **Contributions receivable and allowance for credit losses**

Contributions receivables are determined based on the payroll paycheck date. There were no contributions receivable for the year ended December 31, 2024. On December 31, 2023, \$45,918 of employee contributions were receivable and \$27,493 of employer contributions were receivable. Employee and employer contributions receivables were subsequently paid into the Plan. At Plan year end, management performs an assessment of current conditions, reasonable and supportable forecasts regarding future events, and any other factors deemed relevant. If necessary, an allowance is established for expected credit losses to be recognized over the life of the receivable. Any allowance for credit losses is charged to change in net assets available for benefits in the period the receivable is recorded and revised in subsequent periods to reflect changes in management's estimate of expected credit losses. As of December 31, 2024 and 2023, no allowance for credit loss was considered necessary.

### **Excess contributions payable**

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions.

### **Payment of benefits**

Benefits are recorded when paid.

### 3. Information certified by the trustee

The plan administrator has elected the alternative method of compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (ERISA). Accordingly, as permitted under such election, the investment information certified by Ascensus Trust Company (Ascensus) through February 2024 and Fidelity Management Trust Company (Fidelity) beginning March 2024, was not audited by the independent auditors except for comparing such information to the related information included in the accompanying financial statements and supplemental schedule.

The Plan's financial information that was certified by Fidelity includes plan investments as of December 31, 2024 and 2023 of \$34,418,935 and \$31,135,625, respectively. The Plan's financial information that was certified by Ascensus and Fidelity includes investment income for the year ended December 31, 2024 of \$4,527,320. The Fidelity certification also covered investments-related information in the accompanying supplemental Schedule H, Line 4i-Schedule of Assets (Held At End of Year) as of December 31, 2024.

### 4. Investments at fair value

The Plan classifies its investments into Level 1, which refers to securities valued using quoted prices from active markets for identical assets; Level 2, which refers to securities not traded on an active market but for which observable market inputs are readily available; and Level 3, which refers to securities valued based on significant unobservable inputs. Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement.

Valuation techniques used maximize the use of observable inputs and minimize the use of unobservable inputs. The following section describes the valuation methodologies the Plan uses to measure its assets at fair value.

Money market funds are the only financial statement instrument that are measured and recorded at fair value, and they are considered level 1 valuation securities.

Registered investment companies (mutual funds): Mutual funds for which a quoted market price is available on an active market are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Self-directed brokerage accounts through Fidelity Investments give participants expanded investment choices and the opportunity to more actively manage their retirement contributions. These funds consist of common stock and registered investment companies and are valued at the actively traded value.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while plan management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 5. Party in interest transactions

Ascensus Trust Company was the Trustee of the Plan through February 2024. Certain Plan investments are managed by the Vanguard Group, Inc. (Vanguard). Vanguard provides services to the Plan. Therefore, these transactions qualify as party in interest transactions. Vanguard provides certain administrative services to the Plan through third party arrangements, pursuant to an agreement between the Sponsor and the Vanguard Group, Inc. Vanguard receives revenue from mutual fund service providers for services provided to the funds. This revenue is used to offset certain amounts owed for administrative services to the Plan. If the revenue received by Vanguard from such mutual fund service providers exceeds the amount owed under the agreement, the excess amount is remitted to the Plan's trust on a regular basis. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of participants. During 2024, there were no excess amounts. The Plan or Plan Sponsor may make a payment to Vanguard for administrative changes not covered by revenue sharing. Approximately \$16,000 of administrative fees were paid to Vanguard during the year ended December 31, 2024.

Fidelity Management Trust Company is the Trustee of the Plan starting March 2024, and administrative services were provided by Fidelity Investments. Approximately \$34,000 of administrative fees were paid to Fidelity during the year ended December 31, 2024.

The Plan invested in shares of registered investment companies managed by the trustee. A portion of the income or loss of the Plan was derived from these investments. Fees paid by the Plan to the trustee for certain investment management fees were deducted from the net asset values of the registered investment companies held by the Plan.

### 6. Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100 percent vested in all employer contribution accounts.

### 7. Tax status

The IRS has determined and informed the plan sponsor by a letter dated June 30, 2020, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the advisory opinion, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified.

In accordance with authoritative guidance issued by the FASB, the plan administrator is required to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions. However, there are currently no audits for any tax periods in progress. The Plan is subject to income tax examinations for years ended December 31, 2021 through December 31, 2024.

### 8. Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
