Notes to Financial Statements

Note 1: Description of Plan

The following description of the Via Mobility Services 403(b) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a participant-directed defined contribution plan established for a not-for-profit organization, commonly known as Code Section 403(b) savings plan. Via Mobility Services (the "Organization") is the Plan sponsor and is a not-for-profit corporation as described in Section 501(c)(3) of the Internal Revenue Code (IRC). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Plan is intended to satisfy the requirements under Section 404(c) of ERISA and, therefore, provides that participants may choose to direct their contributions and/or all or part of their account balances among the Plan's investment alternatives. All investments are participant-directed.

The Plan covers all eligible employees of the Organization immediately upon hire, without regard to years of service or age, except for non-resident aliens and employees who normally work less than twenty hours per week.

Contributions

Each year, participants may contribute up to 100% of their annual compensation, as defined by the Plan, subject to maximum deferral limitations established by the Internal Revenue Service (IRS). Participants have the option to contribute pretax elective deferral contributions or after tax Roth elective deferral contributions into the Plan. Effective on January 1, 2024 the Plan was amended to include an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate within 90 days. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation, with no scheduled increases, and their contributions invested into a designated fund. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). The Organization, at its discretion, may contribute amounts as a match of participant elective contributions for the Plan year. In addition, at its discretion, the Organization may contribute a non-elective contribution each Plan year. To receive Organization matching contributions and Organization non-elective contributions, an employee must be at least twenty-one years of age and have been an employee for at least one year in which they worked at least 1,000 hours. In addition, to participate in an allocation of the Organization non-elective contribution, the participant must be employed on the last day of the Plan year. During the year ended December 31, 2024, the Organization made matching contributions of \$177,203 and no non-elective contributions. Contributions are subject to certain IRS limitations.

Note 1: Description of Plan (Continued)

Participant Accounts

Each participant's account is credited with the participant's contributions, the Organization's matching contributions, and allocations of (a) the Organization's non-elective contribution, if any, and (b) Plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their voluntary contributions plus actual earnings thereon. Vesting in the Organization's matching and non-elective employer contribution portion of their accounts plus actual earnings thereon is based on years of service in which the participant completes 1,000 hours of service, as defined by the Plan. Participants vest in the matching and non-elective employer contribution at a rate of 25% per year of service, after the second year of service and reach full vesting after 5 years of such service.

Payment of Benefits

On termination of service due to death, disability, retirement, or other reasons a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account or installment payments, as defined by the Plan. In addition, hardship distributions are permitted if certain criteria are met, subject to the terms of the Plan document. The Plan also allows for in-service distributions upon attaining age 59-1/2.

Forfeitures

At December 31, 2024 and 2023, forfeited accounts totaled \$80 and \$76 respectively. These accounts will be used to reduce future Organization matching contributions in accordance with the Plan document. During the year ended December 31, 2024, Organization matching contributions were reduced by \$4,134 from forfeited nonvested amounts.

SECURE Act 2.0

The SECURE 2.0 Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. Management has evaluated those provisions and determined there is no material impact on the Plan. Plan management will determine the optional provisions, if any, to elect in the future.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States (GAAP).

Use of Estimates in Preparation of Financial Statements

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value, except for fully benefit-responsive investment contracts (FBRICs). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. FBRICs are reported at contract value, which is the amount participants would normally receive if they were to initiate permitted transactions under the terms of the Plan.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Organization. Expenses that are paid directly by the Organization are excluded from these financial statements. Fees for transactions initiated by participants such as distributions are charged to participant accounts and are included in administrative expenses. Investment-related expenses are allocated proportionately to Plan participants based on their respective account balances and are included in net appreciation of fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through October 13, 2025, which is the date the financial statements were available to be issued.

Effective January 1, 2025, long-term part-time employees who have not previously entered the Plan, but have attained at least 500 hours of service in at least three consecutive years beginning after December 31, 2021, are eligible to participate in the Plan.

Note 3: Information Prepared and Certified by the Custodians

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedules, including investments held and due from broker at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by CMFG Life Insurance Company and Matrix Trust Company, the Custodians of the Plan.

Note 4: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consists of unadjusted quoted prices in active markets for identical assets and have the highest priority level. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no Plan assets requiring the use of Level 2 or Level 3 inputs for the periods presented.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Money market fund: Fair values are based on net asset value of \$1 per share at year-end.

The following tables set forth by level, within the fair value hierarchy, the Plan's investment assets at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Note 5: Fully Benefit-Responsive Investment Contracts (FBRICs)

The Plan invests in the CUNA Mutual Guaranteed account, a fixed deferred group annuity account, through a guaranteed annuity contract with CMFG Life Insurance Company (CMFG). CMFG maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expense. CMFG is contractually obligated to pay the principal and a specified rate of interest that is guaranteed to the Plan. The investment is carried at contract value as it is considered fully benefit-responsive. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed on a quarterly basis for resetting. Quarterly interest rates were 2.25% during the year ended December 31, 2024.

Certain events limit the Plan's ability to transact at contract value with CMFG including early withdrawal from the contract or contract termination and certain other events as specified in the investment contract. The Plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants or the issuer are probable of occurring.

Note 6: Tax Status

The Organization has adopted a volume submitter plan that received an IRS determination letter which states the volume submitter plan is in compliance with the applicable sections of Section 403 of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter, however, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Accordingly, no provision for income taxes has been included in the Plan's financial statements.

Note 7: Related Party Transactions

Certain Plan investments are held in the general account of CMFG Life Insurance Company, a Custodian, and certain plan investments are managed by Matrix Trust Company, another Custodian, as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Additionally, the Plan made payments to various service providers for record keeping and investment advisory services that also qualify as party-in-interest transactions which totaled \$25,450 for the year ended December 31, 2024.

Note 8: Plan Termination

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Organization contributions.

Note 9: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 10: Prohibited Transactions

Under DOL Reg. 2510.3-102(b), the Organization is required to remit the employee contributions to the Plan at the earliest date such amounts can be reasonably segregated from the Organization's general assets, but no later than the fifteenth business day of the month following the date that participant contributions are withheld by the Organization. As reported on Schedule H, Line 4a – Schedule of Delinquent Participant Contributions, certain contributions for a payroll during the Plan year ended December 31, 2020, totaling \$20,225, were remitted within the 15-day requirement but not at the earliest day reasonably segregated. This transaction constitutes a prohibited transaction as defined by ERISA. The Organization remitted the contribution during 2020. The Organization intends to remit lost earnings to participant accounts during the Plan year ending December 31, 2025.
